All attachment should be in PDF format. Additional information may be required and further conditions may be imposed depending on the particular circumstances of the proposed operations. Incomplete or insufficient information may delay the application process.

- 1. Applicable fees and charges must be settled in accordance with Cap. 448D Hong Kong Air Navigation (Fees) Regulations.
- 2. A cover letter on the applicant's company letterhead with unique reference number shall always accompany the application form.
- 3. Do not enter ambiguous information such as "to be determined" or "TBD" in any field. Application form with ambiguous information will be rejected.
- 4. Complete all fields in a clear legible way. Enter "N/A" for those fields that are not applicable to this application and justify with reason.
