## Notes :-

- This form should be completed in as much detail as possible. An initial report, which may be made by any means, shall be made to the Hong Kong Civil Aviation Department within 96 hours of the occurrence. Hong Kong Operators shall report dangerous goods occurrence wherever they occurred. Non-Hong Kong operators shall report dangerous goods occurrence if they occurred within Hong Kong.

- 3 ICAO definitions :-
  - (1) Dangerous Goods Accident An occurrence associated with and related to the transport of dangerous goods by air which results in fatal or serious injury to a person or major property or environmental damage.
  - (2) Dangerous Goods Incident An occurrence, other than a dangerous goods accident, associated with and related to the transport of dangerous goods by air, not necessarily occurring on board an aircraft, which results in injury to a person, property or environmental damage, fire, breakage, spillage, leakage of fluid or radiation or other evidence that the integrity of the packaging has not been maintained. Any occurrence relating to the transport of dangerous goods which seriously jeopardizes the aircraft or its occupants is also deemed to be a dangerous goods incident.

Note (1) and (2) includes accidents or incidents involving dangerous goods that are not subject to all or part of the ICAO "Technical Instructions" (Doc 9284) through the application of an exception or of a special provision (e.g. an incident involving the short circuiting of a dry cell battery that is required to meet short circuit prevention conditions in a special provision).
