Project Title: The Development of AFCD Animal Management and Animal Welfare Building Complex in Kai Tak Development (Application No. DIR-263/2018)

Conditions Imposed under Section 5(12) of the EIA Ordinance for Permission to Apply Directly for Environmental Permit

- 1. All measures described in the Project Profile (No. PP-569/2018) submitted with the application on 6 June 2018 shall be fully implemented.
- 2. An independent environmental checker (IEC) shall be employed to audit the implementation of all measures recommended in the Project Profile (No. PP-569/2018). For the design measures stipulated in the Project Profile, including the location of the entrances and exits, the open-air exercise areas for animals, and the air exhausts of the ventilation system of the animal keeping areas, the IEC shall submit an Audit Report to the Director to confirm that the measures have been fully incorporated into the relevant design drawings no later than three months before the commencement of construction of the Project. The IEC shall also submit an Audit Report to the Director, no later than one month before operation of the Project, to verify that all the design measures stipulated in the Project Profile have been fully implemented. During the construction stage, the IEC shall submit monthly Audit Reports to the Director to verify that the construction phase environmental mitigation measures stipulated in the Project Profile are fully implemented.
