PART C (PERMIT CONDITIONS) C部 (許可證條件)

1. **General Conditions** 般條件

1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何 人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(第499章)的規定, 而當局可根據條例採取適當行動。

1.2 The Permit Holder shall ensure full compliance with all legislations from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358) and Noise Control Ordinance (Cap. 400). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

- The Permit Holder shall display conspicuously a copy of this Permit on the Project site(s) at 1.5 all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about the Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. 1.6 The Permit Holder shall construct the Project in accordance with the project description in Part B of this Permit. 许可證持有人須依據本許可證 B 部的工程項目說明,建造本工程項目。

1.7 The Permit Holder shall ensure that the Project is constructed in accordance with the information and recommendations described in the Project Profile (Register No. PP-535/2015), the application document for environmental permit (Application No. AEP-518/2016), other relevant documents in the Register, the information and mitigation measures described in this Permit. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded or impliedly amended in this Permit.

- The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than two weeks prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction. 許可證持有人須在工程項目的建造工程展開前,至少提早 2 個星期以書面方式把建造工程的施工日期通知署長。施工日期如有任何更改,許可證持有人必須立即以書面方式通知署長。
- 1.9 For the purpose of this Permit, "commencement of construction works" does not include works related to site clearance and preparation, or other works as agreed by the Director. 為執行本許可證,「建造工程的展開」不包括有關工地清理和預備工程,或署長同意的其他工程。

2. <u>Specific Conditions</u> 特定條件

- 2.1 All measures described in the Project Profile (Register No.: PP-535/2016) shall be fully implemented for the Project.

 工程項目簡介(編號: PP-535/2016) 載述的所有措施均須在工程項目徹底執行。
- 2.2 Only hand-held power tools and hand-held manual tools shall be used for carrying out the internal works of the Project.

- An independent checker shall be employed by the Permit Holder to audit the implementation of all mitigation measures and environmental monitoring and audit programme recommended in the Project Profile (Register No. PP-535/2016) and to confirm in writing in the monthly audit report full implementation of the measures and environmental monitoring and audit programme. Three hardcopies and one electronic copy of the monthly audit report shall be submitted to the Director within 2 weeks after the end of the reporting month.

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

If there is a breach of any conditions of this Permit, the Director or his authorized officer may, with the consent of the Secretary for the Environment, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

- 3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit. 许可證持有人可根據環評條例第 13 條的規定向署長申請更改本許可證的條件。許可證持有人須把經修改的許可證替換在工程項目工地內展示的原有許可證。
- 4. A person who assumes the responsibility for the whole or a part of the designated project(s) may, before he assumes responsibility of the designated project(s), apply under Section 12 of the EIAO to the Director for a further environmental permit. 承擔工程項目整項或部分工程的責任的人,在承擔責任之前,可根據環評條例第 12 條的規定向署長申請新的環境許可證。
- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for the Environment, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site. 根據環評條例第 14 條的規定,署長可在環境局局長的同意下暫時吊銷、更改或取消本許可證。遭暫時吊銷、更改或取消的許可證必須從工程項目工地除下,不再展示。
- 6. If this Permit is cancelled or surrendered during construction of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct a designated project listed in Part II of Schedule 2 of the EIAO without a valid environmental permit.

- 7. Any person who constructs the Project contrary to the conditions in the Permit, and is convicted of an offence under the EIAO, is liable: 如任何人在違反本許可證的條件下建造工程項目,根據環評條例,即屬犯罪-
 - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;

 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 —經循公訴程序第二次或其後每次定罪,可處罰款 500 萬元及監禁 2 年;
 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months; 一經循簡易程序首次定罪,可處第 6 級罰款及監禁 6 個月;
 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and —經循簡易程序第二次或其後每次定罪,可處罰款 100 萬元及監禁 1 年;及
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued. 在任何情况下如該罪行屬連續性質,法院或裁判官可就其信納該罪行連續的每一天另處罰款 10,000 元。
- 8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit. 許可證持有人可在接獲本許可證後 30 天內,根據環評條例第 17 條就本許可證的任何條件提出上訴。
- 9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.
