PART C (PERMIT CONDITIONS) C 部 (許可證條件)

1. General Conditions

- 1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO. 許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估

- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358), Noise Control Ordinance (Cap. 400) and Dumping at Sea Ordinance (Cap. 466). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of the Permit readily available at all times for inspection by the Director or his authorised officers at all sites/offices covered by this Permit. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site(s).

1.6 The Permit Holder shall construct and operate the Project in accordance with the project description in Part B of this Permit.

1.7 The Permit Holder shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No. AEIAR-203/2016), the application for Environmental Permit (Application No. AEP-531/2017) and other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in the submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded or impliedly amended in this Permit.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap.499). All submissions or any variation of the submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.1 and 2.2 below before submitting to the Director under this Permit.

For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

1.11 All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than one month prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of construction.

2. Specific Conditions

Employment of Environmental Monitoring and Audit (EM&A) Personnel 聘用環境監察及審核(環監)人員

An Environmental Team (ET) shall be established by the Permit Holder no later than one month before commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET Leader. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or

environmental management. The ET and the ET Leader shall be responsible for the implementation of the EM&A programme in accordance with the EM&A requirements as contained in the updated EM&A Manual deposited under Condition 2.4 of this Permit. The ET Leader shall keep a contemporaneous log-book of each and every instance or circumstance or change of circumstances, which may affect the compliance with the recommendations of the EIA Report (Register No. AEIAR-203/2016) and this Permit. ET Leader shall notify the IEC within one working day of the occurrence of any such instance or circumstance or change of circumstances. The ET Leader's log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the EIA Report (Register No. AEIAR-203/2016) and this Permit or by the Director or his authorized officers. Failure to maintain records in the log-book, failure to discharge the duties of the ET Leader as defined in the updated EM&A Manual or failure to comply with this Condition would entitle the Director to require the Permit Holder by notice in writing to replace the ET Leader. Failure by the Permit Holder to make replacement or further failure to keep contemporaneous records in the log-book despite the employment of a new ET Leader may render the Permit liable to suspension, cancellation or variation.

在工程項目的建造工程展開前,許可證持有人須至少提早1個月成立一個環境小組。環境小組不得與工程項目的承辦商或獨立環境查核人有任何聯繫。環境小組須由一名環境小組組長帶領。環境小組組長須在環境監察及審核(「環監」)或環境管理方面至少有7年經驗。環境小組及環境小組組長須按經更新環監手冊內載的環監規定,執行環監計劃,而該環監手冊須按本許可證條件第2.4項存放。環境小組組長須保存一本記錄冊,同時記載可能會影響環評報告(登記冊編號:AEIAR-203/2016)的建議及本許可證的符合情況的每宗事件、每種情況或每次情況變化。環境小組組長須在發生任何類似事件、情況或情況變化後1個工作天內通知獨立環境查核人。存放環境小組組長的記錄冊的地方,須可供協助督導執行環評報告(登記冊編號:AEIAR-203/2016)的建議及本許可證的所有人士、署長或獲授權人員隨時查閱。環境小組組長如未能在記錄冊保存記錄、未能執行經更新環監手冊所列明的環境小組組長職務或未能符合本條件的規定,署長有權以書面要求許可證持有人撤換環境小組組長、許可證持有人如未能安排人選替補,或在聘用新環境小組組長後仍未能在記錄冊保存同期的記錄,或會導致許可證遭暫時吊銷、取消或更改。

2.2 An IEC shall be employed by the Permit Holder no later than one month before commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management. The IEC shall be responsible for duties defined in the updated EM&A Manual deposited under Condition 2.4 of this Permit, and shall audit the overall EM&A performance, including the implementation of all environmental mitigation measures, submissions required in the updated EM&A Manual, and any other submissions required under this Permit. In addition, the IEC shall be responsible for

verifying the environmental acceptability of permanent and temporary works, relevant design plans and submissions under this Permit. The IEC shall verify the log-book(s) mentioned in Condition 2.1 of this Permit. The IEC shall notify the Director by fax or email, within one working day of receipt of notification from the ET Leader of each and every occurrence, change of circumstances or non-compliance with the EIA Report (Register No. AEIAR-203/2016) and this Permit, which may affect the monitoring or control of adverse environmental impacts from the Project. In the case where the IEC fails to so notify the Director of the same, fails to discharge the duties of the IEC as defined in the updated EM&A Manual or fails to comply with this Condition, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render the Permit liable to suspension, cancellation or variation. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition.

2.3 The Permit Holder shall, no later than one month before the commencement of construction of the Project, inform the Director in writing the management organization of the main construction companies and/or any form of joint ventures associated with the construction of the Project. The submitted information shall include at least an organization chart, names of responsible persons and their contact details.

2.4 The Permit Holder shall update the EM&A Manual to include the latest EM&A requirements in accordance with the information and recommendations described in the EIA Report and by taking into account any specific site conditions that may be changed before the construction of the Project. The Permit Holder shall, at least 4 weeks before the commencement of construction of the Project, deposit with the Director 4 hard copies and 4 electronic copies of the updated EM&A Manual. Before submission to the Director, the updated EM&A Manual shall be certified by the ET Leader and verified by the IEC as conforming to the information and recommendations described in the EIA Report (Register No. AEIAR-203/2016), and taking into account any specific requirements with respect to the latest site conditions of the Project. All measures recommended in the updated EM&A Manual deposited under this Condition shall be fully and properly implemented in accordance with the requirements and time schedule(s) set out in the updated EM&A Manual. The EM&A Manual deposited under this Condition shall hereinafter be referred to as the "updated EM&A Manual". 許可證持有人須根據環評報告所載的資料及建議,以及通過考慮在工程項目施工前可能 會改變的任何具體地盤狀況,更新環監手冊,以加入最新的環監規定。許可證持有人須 在工程項目的建造工程展開前,至少提早4個星期向署長存放經更新的環監手冊的4份

2.5 The Permit Holder shall, no later than 2 weeks before the commencement of construction of the Project, deposit 4 hard copies and 1 electronic copy of location plan(s) of the Project with a scale of 1:1000 or other appropriate scale as agreed with the Director. The plans shall include the details the works boundaries, works areas, vertical and horizontal alignments of the roads and any other major facilities; and the locations of key environmental mitigation measures.

許可證持有人須在工程項目的建造工程展開前,至少提早2個星期存放以1:1000的比例或署長同意的其他合適比例繪製的工程項目位置圖的4份硬複本及1份電子版本。有關圖則須包括工程界線、施工區、道路的垂直及水平線向及任何其他主要設施的詳情;以

Submission of Supplementary Contamination Assessment Plan (CAP) 提交補充污染評估計劃書

2.6 Detailed assessment of land contamination to the Project site(s) shall be carried out before the commencement of construction of the Project when access to the site(s) is available. The Permit Holder shall submit 4 hard copies and 1 electronic copy of the supplementary CAP to the Director for approval. All recommendation(s) in the approved supplementary CAP shall be implemented. No construction works shall be commenced before the approval of the supplementary CAP by the Director. Remediation action plan shall be devised and implemented to ensure decontamination of the Project site(s) if found necessary. Contaminated soil shall not be used for planting and landscaping.

Submission of Landscape and Visual Mitigation Plan 提交景觀及視覺緩解計劃

2.7 The Permit Holder shall, at least one month before the commencement of the corresponding parts of landscape and visual mitigation measures of the Project, deposit with the Director 4 hard copies and 1 electronic copy of landscape and visual mitigation The landscape and visual mitigation plan(s) shall show the design details, confirmation of the feasibility for proposed planting, locations, implementation programme, maintenance and management schedules, and drawings in the scale of 1:1,000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures of the Project. Before submission to the Director, the landscape and visual mitigation plan(s) shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations, including those described in the EIA Report (Register No. AEIAR-203/2016). If there is any change proposed to the landscape and visual mitigation measures in the approved Plan, the Permit Holder shall, no later than one month before the implementation of any such change, deposit with the Director 4 hard copies and 1 electronic copy of an update to the Plan. All landscape and visual mitigation measures shall be properly implemented and maintained for the Project in accordance with the deposited landscape and visual mitigation plan(s). The Permit Holder shall make available additional copies to the Director upon request.

2.8 The Permit Holder shall, no later than one month before the commencement of construction of the Project, submit to the Director for approval 4 hard copies and 1 electronic copy of Traffic Noise Mitigation Plan (the Plan). If there is any change proposed to the traffic noise mitigation measures in the approved Plan, the Permit Holder shall, no later than one month before the implementation of any such change, submit to the Director for approval 4 hard copies and 1 electronic copy of an update to the Plan (the Updated Plan). The Plan or any Updated Plan shall demonstrate that the traffic noise performance requirements set out in the EIA report (Register No.: AEIAR-203/2016) will not be exceeded with the mitigation measures in place. All mitigation measures recommended in the approved Plan or approved Updated Plan shall be fully implemented and properly maintained throughout the operational phase(s) of the Project.

2.9 The Permit Holder shall, no later than one month before the commencement of construction of the Project, submit to the Director for approval 4 hard copies and 1 electronic copy of Ecological Mitigation Plan (the Plan). If there is any change proposed

to the mitigation measures in the approved Plan, the Permit Holder shall, no later than one month before the implementation of any such change, submit to the Director for approval 4 hard copies and 1 electronic copy of an update to the Plan (the Updated Plan). All mitigation measures recommended in the approved Plan or approved Updated Plan shall be fully implemented and properly maintained throughout the constructional and operational phases of the Project.

The EM&A Reports shall include a summary of all non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels). The submissions shall be certified by the ET Leader and verified by the IEC. Additional copies of the submission shall be provided to the Director upon request by the Director.

For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

All environmental monitoring data described in Condition 4.1 above shall be made available to the public via the dedicated Internet web site in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet web site in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director.


