Pursuant to Section 10 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) grants this environmental permit to the **AIRPORT AUTHORITY HONG KONG** (hereinafter referred to as the “Permit Holder”) to construct and operate the designated project described in Part B subject to the conditions specified in Part C. The issue of this environmental permit is based on the documents, approvals or permissions described below:



Hereunder is the description of the designated project mentioned in Part A of this environmental permit (hereinafter referred to as the “Permit”):

**PART C (PERMIT CONDITIONS)****C部 (許可證條件)****1. GENERAL CONDITIONS****一般條件**

- 1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap. 499) and may become the subject of appropriate action being taken under the Ordinance.  
許可證持有人及任何從事工程項目的人士必須符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況，可能違反《環境影響評估條例》(第 499 章)的規定，而當局可根據條例採取適當行動。
- 1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358), Noise Control Ordinance (Cap. 400) and Dumping at Sea Ordinance (Cap. 466). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.  
許可證持有人須經常確保完全符合現行法例的規定，包括但不限於《空氣污染管制條例》(第 311 章)；《廢物處置條例》(第 354 章)；《水污染管制條例》(第 358 章)；《噪音管制條例》(第 400 章)；以及《海上傾倒物料條例》(第 466 章)。本許可證本身不會就根據任何法例提出的法律程序構成任何抗辯理由，或根據任何法例默示任何批准。
- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of the Permit readily available at all times for inspection by the Director or his authorized officers at all sites/offices covered by this Permit. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in the Permit. The site(s) refers to site(s) of construction and operation of the Project and shall mean the same hereafter.  
許可證持有人須把本許可證的複本交予有關工地的負責人，並確保這些人士完全明白本許可證的所有條件與規定。工地是指建造及營辦工程項目的工地，下文所提及的工地亦屬同一意思。
- 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the Project site(s) at all site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about the Permit, including any amended Permit, is displayed at such locations. If the Permit



Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site(s).

許可證持有人須在工程項目的工地的所有進出口或一處方便地點，顯眼地展示本許可證的複本，以供公眾在任何時間內閱覽。許可證持有人須確保在這些地點展示關於本許可證（包括任何經修訂的許可證）的最新資料。許可證持有人如交回許可證的部分或全部，必須把其送交署長的通知書，在備有原有許可證的相同地點展示。遭暫時吊銷、更改或取消的許可證必須從工程項目的工地除下，不再展示。

- 1.6 The Permit Holder shall construct and operate the Project in accordance with the project description in Part B of this Permit.

許可證持有人須依據本許可證 B 部的工程項目說明，建造及營辦工程項目。

- 1.7 The Permit Holder shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No. AEIAR-216/2018), the application documents for Environmental Permit (Application No. AEP-560/2018), other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in the submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded or amended in this Permit.

許可證持有人須確保工程項目的設計、建造及營辦，按照下述資料及措施辦理：核准環評報告（登記冊編號：AEIAR-216/2018）所說明的資料及各項建議、環境許可證申請文件（申請書編號：AEP-560/2018）；登記冊內的其他相關文件；本許可證所說明的資料及緩解措施；根據本許可證內載的條件須向署長存放或獲署長批准的提交文件所建議的緩解措施；以及在工程項目各階段進行的持續監察及監測工作所建議的緩解措施。登記冊文件所述建議如沒有在本許可證明確表示，則仍須實施這些建議，除非獲本許可證明確豁除或修訂。

- 1.8 All deposited submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within 1 month of the receipt of the Director's comments or otherwise as specified by the Director.

所有按本許可證規定提交的存放文件，須在接獲署長的意見（如有者）後 1 個月內（除非署長另行指定），根據署長的意見加以修正並再向署長提交。

- 1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, and all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any

non-compliance with the submissions may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap. 499). All submissions or any variation of the submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.2 and 2.4 below before submitting to the Director under this Permit.

署長批准的所有提交文件、署長沒有給予意見的所有存放文件及根據本許可證規定由署長給予意見修正的所有提交文件，均須詮釋為本許可證 C 部說明的許可證條件的一部分。提交文件如有任何修訂，均須獲署長的書面批准，或符合有關許可證條件訂明的規定。如有不符合提交文件的情況，則可能違反《環境影響評估條例》（第 499 章）的規定。所有提交文件或提交文件的任何修訂本，均須按下文條件第 2.2 及 2.4 項所述由環境小組組長核證及獨立環境查核人核實，然後才按本許可證規定向署長提交。

- 1.10 The Permit Holder shall release all finalized submissions, as required under this Permit, to the public by depositing copies in the Environmental Impact Assessment Ordinance Register Office, or in any other places, or any internet websites as specified by the Director, or by any other means as specified by the Director for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

許可證持有人須把所有按本許可證規定提交的文件定稿公開給公眾人士知道，方法是把有關文件複本存放於環境影響評估條例登記冊辦事處，或署長指定的任何其他地方，或署長指定的任何互聯網網站，或採取署長指定的任何其他方法，以供公眾查閱。因此，許可證持有人須提供足夠數量的複本。

- 1.11 All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalized submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

本許可證規定向署長提交的所有文件，須親身送交或以掛號方式郵寄至環境影響評估條例登記冊辦事處（現址為：香港灣仔軒尼詩道 130 號修頓中心 27 樓）。所有按本許可證規定提交的文件定稿的電子版本，均須以超文本標示語言 (HTML)（第 4.0 或較後版本）和便攜式文件格式 (PDF)（第 1.3 或較後版本）製作，除非另獲署長同意，並須與硬複本同時提交。

- 1.12 The Director shall be notified in writing the commencement dates of construction and operation of the Project no later than 2 weeks prior to the respective commencement of construction and operation of the Project. The Director shall be notified in writing immediately if there is any change of the commencement dates of the construction and operation.

許可證持有人須在建造及營辦工程項目展開前，至少提早 2 個星期以書面方式把建造及營辦工程的開展日期通知署長。建造及營辦工程的開展日期如有任何更改，許可證持有人必須立即以書面方式通知署長。

- 1.13 For the purpose of this Permit, “commencement of construction” does not include works related to site investigation, clearance and preparation, or other works as agreed by the Director.

## 2 SPECIFIC CONDITIONS

### 特定條件

#### Employment of EM&A Personnel

##### 聘用環監人員

#### Employment of ET

##### 聘用環境小組

- 2.1 An ET, unless otherwise approved by the Director, shall be established by the Permit Holder no later than 2 months before the commencement of construction of the Project. The ET shall be headed by an ET Leader. The ET shall not be in any way an associated body of the Contractor or the IEC for the Project. The ET Leader shall be a person who has at least 7 years of experience in EM&A or environmental management.

除非署長另行批准，否則許可證持有人須在展開工程項目的建造工程前最少 2 個月成立一個環境小組。環境小組須由一名環境小組組長帶領。環境小組不得與工程項目的承辦商或獨立環境查核人有任何聯繫。環境小組組長須在環監或環境管理方面至少有 7 年經驗。

- 2.2 The ET and the ET Leader shall be responsible for the implementation of the EM&A programme in accordance with the EM&A requirements as contained in the updated EM&A Manual of the Project. The ET Leader shall keep a contemporaneous log-book of each and every instance or circumstance or change of circumstances, which may affect the compliance with the recommendations of the approved EIA Report (Register No. AEIAR-216/2018) and this Permit. The ET Leader shall notify the IEC within 1 working day of the occurrence of any such instance or circumstance or change of circumstances. The ET Leader's log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the approved EIA Report (Register No. AEIAR-216/2018) and this Permit or by the Director or his authorized officers. Failure to maintain records in the log-book, failure to discharge the duties of the ET Leader as defined in the updated EM&A Manual or failure to comply with this Condition would entitle the Director to require the Permit Holder by notice in writing to replace the ET Leader. Failure by the Permit Holder to make replacement, or further failure to keep contemporaneous records in the log-book despite the employment of a new ET Leader may render the Permit liable to suspension, cancellation or variation.

環境小組及環境小組組長須按工程項目的更新環監手冊內載的環監規定執行環監計劃。環境小組組長須保存一本記錄冊，同時記載可能會影響核准環評報告（登記冊編號：AEIAR-216/2018）的建議及本許可證的符合情況的每宗事件、每種情況或每次情況變化。環境小組組





長須在發生任何類似事件、情況或情況變化後 1 個工作天內通知獨立環境查核人。存放環境小組組長的記錄冊的地方，須可供協助督導執行核准環評報告（登記冊編號：AEIAR-216/2018）的建議及本許可證的所有人士、署長或獲授權人員隨時查閱。環境小組組長如未能在記錄冊保存記錄、未能執行更新環監手冊所列明的環境小組組長職務或未能符合本條件的規定，署長有權以書面要求許可證持有人撤換環境小組組長。許可證持有人如未能安排人選替補，或在聘用新環境小組組長後仍未能在記錄冊保存同期的記錄，或會導致許可證遭暫時吊銷、取消或更改。

### **Employment of IEC** **聘用獨立環境查核人**

- 2.3 An IEC shall be employed by the Permit Holder no later than 2 months before the commencement of construction of the Project. The IEC and his team shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be approved by the Director before appointment by the Permit Holder. The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management.

許可證持有人須在展開工程項目的建造工程前最少 2 個月聘用一名獨立環境查核人。獨立環境查核人不得與工程項目的工程承辦商或環境小組有任何聯繫。獨立環境查核人須經署長批准，才可獲許可證持有人聘用。獨立環境查核人須在環監或環境管理方面至少有 7 年經驗。

- 2.4 The IEC shall be responsible for duties defined in the updated EM&A Manual and shall audit the overall EM&A performance, including the implementation of all environmental mitigation measures, submissions required in the updated EM&A Manual, and any other submissions required under this Permit. In addition, the IEC shall be responsible for verifying the environmental acceptability of permanent and temporary works, relevant design plans and submissions under this Permit. The IEC shall verify the log-book(s) mentioned in Condition 2.2. The IEC shall notify the Director by fax, within 1 working day of receipt of notification from the ET Leader of each and every change of circumstances or non-compliance with the recommendations of the approved EIA Report (Register No. AEIAR-216/2018) and this Permit, which might affect the monitoring or control of adverse environmental impacts from the Project. In case the IEC fails to so notify the Director of the same, fails to discharge the duties of the IEC as defined in the updated EM&A Manual or fails to comply with this Condition, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render the Permit liable to suspension, cancellation or variation. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition.

獨立環境查核人須執行更新環監手冊所列明的職務，以及審核整體環監工作的表現，包括實施所有環境緩解措施、提交更新環監手冊規定的文件，以及提交本許可證所要求的任何其他文件。此外，獨立環境查核人須核實永久及臨時工程在環境上的可接受程度、相關的設計圖則和根據本許可證提交的文件，並須核實條件第 2.2 項所述的記錄冊。在每次出現情況變化或不符合核准環評報告（登記冊編號：

AEIAR-216/2018) 的建議及本許可證的情況，而可能會妨礙工程項目所造成不良環境影響的監察或控制工作時，獨立環境查核人須在接獲環境小組組長通知後 1 個工作天內以傳真方式通知署長。獨立環境查核人如未能通知署長有關情況、未能執行更新環監手冊所列明的獨立環境查核人職務或未能符合本條件的規定，署長可以書面要求許可證持有人撤換獨立環境查核人。如未能按指示撤換獨立環境查核人，或在聘用新獨立環境查核人後仍未能通知署長有關情況，則或會導致許可證遭暫時吊銷、取消或更改。為執行本條件，許可證持有人的通知等同獨立環境查核人的通知。

## **Submissions to be made before the Construction of the Project** **工程項目建造工程展開前須提交的文件**

### ***Submission of Management Organizations*** ***提交管理架構***

- 2.5 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, inform the Director in writing the following information: 許可證持有人須在展開工程項目的建造工程前最少 1 個月把以下資料以書面通知署長：
- (i) the management organization of the main construction companies and / or any form of joint ventures associated with the construction of the Project;

  - (ii) the management organization of the ET;  
環境小組的管理架構；
  - (iii) the management organization of the IEC and his team; and  
獨立環境查核人及其小組的管理架構；以及
  - (iv) the submitted information shall include at least an organization chart, names of responsible persons and their contact details.

### ***Submission of Construction Works Schedule and Location Plans*** ***提交施工時間表及位置圖***

- 2.6 The Permit Holder shall, no later than 2 months before the commencement of construction of the Project, deposit 3 hard copies and 1 electronic copy of a work plan (The Plan) with the Director. The Plan shall include at least the following information/specifications: 許可證持有人須在展開工程項目的建造工程前最少 2 個月向署長存放施工計劃 (計劃) 的 3 份硬複本及 1 份電子版本。計劃須包括下列資料／規格：
- (i) a detailed phasing programme of all construction works including construction of the marine section in a marine area between the Airport Island and the HKBCF Island, and a land section on the HKBCF Island; and

- (ii) location plan of all construction works in appropriate scale showing the locations of cofferdams, the excavation areas and the proposed bridge piers and / or abutments of the Project.

***Submission of Silt Curtain and Cofferdam Deployment Plan***

- 2.7 The Permit Holder shall, no later than 2 months before the commencement of marine works involving deployment of silt curtains and cofferdams of the Project, deposit 3 hard copies and 1 electronic copy of a silt curtain and cofferdam deployment plan (The Plan) with the Director. The Plan shall include the construction programme and details on the design, location, operation and maintenance of silt curtain(s) and cofferdam to be deployed during the construction. 許可證持有人須在展開涉及為工程項目敷設淤泥屏障和圍堰的海事工程前最少 2 個月向署長存放淤泥屏障和圍堰敷設計劃（計劃）的 3 份硬複本及 1 份電子版本。計劃須包括施工計劃及施工期間敷設淤泥屏障和圍堰的設計、位置、運作及保養詳情。

***Submission of Landscape and Visual Plan***  
**提交景觀及視覺計劃**

- 2.8 The Permit Holder shall, no later than 2 months before the commencement of construction works of the Project, deposit 3 hard copies and 1 electronic copy of landscape and visual plan (The Plan) with the Director to specify quality criteria on the overall landscape and visual environment of the Project with broad-brush targets to be achieved for greening and planting as benchmarked against international standards and best practices. The Plan, with drawings in the scale of 1:1000 or other appropriate scales showing the landscape and visual mitigation measures of the Project, shall include at least the following information:

許可證持有人須在展開工程項目建造工程前最少 2 個月向署長存放景觀及視覺計劃（計劃）的 3 份硬複本及 1 份電子版本，明述工程項目整體景觀及視覺環境的質素準則，並在與國際標準及 / 或最佳做法比對下訂定擬達致的綠化或種植大概目標。計劃須附有以 1:1000 或其他合適比例繪製的圖則，顯示工程項目的景觀及視覺緩解措施，並須包括下列資料：

- (iv) locations, size, number and plant species to be provided or compensated; and

- (v) implementation programme, maintenance and management schedules.

## **Measures to be Implemented for the Construction of the Project** **工程項目施工期間須採取的措施**

### ***Measures to Minimize Water Quality Impacts*** **盡量減低水質影響的措施**

- 2.9 The Permit Holder shall implement the Silt Curtain and Cofferdam Deployment Plan deposited under Condition 2.7 to minimize the water quality impact caused by the marine works.

### ***Measures to Minimize Ecological Impacts (Marine)*** **盡量減低生態影響（海洋）影響的措施**

- 2.10 The Permit Holder shall not conduct any underwater percussive piling in this Project.

## **3 ENVIRONMENTAL MONITORING AND AUDIT REQUIREMENTS** **環境監察及審核規定**

- 3.1 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements as set out in the EM&A Manual. Any change to the EM&A requirements or programme shall be justified by the ET Leader and verified by the IEC as conforming to the relevant information and requirements set out in the EM&A Manual before submission to the Director for approval.

環監計劃須按照環監手冊所載程序及規定執行。環監規定或計劃如有更改，須由環境小組組長提出充分理由，並由獨立環境查核人核實，證明其符合環監手冊所載的相關規定，並須事先獲署長批准，方可執行。

- 3.2 The Permit Holder shall take samples, measurements and necessary remedial actions in accordance with the requirements of the updated EM&A Manual by:

- (i) conducting baseline environmental monitoring;

- (ii) conducting constructional and operational phase impact monitoring;

- (iii) carrying out remedial actions described in the Event/Action Plans of the updated EM&A Manual in accordance with the time frame set out in the Event/Action Plans, or as agreed by the Director, in case where specified criteria in the updated EM&A Manual are exceeded; and  
如超逾經更新環監手冊內指定的標準，則按照經更新環監手冊內的事件／

行動計劃所訂明的時限或署長所同意的時限，執行事件／行動計劃所說明的補救行動；以及

- (iv) logging and keeping records of the details of (i) to (iii) above for all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available the information for inspection on site.

在收集數據或完成補救行動 3 個工作天內，須記錄及備存上文(i)至(iii)段所有參數的詳情，用作擬備及提交每月環監報告，並備妥有關資料以供在工地查閱。

- 3.3 The Permit Holder shall submit 1 hard copy and 1 electronic copy of relevant Baseline Monitoring Reports to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the updated EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director.

許可證持有人須在展開工程項目的建造工程前，最少 2 個星期向署長提交有關基線監測報告的 1 份硬複本及 1 份電子版本。提交文件須由環境小組組長核證及獨立環境查核人核實，證明其符合經更新環監手冊所載的規定，然後才提交署長。如署長要求，則須提交基線監測報告的額外複本。

- 3.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Monthly EM&A Reports for the construction stage of the Project to the Director, within 2 weeks after the end of the reporting month, unless as specified by the Director. The monthly EM&A Reports shall include a summary of all non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels). The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the updated EM&A Manual before submission to the Director.

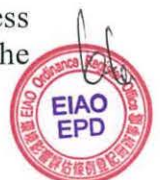

- 3.5 All environmental monitoring and audit data submitted under this Permit shall be true, valid and correct.

#### **4 ELECTRONIC REPORTING OF EM&A INFORMATION** **環監資料的電子匯報**

- 4.1 To facilitate public inspection of the Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the



hard copies as described in Conditions 3.3 and 3.4 above. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

1. This Permit consists of 3 parts, namely, Part A (Main Permit), Part B (Description of Designated Project) and Part C (Permit Conditions). Any person relying on this permit shall obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

2. If there is a breach of any condition of this Permit, the Director or his authorized officer may, with the consent of the Secretary for the Environment, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

6. If this Permit is cancelled or surrendered during the construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part 1 and 2 of Schedule 2 of the EIAO without a valid environmental permit.

- (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;

- (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;

- (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;

一經循簡易程序首次定罪，可處第 6 級罰款及監禁 6 個月；

- (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and

一經循簡易程序第二次或其後每次定罪，可處罰款 100 萬元及監禁 1 年；及

- (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit.

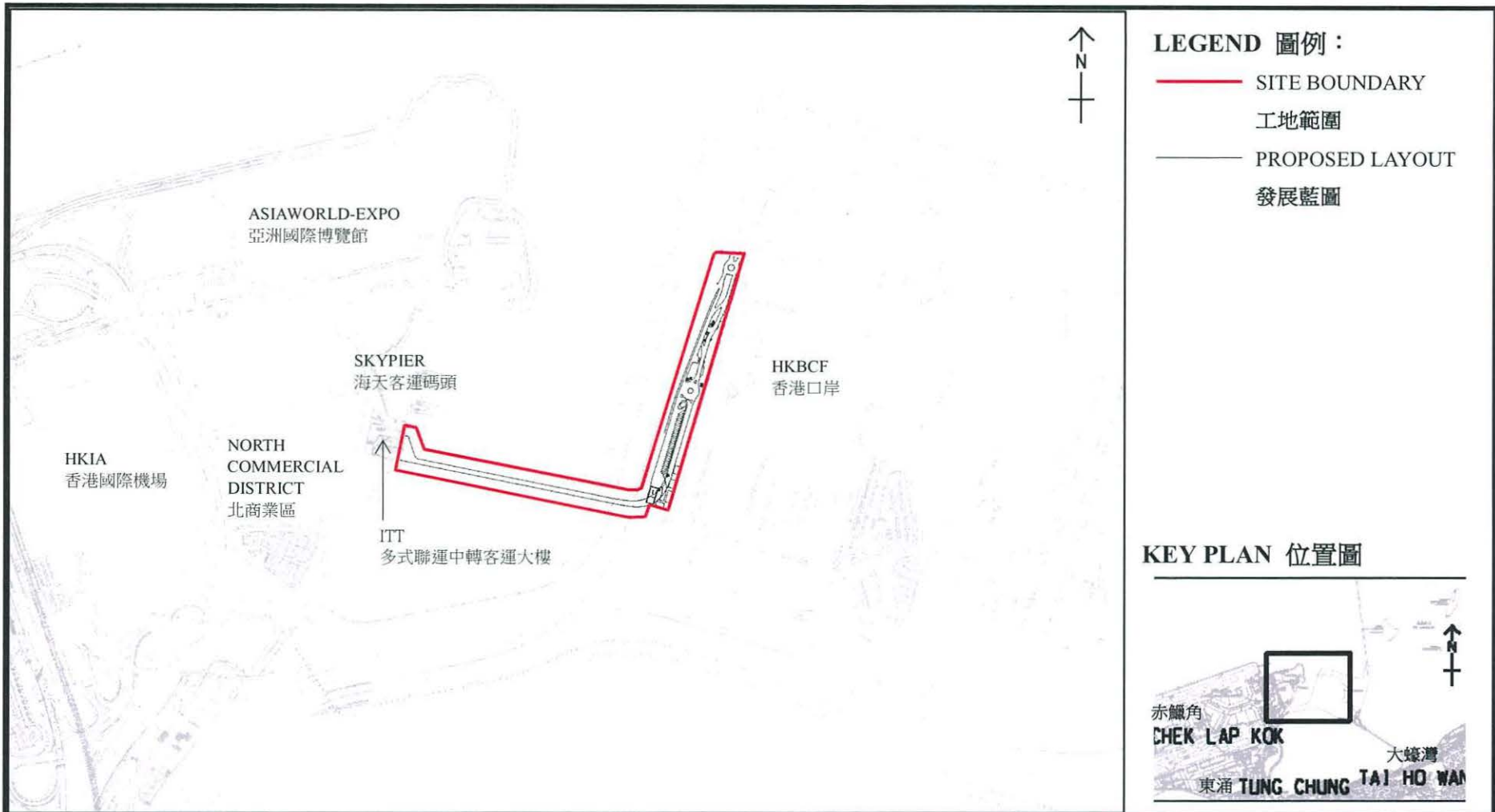
