## 1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the original

Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.1 to 2.6 below before submitting to the Director under this Permit.

Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

The ET shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET Leader and supported by relevant specialists including Terrestrial Ecologist, Landscape Architect, and other professionals. Notification(s) shall be documented in the upcoming EM&A monthly report; and

2.6 If the Director considers the IEC fails to discharge the duties of the IEC as defined in the EM&A Manual or in this Permit, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render this Permit liable to suspension, cancellation or variation.

2.7 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, submit an EP Submission Schedule to set out a timeline for EP submissions in this Permit and shall report the progress in fulfilling the submission requirements in the monthly EM&A reports submitted under Condition 3.4 of this Permit. The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date of the EP submission in writing in case of any subsequent change(s) to the submitted EP Submission Schedule.   - (iii) the management organization of the IEC and his team; and 獨立環境查核人及其支援小組的管理架構;以及
  - (iv) the submitted information shall include at least an organization chart, names of responsible persons and their contact details

#### Submission of Compensatory Tree Planting Implementation Plan 提交樹木補償種植實施計劃

2.9 The Permit Holder shall, no later than 6 weeks of the commencement of the construction of the corresponding parts of the Project, deposit with the Director 3 hard copies and 1 electronic copy of Compensatory Tree Planting Implementation Plan. The Compensatory Tree Planting Implementation Plan shall include with details of the planting objectives, planting numbers and locations, list of native tree species to be used and implementation schedule, with the aim to enhance urban biodiversity as well as landscape compatibility with the surrounding natural environment. The implementation schedule shall be in table form to clearly list out the implementation party, timing and environmental performance required for implementation of the compensatory tree planting. The Permit Holder shall consider off-site locations in the urban area such as Tuen Mun Town Center for compensatory tree planting. The Compensatory Tree Planting Implementation Plan shall be prepared with engagement of the Terrestrial Ecologist and Landscape Architect referred to in Condition 2.1, and certified by the ET Leader and verified by the IEC. Prior to submission to the Director for approval, the Permit Holder shall consult the relevant authorities and seek advice from Director of Agriculture, Fisheries and Conservation Department (AFCD) on the Compensatory Tree Planting Implementation Plan.

2.10 The Permit Holder shall, no later than 2 months before the commencement of the construction of the corresponding parts of landscape and visual mitigation measures of the Project, deposit with the Director 3 hard copies and 1 electronic copy of Landscape and Visual Mitigation Plan (LVMP). The LVMP shall demonstrate the conceptual planting layout and proposed structures or facilities with design details, colour, form and material, implementation schedule, maintenance and management schedules and drawings in the scale of 1:1000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures of the Project. The implementation schedule shall be in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. The LVMP shall be certified by the ET Leader and the Landscape Architect and verified by the IEC as conforming to the relevant information and recommendations, including those described in the EIA Report (Register No. AEIAR-239/2022). All mitigation measures

recommended and requirements specified in the LVMP or the updated LVMP shall be fully implemented and maintained for the Project.

- 2.11 The Permit Holder shall include the construction noise mitigation measures and plant inventory recommended in the EIA report (Register No. AEIAR-239/2022) into the tender document for the construction of the Project. If there is any change to the construction noise mitigation measures and/or plant inventory recommended in the EIA report (Register No. AEIAR-239/2022) before the tender invitation for construction of the Project (the invitation), the Permit Holder shall, no later than 2 months before the invitation, deposit with the Director 3 hard copies and 1 electronic copy of a Pre-tender Construction Noise Management Plan (CNMP) and include the deposited Pre-tender CNMP into the tender document. If there is any change to the construction noise mitigation measures and / or plant inventory recommended in the CNMP, the Permit Holder shall, no later than 1 month before the implementation of any such change, deposit with the Director 3 hard copies and 1 electronic copy of an updated CNMP. The CNMP and updated CNMP shall include an implementation schedule in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. The CNMP and updated CNMP shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations of the EIA Report (Register No. AEIAR).

2.13 The Permit Holder shall undertake a pre-construction dive survey to verify the conditions of the coral colonies within the piling footprint between Cafeteria Old Beach and Kadoorie Beach with a view to avoid the construction of viaduct structure in locations which might bring adverse impact to any significant coral colonies in the vicinity. The Permit Holder shall deposit with the Director a pre-construction dive survey report no later than 1 month before the commencement of any marine construction works.

2.14 Piling works associated with the viaduct between Cafeteria Old Beach and Kadoorie Beach shall only be carried out within cofferdams / watertight steel casing, and such works shall have no contact with water outside the cofferdams or the watertight steel casing. Effective silt curtains shall be deployed to enclose the cofferdams / watertight steel casing / temporary steel platform prior to setting up piling works, installation of cofferdam / watertight steel casing and demolition of temporary steel platform. The effective silt curtains shall only be removed after completion of piling works, removal of cofferdam / watertight steel casing and demolition of temporary steel platform.

#### 3 Environmental Monitoring and Audit (EM&A) Requirements 環境監察及審核規定

3.1 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements as set out in the EM&A Manual. Any changes to the EM&A requirements or programme or termination of the programme shall be justified by the ET Leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual before submission to the Director for approval.

- 3.3 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Baseline Monitoring Reports to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director.

3.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Monthly EM&A Reports for the construction stage of the Project to the Director, within 10 working days after the end of the reporting month. The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Monthly EM&A Reports shall be provided upon request by the Director.

4.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 3.3 and 3.4 above. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

All environmental monitoring data described in Condition 4.1 above shall be made available to the public via the abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. - 1. This Permit consists of three parts, namely, Part A (Main Permit), Part B (Description of Designated Project) and Part C (Permit Conditions). - Under Section 14 of the EIAO, the Director may with the consent of the Secretary for 5. Environment and Ecology, suspend, vary or cancel this Permit. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

  - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
  - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
  - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
  - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.


