Pursuant to Section 10 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) grants this environmental permit to the **Drainage Services Department** (hereinafter referred to as the "Permit Holder") to construct and operate the designated project described in **Part B** subject to the conditions specified in **Part C**. The issue of this environmental permit is based on the documents, approvals or permissions described below:

PART B (DESCRIPTION OF DESIGNATED PROJECT)**B 部 (指定工程項目的說明)**

Hereunder is the description of the designated project mentioned in Part A of this environmental permit (hereinafter referred to as the “Permit”):

Scale and Scope of Designated Project 指定工程項目的規模和範圍	The Project includes: - Drainage improvement of two sections of Ping Yuen River, namely TKL04 (about 1.4km long) and TKL05 (about 2.1km long); - Drainage improvement works at Ping Yeung Village, (about 1050m long in total); and - Construction of road drainage system at part of Ping Che Road, (about 1150m long in total). 工程項目包括: - 平原河兩段支流的改善工程，即 TKL04 (約 1.4 公里) 及 TKL05 (約 2.1 公里)； - 坪洋村的雨水排放系統改善工程 (共長約 1050 米)；和 - 在坪峯路興建的道路雨水排放系統 (共長約 1150 米)



PART C (PERMIT CONDITIONS)

C 部 (許可證條件)

1. General Conditions

一般條件

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.
許可證持有人及任何建造或營辦工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況，可能違反《環境影響評估條例》(環評條例)(第 499 章)的規定，而當局可根據環評條例採取適當行動。
- 1.2 The Permit Holder and any person constructing or operating the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.
許可證持有人及任何建造或營辦工程項目的人士須確保完全符合現行法例的規定，包括但不限於《噪音管制條例》(第 400 章)、《空氣污染管制條例》(第 311 章)、《水污染管制條例》(第 358 章)、《海上傾倒物料條例》(第 466 章)及《廢物處置條例》(第 354 章)。本許可證本身不會就根據任何法例提出的法律程序構成任何抗辯理由，或根據任何法例默示任何批准。
- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of this Permit readily available at all times for inspection by the Director or his authorised officers at all sites covered by this Permit. Any reference to this Permit shall include all documents referred to in this Permit and also the relevant documents in the Register.
許可證持有人須印製本許可證的複本，連同本許可證所述的所有文件及本許可證 A 部 所述文件，以供署長或獲授權人員任何時間內在本許可證所涵蓋的所有工地查閱。凡提述本許可證，須包括本許可證所述的所有文件及登記冊內的相關文件。
- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site(s) and ensure that such person(s) fully understands all conditions and all requirements incorporated in this Permit. The site(s) refers to site(s) of construction and operation of the Project and shall mean the same hereafter.
許可證持有人須把本許可證的一份複本交予有關工地的負責人，並確保這些人士完全明白本許可證的所有條件與規定。工地是指建造及營辦工程項目的工地，下文所提及的工地亦屬同一意思。
- 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the



original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

許可證持有人須在建造工地的所有車輛進出口或一處方便地點，顯眼地展示本許可證的複本，以供公眾在任何時間內閱覽。許可證持有人須確保在這些地點展示關於本許可證（包括任何經修訂的許可證）的最新資料。許可證持有人如交回本許可證的部分或全部，必須把其送交署長的通知書，在備有原有許可證的各處相同地點展示。遭暫時吊銷、更改或取消的許可證必須從建造工地除下，不再展示。

- 1.6 The Permit Holder and any person constructing or operating the Project shall construct and operate the Project in accordance with the project description in Part B of this Permit.

許可證持有人及任何建造或營辦工程項目的人士須依據本許可證 B 部的工程項目說明，建造及營辦工程項目。

- 1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No.: AEIAR-238/2022); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

許可證持有人及任何建造或營辦工程項目的人士須確保工程項目按照下述資料設計、建造及營辦：核准環評報告（登記冊編號：AEIAR-238/2022）所說明的資料及相關建議；環境許可證的申請文件；登記冊內的其他相關文件；本許可證所說明的資料及緩解措施；根據本許可證所載的條件須提交予署長存放或獲署長批准的文件所建議的緩解措施；以及在工程項目各階段進行的持續監察及監測工作所建議的緩解措施。登記冊文件所述建議如沒有在本許可證明確表示，則仍須實施這些建議，除非獲本許可證明確豁除或另獲署長同意。

- 1.8 All submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director. 所有按本許可證規定提交的文件，須在接獲署長的意見（如有者）後 1 個月內或署長另行指定的期限內，根據署長的意見加以修正及重新提交。

- 1.9 All submissions approved by the Director, all submissions deposited without comments by the Director, or all submissions rectified in accordance with comments by the Director under this Permit shall be construed as part of the permit conditions described in Part C of this Permit. Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to



in Conditions 2.1 and 2.4 below before submitting to the Director under this Permit.

- 1.10 The Permit Holder shall release all finalised submissions as required under this Permit to the public by depositing copies in the Environmental Impact Assessment Ordinance Register Office, or in any other places, or any internet websites as specified by the Director, or by any means as specified by the Director, for public inspection. For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

許可證持有人須把所有按本許可證規定提交的文件定稿公開給公眾人士知道，方法是把有關文件複本存放於環境影響評估條例登記冊辦事處，或署長指定的任何其他地方，或署長指定的任何互聯網網站，或署長指定的任何方法，以供公眾查閱。為此，許可證持有人須提供足夠數量的複本。

- 1.11 The Permit Holder shall submit and / or deposit all submissions within the time as specified in the Conditions of this Permit. All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). Electronic copies of all finalised submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

許可證持有人須在本許可證條件所列明的時間內，提交及/或存放所有文件。本許可證規定向署長提交的所有文件，須親身送交或以掛號方式郵寄至環境影響評估條例登記冊辦事處（現址為：香港灣仔軒尼詩道 130 號修頓中心 27 樓）。所有按本許可證規定提交的文件定稿的電子複本，均須以超文本標示語言(HTML)(第 4.0 或較後版本)和便攜式文件格式(PDF)(第 1.3 或較後版本)製作，除非另獲署長同意，電子複本須與硬複本同時提交。

- 1.12 The Permit Holder shall notify the Director in writing the commencement date of construction of the Project no later than 2 month prior to the commencement of construction of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of the construction.

許可證持有人須在工程項目建造工程展開前最少 2 個月，以書面方式把工程項目建造工程的展開日期通知署長。建造工程的展開日期如有任何更改，許可證持有人必須立即以書面方式通知署長。

- 1.13 For the purpose of this Permit, “commencement of construction” does not include works related to site clearance and preparation, or other works as agreed by the Director.

為執行本許可證，「建造工程的展開」不包括有關工地清理和預備的工程，或署長同意的其他工程。



- 1.14 The Permit Holder shall notify the Director in writing the commencement date of operation of the Project no later than 3 months prior to the commencement of operation of the Project. The Permit Holder shall notify the Director in writing immediately if there is any change of the commencement date of operation.
許可證持有人須在工程項目開始營辦前最少 3 個月，以書面方式把工程項目開始營辦的日期通知署長。開始營辦的日期如有任何更改，許可證持有人須立即以書面方式通知署長。

2. **Specific Conditions**

Employment or Submissions before Construction of the Project
工程項目施工前須聘用的人員或提交的文件

Employment of Environmental Team (ET)
聘用環境小組

- 2.1 An ET shall be established by the Permit Holder no later than 3 months before the commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET Leader. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management.
許可證持有人須在工程項目建造工程展開前最少 3 個月成立一個環境小組。環境小組不得與工程項目的承辦商或獨立環境查核人有任何關聯。環境小組須由一名環境小組組長帶領。該名環境小組組長須在環境監察及審核（“環監”）或環境管理方面至少有 7 年經驗。
- 2.2 The ET and the ET Leader shall be responsible for duties defined in the EM&A Manual and this Permit, including implementation of the EM&A programme in accordance with the EM&A requirements as contained in the EM&A Manual of the Project; and site inspections to audit the Contractor's site practice and work methodologies with respect to environmental mitigation measures contained in the EM&A Manual of the Project and / or as required under this Permit and to take pro-active actions to pre-empt environmental problems. The ET Leader shall be responsible for:
環境小組及環境小組組長須負責執行環監手冊及本許可證所列明的職務，包括按工程項目的環監手冊所載的環監規定執行環監計劃；以及進行實地視察，以便就工程項目的環監手冊所載及 / 或按本許可證規定的環境緩解措施，審核承辦商的工地作業方式及工作方法，並採取積極行動，防止環境問題出現。環境小組組長須負責：
- (i) certifying the environmental acceptability of permanent and temporary works, relevant plans and submissions required in the EM&A Manual and / or under this Permit. Certification(s) shall be documented in the upcoming EM&A monthly report;
核證永久及臨時工程在環境上的可接受程度、相關的設計圖則和根據環監手冊及本許可證規定提交的文件。核證須記錄於每月環監報告；
 - (ii) notifying the IEC within 1 working day of the occurrence of each and every instance or circumstance or change of circumstances, which may affect the compliance with the recommendations of the approved EIA Report (Register



No. AEIAR-238/2022) and / or this Permit. Notification(s) shall be documented in the upcoming EM&A monthly report; and

在發生可能會影響核准環評報告 (登記冊編號: AEIAR-238/2022) 的建議及 / 或本許可證的合規情況的每宗事件、每種情況或每次情況變化後 1 個工作天內通知獨立環境查核人。通知須記錄於每月環監報告；以及

- (iii) keeping a contemporaneous log-book of any such instance or circumstance or change of circumstances, which may affect the compliance with the EIA Report (Register No. AEIAR-238/2022) and / or this Permit. The format of the log-book shall be certified and approved by the IEC. The log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the approved EIA Report (Register No. AEIAR-238/2022) and this Permit or by the Director or his authorized officers.

- 2.3 Failure to maintain records in the log-book, failure to discharge the duties of the ET Leader as defined in the EM&A Manual or failure to comply with Condition 2.2 above would entitle the Director to require the Permit Holder by notice in writing to replace the ET Leader. Employment of Independent Environmental Checker (IEC)

聘用獨立環境查核人

- 2.4 An IEC shall be employed by the Permit Holder no later than 3 months before the commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management. 許可證持有人須在工程項目建造工程展開前最少 3 個月聘用一名獨立環境查核人。獨立環境查核人不得與工程項目的承辦商或環境小組有任何關聯，而該名獨立環境查核人須在環監或環境管理方面至少有 7 年經驗。
- 2.5 The IEC shall be responsible for duties defined in the EM&A Manual and this Permit, including the following:
獨立環境查核人須執行環監手冊及本許可證所列明的職務，包括以下：
- (i) auditing the overall EM&A performance, including the implementation of all environmental mitigation measures and monitoring activities on site, submissions required in the EM&A Manual, and / or under this Permit. Finding(s) of the audit(s) shall be documented in the upcoming EM&A monthly report.



審核整體環監工作的表現，包括實施所有環境緩解措施和執行現場的監察工作、提交環監手冊及/或本許可證所規定的文件。審核結果須記錄於每月環監報告；

- (ii) verifying the environmental acceptability of permanent and temporary works, relevant design plans and submissions required in the EM&A Manual and under this Permit. Verification(s) shall be documented in the upcoming EM&A monthly report;
核實永久及臨時工程在環境上的可接受程度、相關的設計圖則和根據環監手冊及本許可證規定提交的文件。核實結果須記錄於每月環監報告；
- (iii) verifying the log-book(s) mentioned in Condition 2.2(iii). The IEC shall sign off with a date on the log-book after verification;
核實條件第 2.2 (iii) 項所述的記錄冊。核實後獨立環境查核人須於記錄冊上簽署；
- (iv) notifying the Director by fax or email, within one working day of receipt of notification from the ET Leader, or identification by the IEC and his team, of each and every change of circumstances or suspected and / or potential non-compliance with the recommendations (such as construction methods, mitigation measures, and environmental standards) of the approved EIA Report (Register No. AEIAR-238/2022), the EM&A Manual and this Permit, which might affect the monitoring or control of adverse environmental impacts arising from the Project. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition;

- (v) liaising closely with the Director;

- (vi) accompanying the Director in carrying out site inspections and attending meetings when requested;

- (vii) offering objective and professional advice on environmental issues, when requested, and to respond to questions and enquiries from the Director on the project, the EM&A programme and duties discharged by the IEC, with the support of relevant information, documents and records as appropriate; and
按要求就環境問題提供客觀及專業意見, 並提供合適的相關資料、文件和記錄, 以回應署長就環監計劃及獨立環境查核人所執行之職務提出的問題及查詢；以及
- (viii) allocating adequate resources, including any necessary specialist support, for discharging the duties required in the EM&A Manual and / or this Permit.

- 2.6 If the Director considers the IEC fails to discharge the duties of the IEC as defined in the EM&A Manual or in this Permit, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render this Permit liable to suspension, cancellation or variation.

如署長認為獨立環境查核人未能執行環監手冊或本許可證所列明的獨立環境查核人職務，署長可藉書面通知要求許可證持有人撤換獨立環境查核人。如未能按指示撤換獨立環境查核人，或在聘用新獨立環境查核人後仍未能通知署長有關情況，則或會導致本許可證遭暫時吊銷、取消或更改。

Employment of Qualified Ecologist(s)

聘用合資格的生態學家

- 2.7 The ecologist(s) shall be employed by the Permit Holder before commencement of construction of the Project. The ecologist(s) shall prepare the submissions under Conditions 2.11, 2.13, 2.14 and 3.2 of this Permit and carry out works relating to ecological aspects including but not limited to conducting the detailed vegetation survey and translocation proposal, carrying out the translocation and post-translocation monitoring, conducting egret count and auditing the mitigation measures to ensure compliance with the recommendations of the approved EIA Report (Register No. AEIAR-238/2022). The qualification and experience of the ecologist(s) shall be agreed by Agriculture, Fisheries and Conservation Department (AFCD).

Employment of Registered Landscape Architect

聘用註冊園境師

- 2.8 The Permit Holder shall, no later than 3 months before the commencement of the construction of the Project, appoint a Registered Landscape Architect to form part of the ET to carry out work relating to landscape aspects including but not limited to preparing submission of the Landscape & Visual Mitigation Plan(s) for the Project as required under Condition 2.13 of this Permit, and to audit the implementation of landscape and visual mitigation measures to ensure compliance with the recommendations of the approved submission under Condition 2.13 of this Permit and the approved EIA Report (Register No. AEIAR-238/2022). The qualification and experience of the Registered Landscape Architect shall be certified by the ET Leader and verified by the IEC.

許可證持有人須在工程項目的建造工程展開前最少 3 個月，聘用一名註冊園境師作為環境小組成員，以進行與景觀有關的工作，包括但不限於按照本許可證條件第 2.13 項的規定，就工程項目擬備須提交的一份（或多份）景觀及視覺影響緩解計劃，並審核景觀及視覺影響緩解措施的執行情況，確保已遵從按照本許可證條件第 2.13 項規定提交的核准文件和核准環評報告（登記冊編號：AEIAR-238/2022）載述的建議。註冊園境師的資格及經驗須由環境小組組長核證，並經獨立環境查核人核實。



Submission of Environmental Permit (EP) Submission Schedule

- 2.9 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, submit an EP Submission Schedule to set out a timeline for EP submissions in this Permit and shall report the progress in fulfilling the submission requirements in the monthly EM&A reports submitted under Condition 4.4 of this Permit. The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date of the EP submission in writing in case of any subsequent change(s) to the submitted EP Submission Schedule. The EP Submission Schedule or any subsequent change(s) to the submitted Schedule shall be certified by the ET Leader and verified by the IEC before submitting to the Director under this Permit.

- 2.10 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, inform the Director in writing the following information:

- (iv) the submitted information shall include at least an organization chart, names of responsible persons and their contact details.

Submission of Detailed Vegetation Survey Report and Plant Preservation and Transplantation Proposal

- 2.11 To minimize the potential impact on flora species of conservation importance due to construction of the Project, including *Aquilaria sinensis*, *Cephalanthus tetrandrus*,



Mucuna championii and *Neottopteris nidus*, and any other flora species of conservation importance, the Permit Holder shall:

- (i) no later than 1 month before the commencement of site clearance works, submit 4 hard copies and 1 electronic copy of a Detailed Vegetation Survey Report (DVSR) to the Director for approval. The DVSR shall provide the methodology as well as survey results, including the updated conditions, number and locations of the individuals of flora species of conservation importance identified within the works boundary confirming whether any individuals of these species would be directly affected by the proposed works, recommending protective measures for identified individuals of each species where in situ preservation is feasible, and assessing the suitability and/or practicality of the transplantation of those individuals to be directly affected to the Director for approval;

- (ii) no later than 1 month before the commencement of site clearance works, submit 4 hard copies and 1 electronic copy of a Plant Preservation and Transplantation Proposal (PPTP) to the Director for approval. The PPTP shall include but not limited to the following information:

measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. The DVSR and the PPTP shall be prepared by the qualified ecologist(s) employed under Condition 2.7, certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations contained in the approved EIA Report (Register No. AEIAR-238/2022). The mitigation measures recommended and requirements specified in the approved DVSR and the approved PPTP shall be fully implemented. No vegetation clearance shall be carried out before approval of the DVSR and the PPTP. Prior to submission to the Director for approval, the Permit Holder shall consult the relevant authorities and seek advice from AFCD on the DVSR and PPTP.

Submission of Waste Management Plan **提交廢物管理計劃**

- 2.12 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, deposit with the Director 3 hard copies and 1 electronic copy of a Waste Management Plan (WMP). The WMP shall include estimated volume of different types of waste, e.g. construction and demolition (C&D materials) materials, chemical waste, general refuse, etc., and also the arrangements for avoidance, minimization, recovery, recycling, reuse, storage, collection, treatment and disposal of different categories of waste to be generated from the construction activities. The WMP shall also describe the tracking system to be adopted to avoid illegal dumping or landfilling of C&D materials. The WMP shall include an implementation schedule in table form to clearly list out the amount and disposal outlet for the different types of waste arising, mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. All mitigation measures recommended and requirements specified in the WMP and the implementation schedule shall be fully implemented.

許可證持有人須在工程項目的建造工程展開前最少 1 個月，把廢物管理計劃的 3 份硬複本及 1 份電子複本送交署長存放。廢物管理計劃須包括建築活動所產生的各種廢物(如建築和拆卸物料、化學廢物及一般垃圾)的估計數量，以及就避免、盡量減少、回收、循環再用、重用、貯存、收集、處理及處置各類廢物而作出的安排。廢物管理計劃亦須說明追蹤系統，以防止非法棄置或堆填建築和拆卸物料。廢物管理計劃須包括以列表形式列出的實施時間表，清楚列明將會執行的緩解措施、實施者、地點、時間，以及實施緩解措施時須達到的環境表現規定。廢物管理計劃及實施時間表中建議的所有緩解措施及指明的規定，均須全面予以實施。



Submission of Landscape and Visual Mitigation Plan 提交景觀及視覺影響緩解計劃

- 2.13 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project or otherwise approved by the Director, submit to the Director for approval 4 hard copies and 1 electronic copy of a Landscape and Visual Mitigation Plan (LVMP). The LVMP shall incorporate the design of green channel and wildlife corridor with landscape planting along the channel edges with a view to enhancing habitat connectivity and revitalising the channels with visual and landscape benefits for public enjoyment. The LVMP shall include recommendations of landscape and visual mitigation measures, implementation programme, maintenance and management schedules, and drawings in the scale of 1: 1,000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures. The LVMP shall include an implementation schedule in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing and environmental performance required for implementation of the mitigation measures. If there are any change(s) to the landscape and visual mitigation measures in the approved LVMP, the Permit Holder shall, no later than 1 month before the implementation of such change(s), submit 4 hard copies and 1 electronic copy of the Updated LVMP with clear indication of the proposed change(s). Before submission to the Director, the LVMP or any Updated LVMP shall be prepared by the qualified ecologist(s) and Registered Landscape Architect employed under Condition 2.7 and Condition 2.8 respectively, certified by the ET Leader, and verified by the IEC as conforming to the relevant information and recommendations on landscape and visual mitigation measures contained in the approved EIA report (Register No. AEIAR-238/2022) or provide with adequate and relevant justifications. All landscape and visual mitigation measures recommended in the LVMP or any Updated LVMP shall be fully implemented. The Permit Holder shall make available additional copies of the LVMP or any Updated LVMP to the Director upon request. The Permit Holder shall consult the relevant government departments including Planning Department on the LVMP prior to submission to the Director.

許可證持有人須在工程項目的建造工程展開前最少1個月，或在署長另行批准的限期前，向署長提交景觀及視覺影響緩解計劃(緩解計劃)的4份硬複本及1份電子版本，以供審批。緩解計劃須加入綠化河道和野生生物走廊的設計，在河道兩旁進行景觀美化種植，以期加強生境連繫和活化河道，並同時營造良好的視覺和景觀效果，供公眾享用。緩解計劃須包括景觀及視覺影響緩解措施的建議、實施計劃、保養及管理時間表，以及採用1:1000的比例或署長同意的其他合適比例繪畫的圖則。緩解計劃亦須包括以列表形式擬備的實施一覽表，清楚列明將會實施的緩解措施、實施者、地點、時間，以及實施緩解措施時須達到的環境效益。如核准緩解計劃內的景觀及視覺影響緩解措施有任何更改，許可證持有人須在實施有關更改前最少1個月，提交最新的緩解計劃的4份硬複本及1份電子版本，清楚顯示擬議更改。緩解計劃或任何最新的緩解計劃須由合資格生態學家、註冊園境師(分別根據條件第2.7項及第2.8項聘用)擬備，並由環境小組組長核證，再經獨立環境查核人核實，證明符合核准環評報告(登記冊編號：AEIAR-238/2022)所載有關景觀及視覺影響緩解措施的資料和建議，或提供充分的相關理據，然後才提交署長。緩解計劃或任何最新的緩解計劃所建議的所有景觀及視覺影響緩解措施均須全面予以執行。許可證持有人須按要求向署長提供緩解計劃或任何最新的緩解計劃的額外複本。許可證持有人須就緩解計劃徵詢有關政府部門(包括規劃署)的意見，然後才提交署長。



Submission of Chinese Bullfrog Translocation Plan 提交虎紋蛙遷徙計劃

- 2.14 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project or otherwise approved by the Director, submit to the Director for approval 4 hard copies and 1 electronic copy of a Chinese Bullfrog Translocation Plan (CBTP), prepared by the qualified ecologist(s) employed under Condition 2.7, certified by the ET Leader and verified by the IEC. The CBTP shall include details of the pre-construction aquatic survey at the Project site and the receptor site(s), translocation methodology, identification of location(s) and suitability of the receptor site(s), carrying out the translocation, post-translocation monitoring programme as well as a contingency plan in case of failure of the translocation. All mitigation measures recommended and requirements specified in the CBTP shall be fully implemented. The Permit Holder shall consult the AFCD on the CBTP prior to submission to the Director. The Permit Holder shall also, no later than 2 weeks after the completion of pre-construction survey and translocation, deposit with the Director 4 hard copies and 1 electronic copy of pre-construction survey and translocation report, prepared by the qualified ecologist(s) employed under Condition 2.7, certified by the ET Leader and verified by the IEC, showing pre-construction survey results, numbers and types of translocated species, and locations of the receptor site(s).

許可證持有人須在工程項目的建造工程展開前最少 1 個月，或在署長另行批准的限期前，向署長提交受影響虎紋蛙遷徙計劃(遷徙計劃)的 4 份硬複本及 1 份電子版本，以供審批。遷徙計劃須由根據條件第 2.7 項聘用的合資格生態學家擬備，並由環境小組組長核證，再經獨立環境查核人核實，內容包括在工程項目範圍和接收地進行施工前期水生調查的詳情、遷徙方法、尋找接收地和確定有關地點是否合適、遷徙的執行過程、遷徙後監察計劃，以及遷徙萬一失敗時的應變計劃。遷徙計劃建議的所有緩解措施和指明的規定，均須全面予以執行。許可證持有人須就遷徙計劃徵詢漁護署的意見，然後才提交署長。許可證持有人須於施工前期調查及遷徙完成後 2 個星期內，把由合資格生態學家(根據條件第 2.7 項聘用)擬備，並由環境小組組長核證，再經獨立環境查核人核實的施工前期調查及遷徙報告的 4 份硬複本及 1 份電子版本送交署長存放，調查及報告的內容包括施工前期調查結果、遷徙物種的數目和類別，以及接收地的位置圖。

3. Measures during Construction of the Project 工程項目施工期間須採取的措施

Measures to Mitigate Water Quality Impacts *緩解水質影響的措施*

- 3.1 To minimize potential impacts on water quality during the channel works for the proposed drainage improvements at Ping Yuen River, the excavation works shall be carried out within an artificially enclosed dry section of the drainage channels.

鑑於平原河擬議進行雨水排放系統改善工程，為盡量減低排水道工程期間對水質可能造成的影響，挖掘工程須在排水道的人工圍封乾涸範圍內進行。

Measures to Mitigate Ecological Impacts *緩解生態影響的措施*

- 3.2 In order to mitigate the potential disturbance to the Ping Che Egretty during construction, all construction works proposed within 100m radius from the Ping Che



Egretry should be scheduled outside the ardeids breeding season, i.e. March to August. Monthly egret count during the breeding season should be conducted at Ping Che Egret by the qualified ecologist(s) employed under Condition 2.7 to monitor any abnormal changes in nesting ardeids due to indirect impacts from the construction activities. In case abnormal changes in nesting ardeids are found, the qualified ecologist(s) should propose mitigation measures to avoid disturbance to breeding and roosting ardeids. All findings should be reported in the Monthly EM&A Report to be submitted under Condition 4.4.

為盡量減少建造工程期間對坪輦鷺鳥林造成的滋擾，建造工程只可在鷺鳥繁殖季節(即3月至8月)以外進行。在繁殖季節期間，合資格生態學家(根據條件第2.7項聘用)須每月在坪輦鷺鳥林進行鷺鳥點算工作，以監測因建造工程對鷺鳥築巢帶來任何間接影響而造成異常變化。如發現任何異常變化，合資格的生態學家須建議緩解措施，以避免對鷺鳥的繁殖和棲息造成滋擾。所有結果須記錄在根據條件4.4提交的每月環監報告內。

4 Environmental Monitoring and Audit (EM&A) Requirements **環境監察及審核規定**

- 4.1 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements as set out in the EM&A Manual. Any changes to the EM&A requirements or programme or termination of the programme shall be justified by the ET Leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual before submission to the Director for approval.

許可證持有人須按照環監手冊所載的程序及規定執行環監計劃。環監的規定或計劃如有更改或計劃如終止，須由環境小組組長提出理據並由獨立環境查核人核實，證明其符合環監手冊所載的資料及規定，然後才提交署長批准。

- 4.2 The Permit Holder shall take samples, measurements and necessary remedial actions in accordance with the requirements of the EM&A Manual by:

許可證持有人須按照環監手冊所載的規定，透過以下方法進行取樣、測量及所需的補救行動：

- (i) conducting baseline environmental monitoring;
進行環境基線監測；
- (ii) conducting impact monitoring;
進行影響監測；
- (iii) carrying out remedial actions described in the Event/Action Plans of the EM&A Manual in accordance with the time frame set out in the Event/Action Plans, or as agreed by the Director, in case where specified criteria in the EM&A Manual are exceeded; and
如超逾環監手冊內指定的標準，則按照環監手冊內的事件／行動計劃所訂明的時限或署長所同意的時限，執行事件／行動計劃所說明的補救行動；以及
- (iv) logging and keeping records of the details of (i) to (iii) above for all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available the information for inspection on site.



在收集數據或完成補救行動 3 個工作天內，須記錄及備存上文(i)至(iii)段所有參數的詳情，用作擬備及提交每月環監報告，並備妥有關資料以供在工地查閱。

- 4.3 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Baseline Monitoring Reports to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director.
許可證持有人須在展開工程項目的建造工程前最少 2 個星期向署長提交基線監測報告的 1 份硬複本及 1 份電子版本。提交文件須由環境小組組長核證及獨立環境查核人核實，證明其符合環監手冊所載的規定，然後才提交署長。如署長要求，則須提交基線監測報告的額外複本。
- 4.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Monthly EM&A Reports for the construction stage of the Project to the Director, within 10 working days after the end of the reporting month. The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Monthly EM&A Reports shall be provided upon request by the Director.
在每個提交報告的月份結束後 10 個工作天內，許可證持有人須向署長提交工程項目建築階段每月環監報告的 1 份硬複本及 1 份電子版本。每月環監報告須包括各項環境審核結果，以及在發生不符合（超出）環境質素表現規限（行動及極限水平）情況時所採取的行動、接獲有關違反環境法例的投訴及發生相關緊急事件的行政摘要。提交的報告須由環境小組組長核證及獨立環境查核人核實，證明其符合環監手冊所載的規定，然後才提交署長。如署長要求，則須向署長提交每月環監報告的額外複本。
- 4.5 All environmental monitoring and audit data submitted under this Permit shall be true, valid and correct.
根據本許可證提交的所有環監數據，均須有效及真實無誤。
- 4.6 To ensure a high degree of transparency regarding the monitoring data and results in view of the public concern about the Project, all environmental monitoring and audit data and results and all submissions and all performance test data and results required by this Permit shall be made available by the Permit Holder to the public through a dedicated website to be set up by the Permit Holder under Condition 5.2 below, in the shortest practicable time and in no event later than 10 working days after such information is available.

5. **Electronic Reporting of EM&A Information**
環監資料的電子匯報

- 5.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 4.3 and 4.4 above. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

- 5.2 The Permit Holder shall, within 4 weeks after the commencement of construction of the Project, set up a dedicated Internet website and notify the Director in writing the Internet address where the environmental monitoring data and project information is to be placed. All environmental monitoring data described in Condition 5.1 above shall be made available to the public via the abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the entire construction period and until 2 months after the last EM&A report is uploaded, or otherwise as agreed by the Director.

- 5.3 The Internet website as described in Condition 5.2 above shall enable user-friendly public access to the environmental monitoring data and project information including the Project Profile, EIA Report and Environmental Permit(s). The Internet website shall have features capable of:

1. This Permit consists of three parts, namely, Part A (Main Permit), Part B (Description of Designated Project) and Part C (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

2. If there is a breach of any condition of this Permit, the Director or his authorized officer may, with the consent of the Secretary for Environment and Ecology, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

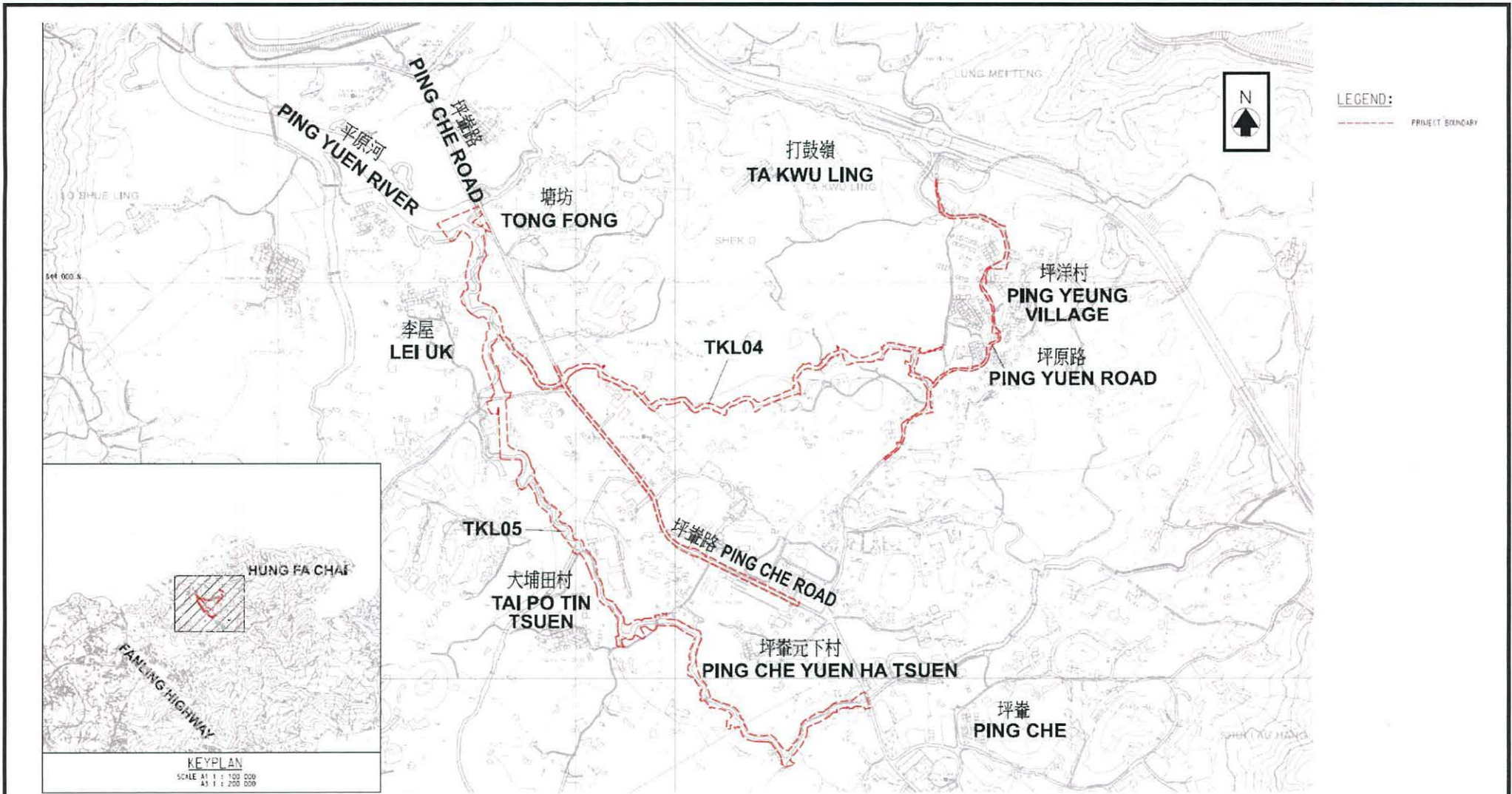

8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit.
