#### PART C (PERMIT CONDITIONS) C部 (許可證條件)

## 1. <u>General Conditions</u> 一般條件

- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

- 1.2 The Permit Holder and any person constructing or operating the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). - 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit and the documents referred to in Part A of this Permit readily available at all times for inspection by the Director or his authorised officers at all sites covered by this Permit. - 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the

original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

- 1.7 The Permit Holder and any person constructing or operating the Project shall ensure that the Project is designed, constructed and operated in accordance with the information and recommendations described in the approved EIA Report (Register No.: AEIAR-238/2022); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to

in Conditions 2.1 and 2.4 below before submitting to the Director under this Permit.

For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). - 1.13 For the purpose of this Permit, "commencement of construction" does not include works related to site clearance and preparation, or other works as agreed by the Director.

1.14 The Permit Holder shall notify the Director in writing the commencement date of operation of the Project no later than 3 months prior to the commencement of operation of the Project. Employment of Environmental Team (ET) 聘用環境小組

- An ET shall be established by the Permit Holder no later than 3 months before the commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET Leader. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management. 許可證持有人須在工程項目建造工程展開前最少 3 個月成立一個環境小組。環境小組不得與工程項目的承辦商或獨立環境查核人有任何關聯。環境小組須由一名環境小組組長帶領。該名環境小組組長須在環境監察及審核("環監")或環境管理方面至少有 7 年經驗。
- 2.2 The ET and the ET Leader shall be responsible for duties defined in the EM&A Manual and this Permit, including implementation of the EM&A programme in accordance with the EM&A requirements as contained in the EM&A Manual of the Project; and site inspections to audit the Contractor's site practice and work methodologies with respect to environmental mitigation measures contained in the EM&A Manual of the Project and / or as required under this Permit and to take pro-active actions to pre-empt environmental problems. The ET Leader shall be responsible for:

The log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the approved EIA Report (Register No. AEIAR-238/2022) and this Permit or by the Director or his authorized officers.

The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management. 許可證持有人須在工程項目建造工程展開前最少 3 個月聘用一名獨立環境查核人。獨立環境查核人不得與工程項目的承辦商或環境小組有任何關聯,而該名獨立環境查核人須在環監或環境管理方面至少有7年經驗。
- 2.5 The IEC shall be responsible for duties defined in the EM&A Manual and this Permit, including the following:

2.6 If the Director considers the IEC fails to discharge the duties of the IEC as defined in the EM&A Manual or in this Permit, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render this Permit liable to suspension, cancellation or variation.

2.7 The ecologist(s) shall be employed by the Permit Holder before commencement of construction of the Project. The ecologist(s) shall prepare the submissions under Conditions 2.11, 2.13, 2.14 and 3.2 of this Permit and carry out works relating to ecological aspects including but not limited to conducting the detailed vegetation survey and transplantation proposal, carrying out the translocation and post-translocation monitoring, conducting egretry count and auditing the mitigation measures to ensure compliance with the recommendations of the approved EIA Report (Register No. AEIAR-238/2022). The qualification and experience of the ecologist(s) shall be agreed by Agriculture, Fisheries and Conservation Department (AFCD).

2.8 The Permit Holder shall, no later than 3 months before the commencement of the construction of the Project, appoint a Registered Landscape Architect to form part of the ET to carry out work relating to landscape aspects including but not limited to preparing submission of the Landscape & Visual Mitigation Plan(s) for the Project as required under Condition 2.13 of this Permit, and to audit the implementation of landscape and visual mitigation measures to ensure compliance with the recommendations of the approved submission under Condition 2.13 of this Permit and the approved EIA Report (Register No. AEIAR-238/2022). The qualification and experience of the Registered Landscape Architect shall be certified by the ET Leader and verified by the IEC.

2.9 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, submit an EP Submission Schedule to set out a timeline for EP submissions in this Permit and shall report the progress in fulfilling the submission requirements in the monthly EM&A reports submitted under Condition 4.4 of this Permit. The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date of the EP submission in writing in case of any subsequent change(s) to the submitted EP Submission Schedule. The EP Submission Schedule or any subsequent change(s) to the submitted Schedule shall be certified by the ET Leader and verified by the IEC before submitting to the Director under this Permit.

2.11 To minimize the potential impact on flora species of conservation importance due to construction of the Project, including *Aquilaria sinensis*, *Cephalanthus tetrandrus*.

Mucuna championii and Neottopteris nidus, and any other flora species of conservation importance, the Permit Holder shall:

The DVSR and the PPTP shall be prepared by the qualified ecologist(s) employed under Condition 2.7, certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations contained in the approved EIA Report (Register No. AEIAR-238/2022). The mitigation measures recommended and requirements specified in the approved DVSR and the approved PPTP shall be fully implemented. No vegetation clearance shall be carried out before approval of the DVSR and the PPTP. Prior to submission to the Director for approval, the Permit Holder shall consult the relevant authorities and seek advice from AFCD on the DVSR and PPTP.

The WMP shall include estimated volume of different types of waste, e.g. construction and demolition (C&D materials) materials, chemical waste, general refuse, etc., and also the arrangements for avoidance, minimization, recovery, recycling, reuse, storage, collection, treatment and disposal of different categories of waste to be generated from the construction activities. The WMP shall also describe the tracking system to be adopted to avoid illegal dumping or landfilling of C&D materials. The WMP shall include an implementation schedule in table form to clearly list out the amount and disposal outlet for the different types of waste arising, mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. All mitigation measures recommended and requirements specified in the WMP and the implementation schedule shall be fully implemented.

2.13 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project or otherwise approved by the Director, submit to the Director for approval 4 hard copies and 1 electronic copy of a Landscape and Visual Mitigation Plan (LVMP). The LVMP shall incorporate the design of green channel and wildlife corridor with landscape planting along the channel edges with a view to enhancing habitat connectivity and revitalising the channels with visual and landscape benefits for public enjoyment. The LVMP shall include recommendations of landscape and visual mitigation measures, implementation programme, maintenance and management schedules, and drawings in the scale of 1: 1,000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures. The LVMP shall include an implementation schedule in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing and environmental performance required for implementation of the mitigation measures. If there are any change(s) to the landscape and visual mitigation measures in the approved LVMP, the Permit Holder shall, no later than 1 month before the implementation of such change(s), submit 4 hard copies and 1 electronic copy of the Updated LVMP with clear indication of the proposed change(s). Before submission to the Director, the LVMP or any Updated LVMP shall be prepared by the qualified ecologist(s) and Registered Landscape Architect employed under Condition 2.7 and Condition 2.8 respectively, certified by the ET Leader, and verified by the IEC as conforming to the relevant information and recommendations on landscape and visual mitigation measures contained in the approved EIA report (Register No. AEIAR-238/2022) or provide with adequate and relevant justifications. All landscape and visual mitigation measures recommended in the LVMP or any Updated LVMP shall be fully implemented. The Permit Holder shall make available additional copies of the LVMP or any Updated LVMP to the Director upon request. The Permit Holder shall consult the relevant government departments including Planning Department on the LVMP prior to submission to the Director.

#### Submission of Chinese Bullfrog Translocation Plan 提交虎紋蛙遷徙計劃

2.14 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project or otherwise approved by the Director, submit to the Director for approval 4 hard copies and 1 electronic copy of a Chinese Bullfrog Translocation Plan (CBTP), prepared by the qualified ecologist(s) employed under Condition 2.7, certified by the ET Leader and verified by the IEC. The CBTP shall include details of the pre-construction aquatic survey at the Project site and the receptor site(s), translocation methodology, identification of location(s) and suitability of the receptor site(s), carrying out the translocation, post-translocation monitoring programme as well as a contingency plan in case of failure of the translocation. All mitigation measures recommended and requirements specified in the CBTP shall be fully implemented. The Permit Holder shall consult the AFCD on the CBTP prior to submission to the Director. The Permit Holder shall also, no later than 2 weeks after the completion of pre-construction survey and translocation, deposit with the Director 4 hard copies and 1 electronic copy of pre-construction survey and translocation report, prepared by the qualified ecologist(s) employed under Condition 2.7, certified by the ET Leader and verified by the IEC, showing pre-construction survey results, numbers and types of translocated species, and locations of the receptor site(s). 許可證持有人須在工程項目的建造工程展開前最少 1 個月,或在署長另行批准 的限期前,向署長提交受影響虎紋蚌遷徙計劃(遷徙計劃)的 4 份硬複本及 1 份 電子版本,以供審批。遷徙計劃須由根據條件第 2.7 項聘用的合資格生態學家 擬備,並由環境小組組長核證,再經獨立環境查核人核實,內容包括在工程項 目範圍和接收地進行施工前期水生調查的詳情、遷徙方法、尋找接收地和確定 有關地點是否合適、遷徙的執行過程、遷徙後監察計劃,以及遷徙萬一失敗時 的應變計劃。遷徙計劃建議的所有緩解措施和指明的規定,均須全面予以執 行。許可證持有人須就遷徙計劃徵詢漁護署的意見,然後才提交署長。許可證 持有人須於施工前期調查及遷徙完成後 2 個星期內,把由合資格生態學家(根據 條件第 2.7 項聘用)擬備,並由環境小組組長核證,再經獨立環境查核人核實的 施工前期調查及遷徙報告的 4 份硬複本及 1 份電子版本送交署長存放,調查及 報告的內容包括施工前期調查結果、遷徙物種的數目和類別,以及接收地的位 置昌。

### 3. <u>Measures during Construction of the Project</u> 工程項目施工期間須採取的措施

#### Measures to Mitigate Water Quality Impacts 緩解水質影響的措施

3.1 To minimize potential impacts on water quality during the channel works for the proposed drainage improvements at Ping Yuen River, the excavation works shall be carried out within an artificially enclosed dry section of the drainage channels.

#### Measures to Mitigate Ecological Impacts 緩解生態影響的措施

3.2 In order to mitigate the potential disturbance to the Ping Che Egretry during construction, all construction works proposed within 100m radius from the Ping Che

Egretry should be scheduled outside the ardeids breeding season, i.e. March to August. Monthly egretry count during the breeding season should be conducted at Ping Che Egretry by the qualified ecologist(s) employed under Condition 2.7 to monitor any abnormal changes in nesting ardeids due to indirect impacts from the construction activities. In case abnormal changes in nesting ardeids are found, the qualified ecologist(s) should propose mitigation measures to avoid disturbance to breeding and roosting ardeids. All findings should be reported in the Monthly EM&A Report to be submitted under Condition 4.4.

## 4 <u>Environmental Monitoring and Audit (EM&A) Requirements</u> 環境監察及審核規定

4.1 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements as set out in the EM&A Manual. Any changes to the EM&A requirements or programme or termination of the programme shall be justified by the ET Leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual before submission to the Director for approval.

  - (i) conducting baseline environmental monitoring; 進行環境基線監測;
  - (ii) conducting impact monitoring; 進行影響監測;
  - (iii) carrying out remedial actions described in the Event/Action Plans of the EM&A Manual in accordance with the time frame set out in the Event/Action Plans, or as agreed by the Director, in case where specified criteria in the EM&A Manual are exceeded; and 如超逾環監手冊內指定的標準,則按照環監手冊內的事件/行動計劃所訂明的時限或署長所同意的時限,執行事件/行動計劃所說明的補救行動;以及
  - (iv) logging and keeping records of the details of (i) to (iii) above for all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available the information for inspection on six

- 4.3 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Baseline Monitoring Reports to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Baseline Monitoring Reports shall be provided upon request by the Director. 許可證持有人須在展開工程項目的建造工程前最少 2 個星期向署長提交基線監測報告的 1 份硬複本及 1 份電子版本。提交文件須由環境小組組長核證及獨立環境查核人核實,證明其符合環監手冊所載的規定,然後才提交署長。如署長要求,則須提交基線監測報告的額外複本。
- 4.4 The Permit Holder shall submit 1 hard copy and 1 electronic copy of Monthly EM&A Reports for the construction stage of the Project to the Director, within 10 working days after the end of the reporting month. The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Monthly EM&A Reports shall be provided upon request by the Director.

- 4.5 All environmental monitoring and audit data submitted under this Permit shall be true, valid and correct.

- 4.6 To ensure a high degree of transparency regarding the monitoring data and results in view of the public concern about the Project, all environmental monitoring and audit data and results and all submissions and all performance test data and results required by this Permit shall be made available by the Permit Holder to the public through a dedicated website to be set up by the Permit Holder under Condition 5.2 below, in the shortest practicable time and in no event later than 10 working days after such information is available.

### 5. <u>Electronic Reporting of EM&A Information</u> 環監資料的電子匯報

5.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 4.3 and 4.4 above. For the HTML version, a content page capable of providing hyperlink to each section and subsection of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

All environmental monitoring data described in Condition 5.1 above shall be made available to the public via the abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the entire construction period and until 2 months after the last EM&A report is uploaded, or otherwise as agreed by the Director.

- 1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the EIAO, and the following notes are for general information only.

- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

  - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
  - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months:
  - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
  - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.


