- 1.1 The Permit Holder and any person constructing the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO. 許可證持有人及任何建造工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(環評條例) (第 499 章) 的規定,而當局可根據環評條例採取適當行動。
- 1.2 The Permit Holder and any person constructing the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). - 1.5 The Permit Holder shall display conspicuously a copy of this Permit on the construction site(s) at all vehicular site entrances/exits or at a convenient location for public's information at all times. The Permit Holder shall ensure that the most updated information about this Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of this Permit, the notice he sends to the Director shall also be displayed at the same locations as the

original Permit. The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

- 1.7 The Permit Holder and any person constructing the Project shall ensure that the Project is designed and constructed in accordance with the information and recommendations described in the Project Profile (Register No.: PP-651/2022); the application documents for environmental permits; other relevant document in the Register; the information and mitigation measures described in this Permit; mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit or otherwise agreed by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). All submissions or any variation of submissions shall be certified by the Independent Environmental Checker referred to in Condition 2.1 below before submitting to the Director under this Permit

All submissions to the Director required under this Permit shall be delivered either in person or by registered mail to the Environmental Impact Assessment Ordinance Register Office (currently at 27/F, Southorn Centre, 130 Hennessy Road, Wanchai, Hong Kong). 2. <u>Specific Conditions</u> 特定條件

Employment of Independent Environmental Checker 聘用獨立環境查核人

2.1 An Independent Environmental Checker (IEC) shall be employed by the Permit Holder before commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor for the Project. The IEC shall be a person who has at least 7 years of experience in Environmental Monitoring and Audit or environmental management. The IEC shall audit the implementation of the environmental mitigation measures recommended in the Project Profile (Register No. PP-651/2022) and required under this Permit, and to confirm full compliance of the mitigation measures through an audit report. The Permit Holder shall, within one month upon completion of the construction works, submit to the Director 2 hard copies and 1 electronic copy of the audit report prepared by the IEC. 許可證持有人須在工程項目的建造工程展開前聘用一名獨立環境查核人。獨立 環境查核人不得與工程項目的承辦商有任何聯繫。獨立環境查核人須在環境監 察及審核或環境管理方面最少有 7 年經驗。獨立環境查核人須審核工程項目簡 介 (登記冊編號: PP-651/2022) 內及本許可證條件中建議的環境保護措施的實施 工作, 並在審核報告書確認所有措施的實施完全符合工程項目簡介以及各許可 證條件的規定。許可證持有人須在建造工程完成後1個月內,向署長提交由獨立 環境查核人擬備的審核報告書的2份硬複本及1份電子複本。

Employment of Ecologist 聘用生態學家

An ecologist shall be employed by the Permit Holder before commencement of construction of the Project. The ecologist shall certify the submission under Condition 2.3 of this Permit. The ecologist shall also monitor the implementation of ecological mitigation measures, including but not limited to those related to the protection of flora species of conservation importance, during construction. The ecologist shall be a person who has at least 3 years of relevant experience. The qualification and experience of the ecologist shall be verified by the IEC. 許可證持有人須在工程項目的建造工程展開前聘用一名生態學家。生態學家須根據本許可證條件第2.3項核證提交文件。生態學家亦須在建造工程期間監察生態緩解措施的實施情況,包括但不限於保護具存護重要性的植物物種的措施。生態學家須具備至少3年相關經驗,其資格及經驗須由獨立環境查核人核實。

Submission of Proposal for Reinstatement Works 提交復原工程提議

2.3 The Permit Holder shall, no later than 1 month before the commencement of reinstatement works of the works areas and associated temporary access (except the area for groundwater monitoring), deposit with the Director 4 hard copies and 1 electronic copy of the proposal for reinstatement works, certified by the ecologist appointed under Condition 2.2 above, and verified by the IEC. The measure(s) recommended and requirement(s) specified in the proposal for reinstatement works shall be fully implemented.

 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 - on a first summary conviction to a fine at level 6 and to imprisonment for 6 (iii) months;
 - on a second or subsequent summary conviction to a fine of \$1 million and to (iv) imprisonment for 1 year; and
 - in any case where the offence is of a continuing nature, the court or (v) magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.
