- 1.1 The Permit Holder and any person constructing or operating the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO. 許可證持有人及任何建造或營辦工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》(環評條例)(第 499 章)的規定,而當局可根據環評條例採取適當行動。
- 1.2 The Permit Holder and any person constructing or operating the Project shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466), and Waste Disposal Ordinance (Cap. 354). The suspended, varied or cancelled Permit shall be removed from display at the construction site(s).

Any non-compliance with the submissions may constitute a contravention of the EIAO (Cap. 499). Electronic copies of all finalized submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

2.1 An ET shall be established by the Permit Holder no later than two months before the commencement of construction of the Project. The ET shall not be in any way an associated body of the Contractor or

the IEC for the Project. The ET shall be headed by an ET Leader. The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management.

Failure by the Permit Holder to make replacement or further failure to keep contemporaneous records in the log-book despite the employment of a new ET Leader may render this Permit liable to suspension, cancellation or variation

The Permit Holder shall inform the Director no later than 2 weeks before the scheduled submission date of the EP submission in writing in case of any subsequent change(s) to the submitted EP Submission Schedule. The EP Submission Schedule or any subsequent change(s) to the submitted Schedule shall be certified by the ET Leader and verified by the IEC before submitting to the Director under this Permit.

The schedule shall be certified by ET Leader and verified by the IEC before submission to the Director.

2.10 Submission of Detailed Design Plan for Screen/Barriers along the Site Boundary 提交沿地盤界線設置屏障/圍欄的詳細設計圖則

The Permit Holder shall, no later than one month before the commencement of construction of the Project, deposit with the Director 3 hard copies and 1 electronic copy of a Detailed Design Plan for design of opaque screen/barriers along the site abutting the ponds in YMST in the northeast of the Project site and the Ngau Tam Mei Drainage Channel (NTMDC). The Detailed Design Plan may refer to the location plan in Figure 6.1 of the Project Profile (Register No. PP-652/2023). The Detailed Design Plan shall be certified by ET Leader and verified by the IEC before submission to the Director. The details of screen / barriers specified in the Detailed Design Plan shall be fully implemented during the construction stage of the Project.

2.11 Submission of Compensatory Tree Planting Implementation Plan 提交補償植樹計劃

The Permit Holder shall, no later than one month before the commencement of the construction of the Project, deposit with the Director 3 hard copies and 1 electronic copy of Compensatory Tree Planting Implementation Plan. The Compensatory Tree Planting Implementation Plan shall include details of the planting objectives, planting numbers and locations, list of tree species to be used (with priority given to native tree species) and implementation schedule. The implementation schedule shall be in table form to clearly list out the implementation party, location and timing for the compensatory tree planting. Priority shall be given to planting of compensatory trees along the NTMDC with an aim to providing better screening effects to the NTMDC. The Compensatory Tree Planting Implementation Plan shall be certified by the ET

Leader and verified by the IEC before submission to the Director. The measures recommended in the Compensatory Tree Planting Implementation Plan shall be fully implemented.

2.12 Submission of Noise Mitigation Plan 提交噪音緩解計劃

The Permit Holder shall, no later than 6 months before the commencement of operation of the Project, submit to the Director for approval 3 hard copies and 1 electronic copy of Noise Mitigation Plan (NMP) on details of operation stage noise mitigation measures. The NMP shall review the noise mitigation measures recommended in the EIA Report (Register No. AEIAR-182/2014) based on the final housing layout. The NMP shall be certified by ET Leader and verified by the IEC before submission to the Director. The noise mitigation measures recommended in the approved NMP shall be fully implemented before the commencement of operation of the Project.

2.13 Measures to Mitigate Operation Stage Sewage Discharge 管辦階段的排污緩解措施

For disposal of sewage generated during the operation stage of the Project, the sewage shall be discharged to the public sewerage system throughout the operation stage of the project. 為處置工程項目營辦階段所產生的污水,有關污水在整個工程項目營辦階段均須排放到公共污水渠系統。

3. <u>Environmental Monitoring and Audit (EM&A) Requirements</u> 環境監察及審核(環監)規定

3.1 The Permit Holder shall, no later than 1 month before the commencement of construction of the Project, submit 3 hard copies and 1 electronic copy of an EM&A Manual to the Director for approval. The EM&A Manual shall include details of EM&A programme for the Project and also the ecological monitoring activities during the construction phase. Before submission to the Director, the EM&A Manual shall be certified by the ET Leader and verified by the IEC as conforming to the information and recommendations contained in the Project Profile (Register No. PP-652/2023). 許可證持有人須在展開工程項目的建造工程前最少 1 個月,向署長提交環監手冊的 3 份硬複本和 1 份電子複本,以供審批。環監手冊須詳列工程項目的環監計劃及施工階段進行的生態監察活動。環監手冊須經環境小組組長核證和獨立環境查核人核實,證明符合工程項目簡介(登記冊編號:PP-652/2023)所載的資料及建議,才向署長提交。

3.2 The Permit Holder shall implement the EM&A programme in accordance with the procedures and requirements in the EM&A Manual approved under Condition 3.1 of this Permit. Any changes to the EM&A requirements or programme and termination of the EM&A programme shall be justified by the ET leader and verified by the IEC as conforming to the information and requirements contained in the EM&A Manual approved under Condition 3.1 of this Permit before submission to the Director for approval.

 - (i) conducting baseline environmental monitoring; 進行環境基線監測;
 - (ii) conducting impact monitoring; 進行影響監測;
 - (iii) carrying out remedial actions described in the Event/Action Plans of the EM&A Manual in accordance with the time frame set out in the Event/Action Plans, or as agreed by the Director, in case where specified criteria in the EM&A Manual are exceeded; and 如超逾環監手冊內指定的標準,則按照環監手冊內的事故/行動計劃所訂明的時限或署長所同意的時限,執行事故/行動計劃所說明的補救行動;以及
 - (iv) logging and keeping records of the details of (i) to (iii) above for all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available the information for inspection on site.

- The Permit Holder shall submit 1 hard copy and 1 electronic copy of the Baseline Monitoring Report to the Director at least 2 weeks before the commencement of construction of the Project for record. The submission shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the submission shall be provided upon request by the Director. 許可證持有人須在展開工程項目的建造工程前最少 2 個星期,向署長提交基線監測報告的 1 份硬複本和 1 份電子複本,以作記錄。提交文件須經環境小組組長核證和獨立環境查核人核實,證明符合環監手冊所載的規定,才向署長提交。如署長要求,則須提交相關文件的額外複本。
- 3.5 The Permit Holder shall submit 1 hard copy and 1 electronic copy of monthly EM&A Reports for the construction stage of the Project to the Director, within 10 working days after the end of the reporting month. The monthly EM&A Reports shall include an executive summary of all environmental audit results, together with actions taken in the event of non-compliance (exceedances) of the environmental quality performance limits (Action and Limit Levels), complaints received and emergency events relating to violation of environmental legislation. The

submissions shall be certified by the ET Leader and verified by the IEC as having complied with the requirements as set out in the EM&A Manual before submission to the Director. Additional copies of the Monthly EM&A Reports shall be provided to the Director upon request by the Director.

- 3.6 All environmental monitoring and audit data submitted under this Permit shall be true, valid and correct.

- 3.7 To ensure a high degree of transparency regarding the monitoring data and results in view of the public concern about the Project, all environmental monitoring and audit data and results and all submissions and all performance test data and results required by this Permit shall be made available by the Permit Holder to the public through a dedicated website to be set up by the Permit Holder under Condition 4.2 below, in the shortest practicable time and in no event later than 10 working days after such information is available.

4.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 3.4 and 3.5 above. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF, JPEG or PDF format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

All environmental monitoring data described in Condition 4.1 above shall be made available to the public via the

abovementioned dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. All finalized submissions and plans shall be made available to the public via the dedicated Internet website in the shortest possible time and in any event no later than 2 weeks after the submissions and plans are approved by or deposited with the Director, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the entire construction period and during the first 3-year period of operation of the Project, or otherwise as agreed by the Director.


