
Pursuant to Section 12(3) of the EIA Ordinance, I now issue the attached further environmental permit (No. FEP-02/097/2001/B) for your use.

PART A (MAIN PERMIT)

A 部 (許可證主要部分)

Pursuant to Sections 10 and 12 of the Environmental Impact Assessment Ordinance (EIAO), the Director of Environmental Protection (the Director) granted this Further Environmental Permit (hereinafter referred to as this “Permit”) to the **Leisure and Cultural Services Department** (hereinafter referred to as the “Permit Holder”) to operate the designated project described in **Part B** of this Permit subject to the conditions specified in **Part C** of this Permit. The issue of this Permit is based on the documents, approval and permissions described below:



PART B (DESCRIPTION OF PART OF DESIGNATED PROJECT)

Hereunder is the description of the designated project mentioned in Part A of this environmental permit (hereinafter referred to as the “Permit”):

PART C (PERMIT CONDITIONS)

C 部 (許可證條件)

1. General Conditions

一般條件

- 1.1 The Permit Holder shall ensure full compliance with all conditions of this environmental permit. Any non-compliance may constitute a contravention of the EIAO and may become subject of appropriate action to be taken under the Ordinance.

許可證持有人必須確保完全符合本環境許可證的全部條件。如有不符合本許可證的情況，可能構成違反《環境影響評估條例》的規定，而當局可根據條例採取適當行動。

- 1.2 The Permit Holder shall ensure, from time to time, full compliance with all legislation in force including but without limitation to the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358) and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defense against any proceedings instituted under any legislation.

許可證持有人須經常確保完全符合現行法例的規定，包括(但不限於)噪音管制條例(第 400 章);空氣污染管制條例(第 311 章);水污染管制條例(第 358 章);及廢物處置條例(第 354 章)。本許可證本身不會就根據任何法例提起的法律程序構成任何抗辯理由。

- 1.3 The Permit Holder shall make copies of this Permit together with all documents referred to in this Permit or the documents referred to in [Part A](#) of this Permit readily available at all times for inspection by the Director at the Permit Holder's office. Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

- 1.4 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the operation of the Project and ensure that such person(s) fully understands all conditions and all requirements incorporated by the Permit.

許可證持有人須將本許可證的一份複本交予負責營辦本工程項目的人士，並確保這些人士完全明白本許可證的所有條件與規定。



1.5 The Permit Holder shall operate the part of the Project described in Part B of this Permit.

許可證持有人須依據本許可證 B 部 的說明，營辦工程項目部份。

1.6 The Permit Holder shall ensure that the Project is operated in accordance with the information and recommendations described in the approved EIA Report (Register No. AEIAR-032/2000), the application documents for environmental permits, other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded or amended in this Permit.

許可證持有人須確保工程項目按照下述資料營辦：環評報告（登記冊編號：AEIAR-032/2000）所說明的資料及各項建議；環境許可證的申請文件；登記冊內的其他相關文件；本許可證所說明的資料或緩解措施；根據本許可證內載的條件須向署長存放或獲署長批准的提交文件所建議的緩解措施；以及在工程項目各階段進行的持續監察及監測工作所建議的緩解措施。登記冊文件所述建議如沒有在本許可證明確表示，則仍須實施這些建議，除非獲本許可證明確豁除或修訂。

2. Specific Conditions

特別條件

2.1 The Permit Holder shall manage and maintain the roadside planting areas as shown in Figures R1 to R12 of this Permit, in accordance with the detailed landscape plan deposited with the Director under Condition 2.7 of the environmental permit (Permit No.: EP-097/2001/B).

1. This Permit consists of three parts, namely, PART A (Main Permit), PART B (Description of Designated Project) and PART C (Permit Conditions). Any person relying on this Permit should obtain independent legal advice on the legal implications under the Ordinance, and that the following notes are for general information only.



本許可證共有 3 部，即：A 部（許可證主要部分）；B 部（指定工程項目的說明）；及 C 部（許可證條件）。任何援引本許可證的人士須就條例的法律含意徵詢獨立法律意見，下述註解只供一般參考用。

2. If there is a breach of any conditions of this Permit, the Director or his authorized officer may, with the consent of the Secretary for the Environment, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

如違反本許可證的任何條件，署長或獲授權人員徵得環境局局長的同意後可勒令停止相關工程，直至許可證持有人為所造成的環境損害採取補救行動為止。在此情況下，許可證持有人未經署長或獲授權人員同意，不得進行任何相關工程。

3. The Permit Holder may apply under Section 13 of the Ordinance to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original Permit by the amended Permit.

許可證持有人可根據條例第 13 條的規定向署長申請更改本許可證的條件。許可證持有人須將經修改的許可證，替換原有許可證。

4. A person who assumes the responsibility for the whole or a part of the designated project may, before he assumes responsibility of the designated project, apply under Section 12 of the Ordinance to the Director for a further environmental permit.

承擔指定工程項目的整項或部分工程的責任的人，在承擔指定工程項目責任之前，可根據條例第 12 條的規定向署長申請新的環境許可證。

5. Under Section 14 of the Ordinance, the Director may, with the consent of the Secretary for the Environment, suspend, vary or cancel this Permit.

根據條例第 14 條的規定，署長可在環境局局長的同意下暫時吊銷、更改或取消本許可證。

6. If this Permit is cancelled or surrendered during the operation or decommission of the Project, another environmental permit must be obtained under the EIAO before the operation of the Project could be continued. It is an offence under Section 26(1) of the EIAO to operate or decommission a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

任何人在沒有有效環境許可證的情況下營辦或解除運作環評條例附表2第I部所列明的指定工程項目，即屬犯罪。

7. Any person who operates the Project contrary to the conditions in the Permit, and is convicted of an offence under the Ordinance, is liable –

如任何人在違反本許可證的條件下營辦工程項目，根據環評條例，即屬犯罪 –

- (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;
一經循公訴程序首次定罪，可處罰款 200 萬元及監禁 6 個月；
- (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
一經循公訴程序第二次或其後每次定罪，可處罰款 500 萬元及監禁 2 年；
- (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
一經循簡易程序首次定罪，可處第 6 級罰款及監禁 6 個月；
- (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
一經循簡易程序第二次或其後每次定罪，可處罰款 100 萬元及監禁 1 年；及
- (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.
在任何情況下如該罪行屬持續性質，則法院或裁判官可就其信納該罪行持續的每天另處罰款 10,000 元。

8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the Ordinance within 30 days of receipt of this Permit.

許可證持有人可在接獲本許可證後 30 天內，根據條例第 17 條就本許可證的任何條件提出上訴。

9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.

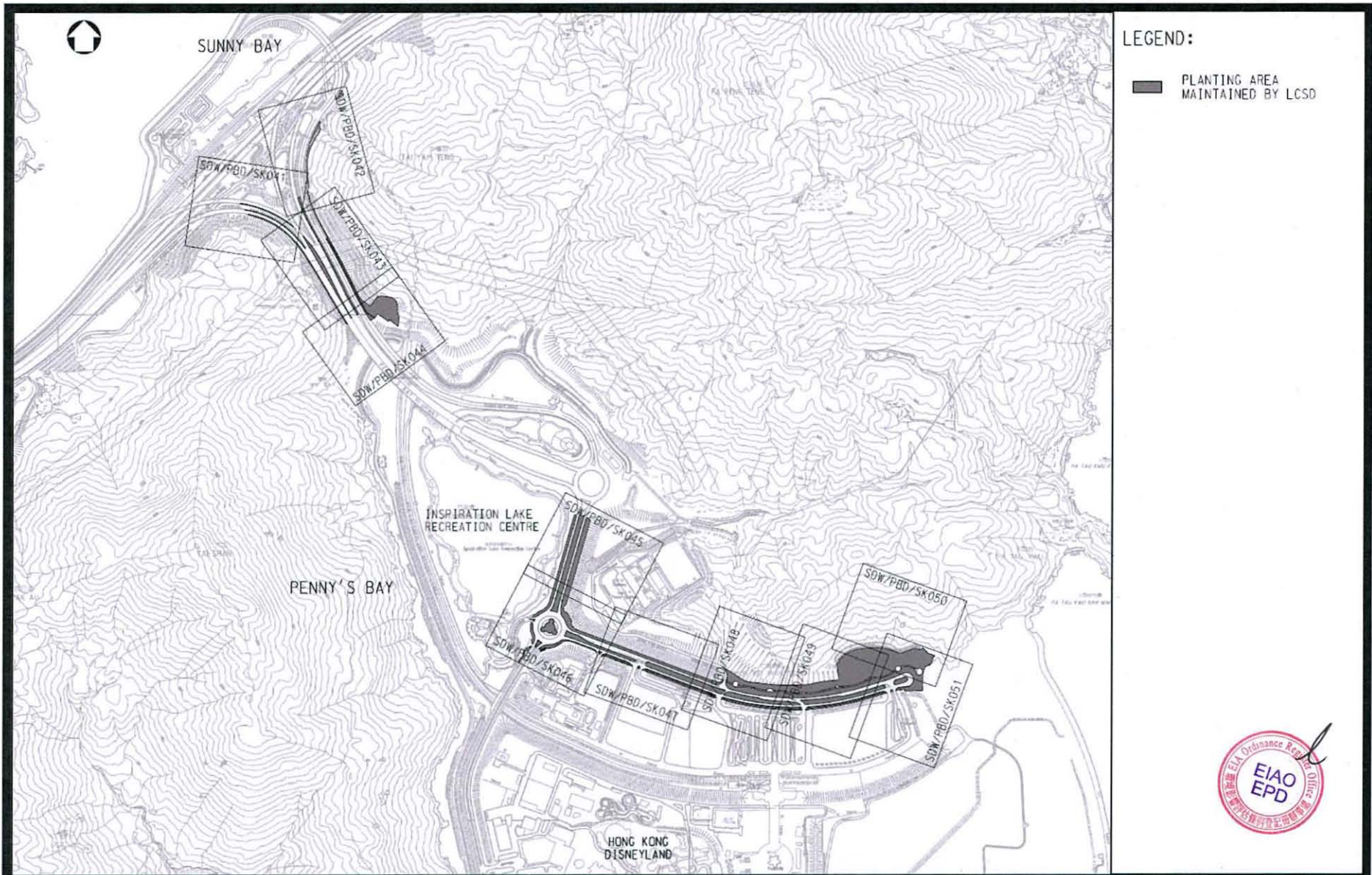


Figure R1: Chok Ko Wan Link Road (Part)

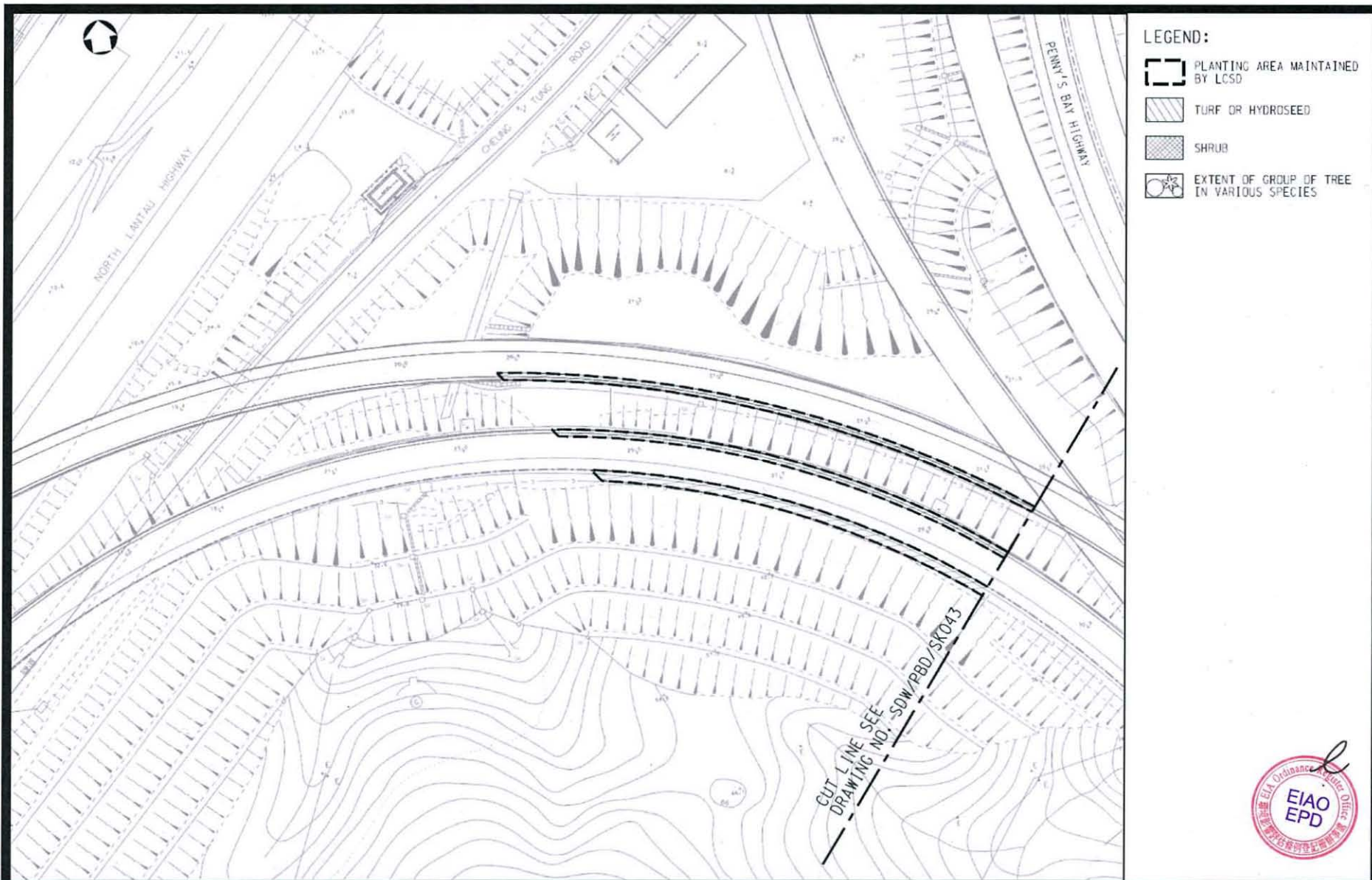


Figure R2: Chok Ko Wan Link Road (Part)

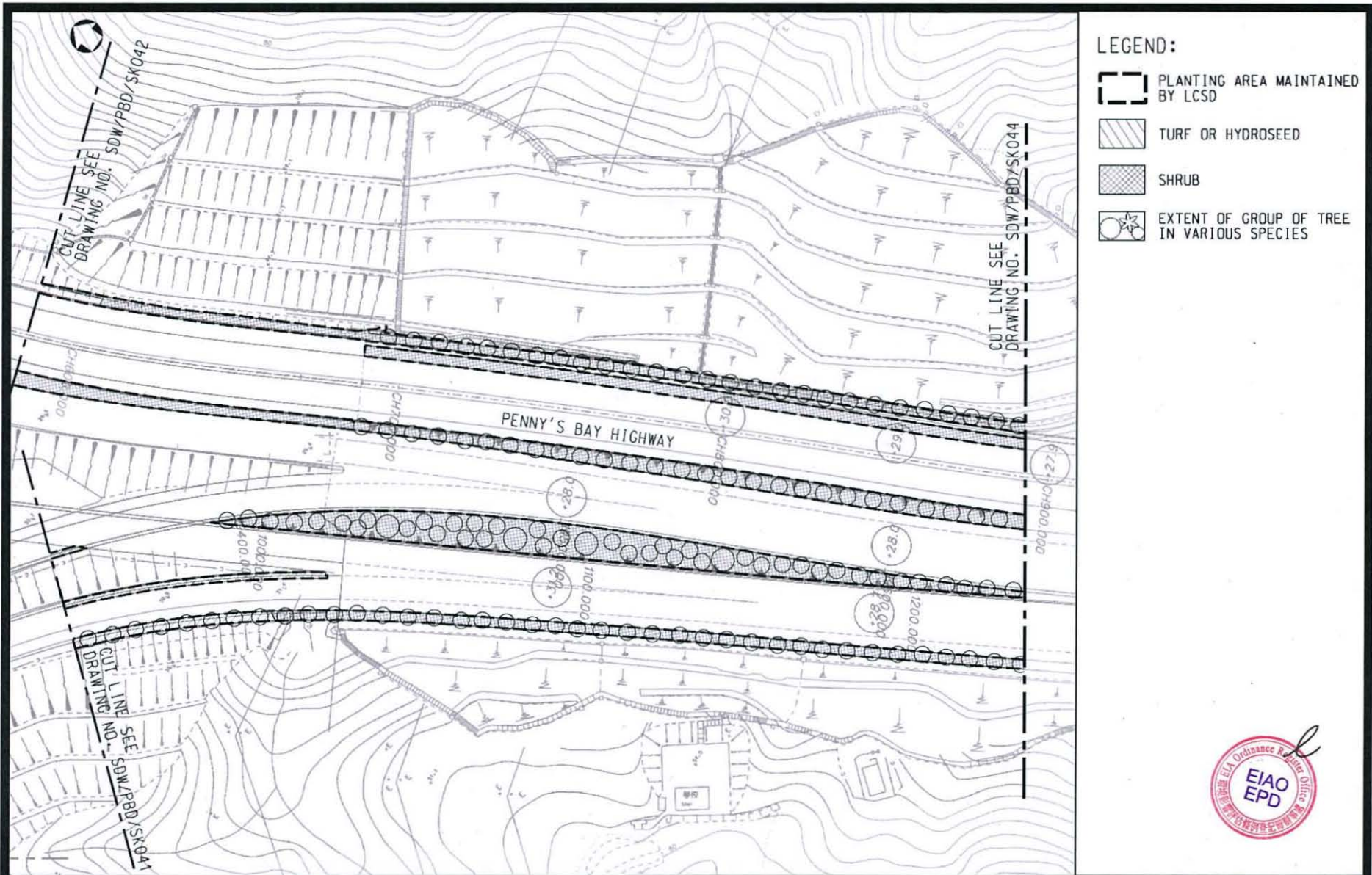


Figure R4: Chok Ko Wan Link Road (Part)

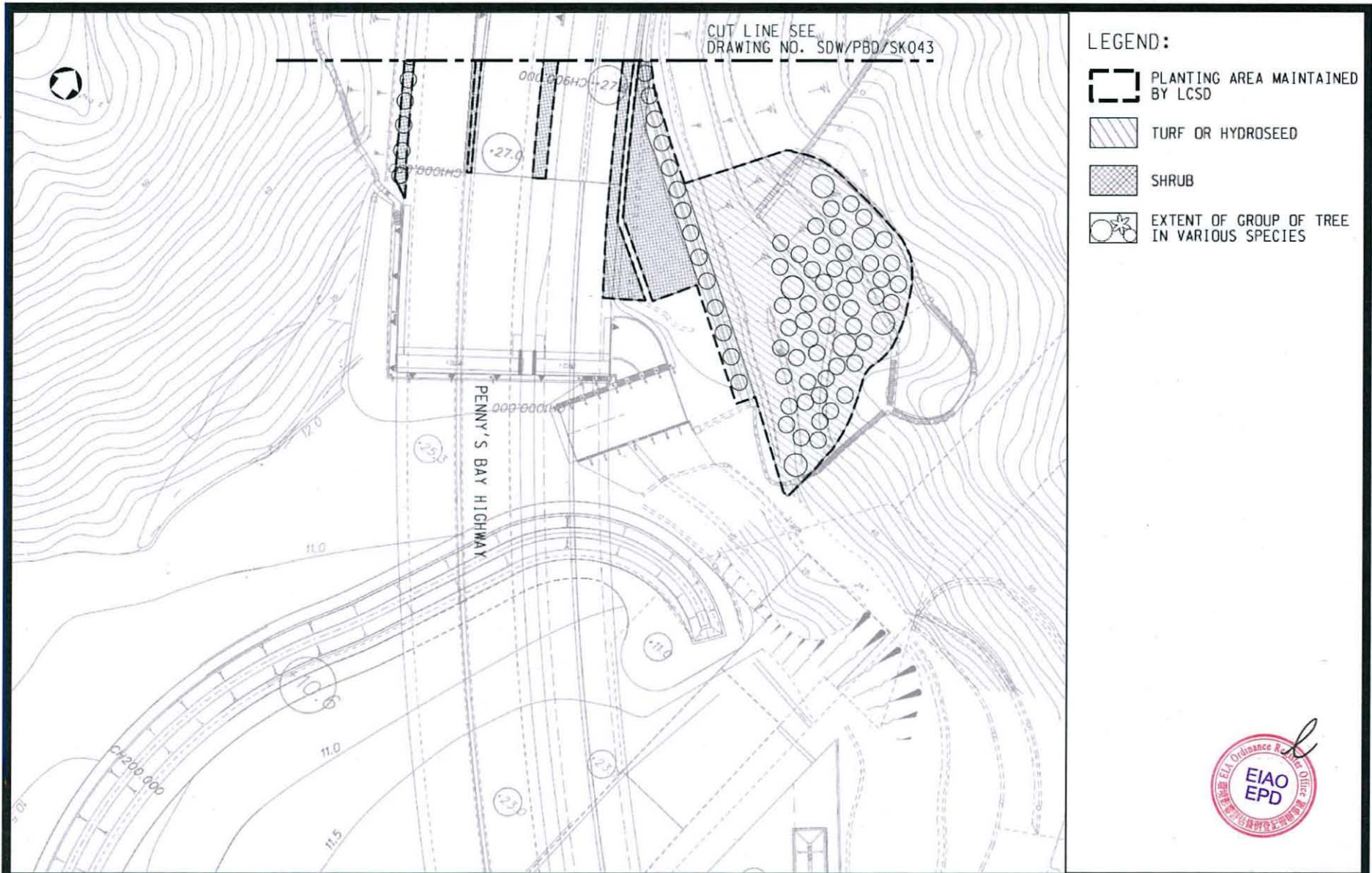


Figure R5: Chok Ko Wan Link Road (Part)

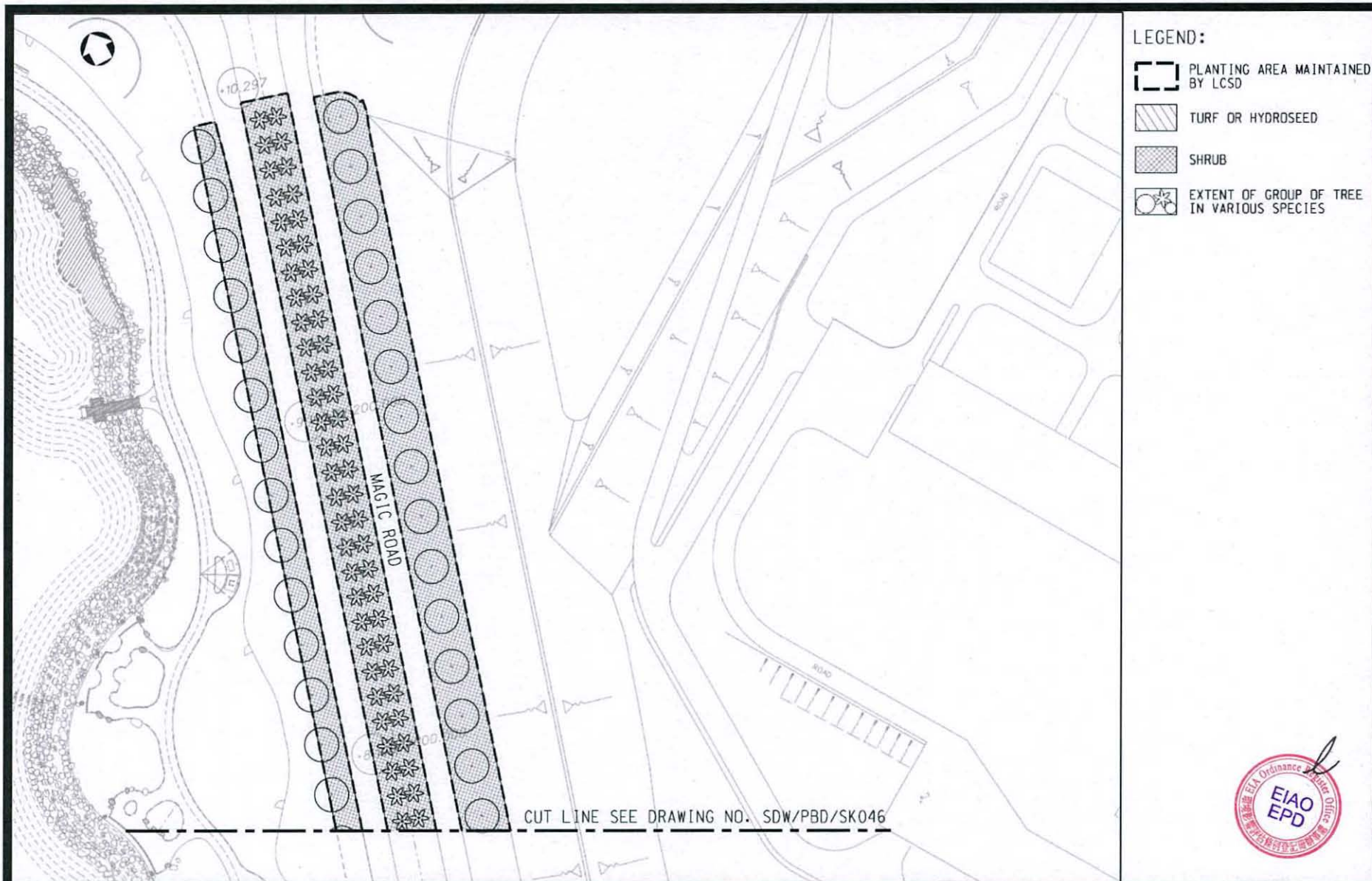


Figure R6: Chok Ko Wan Link Road (Part)

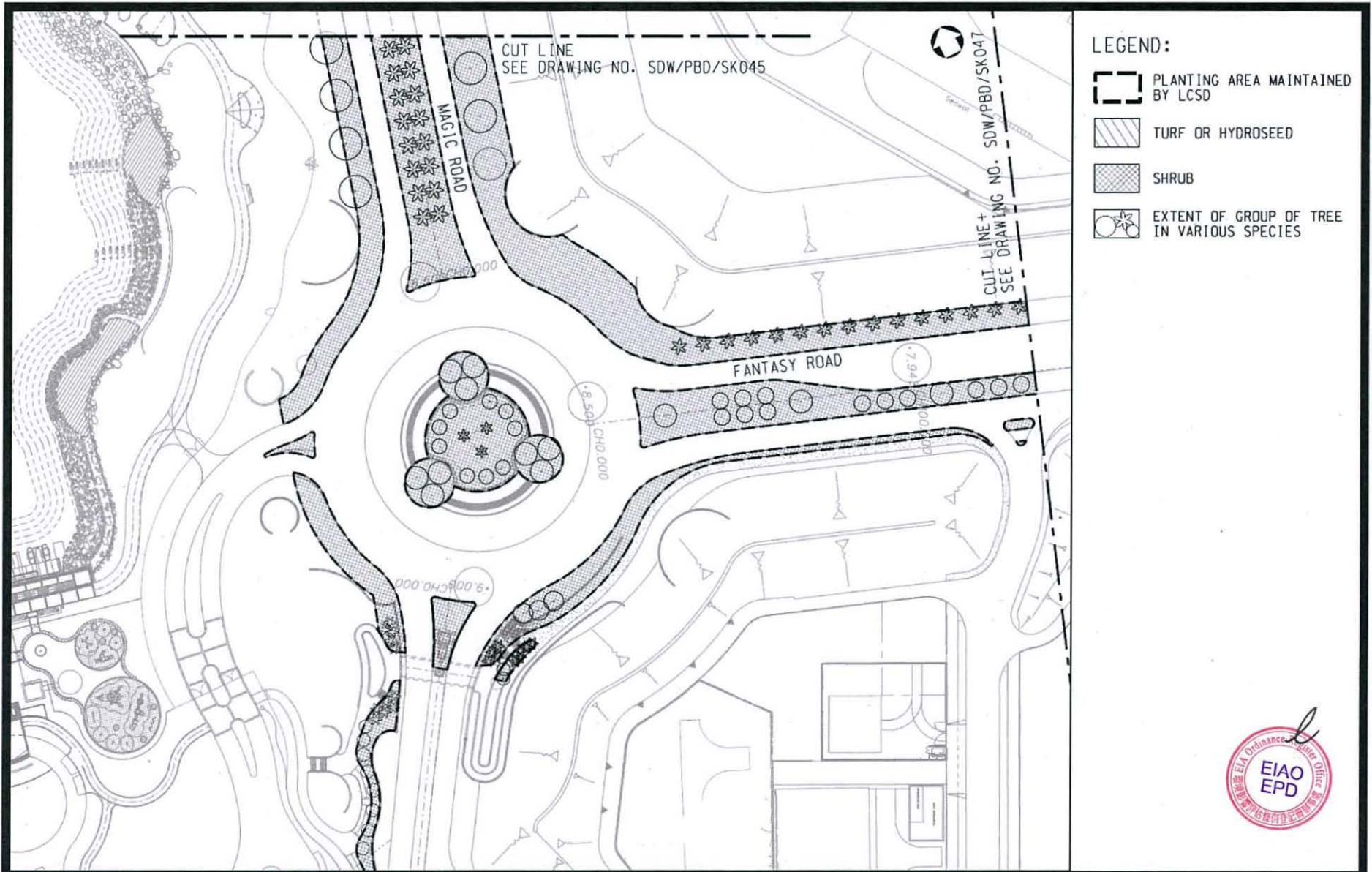


Figure R7: Chok Ko Wan Link Road (Part)

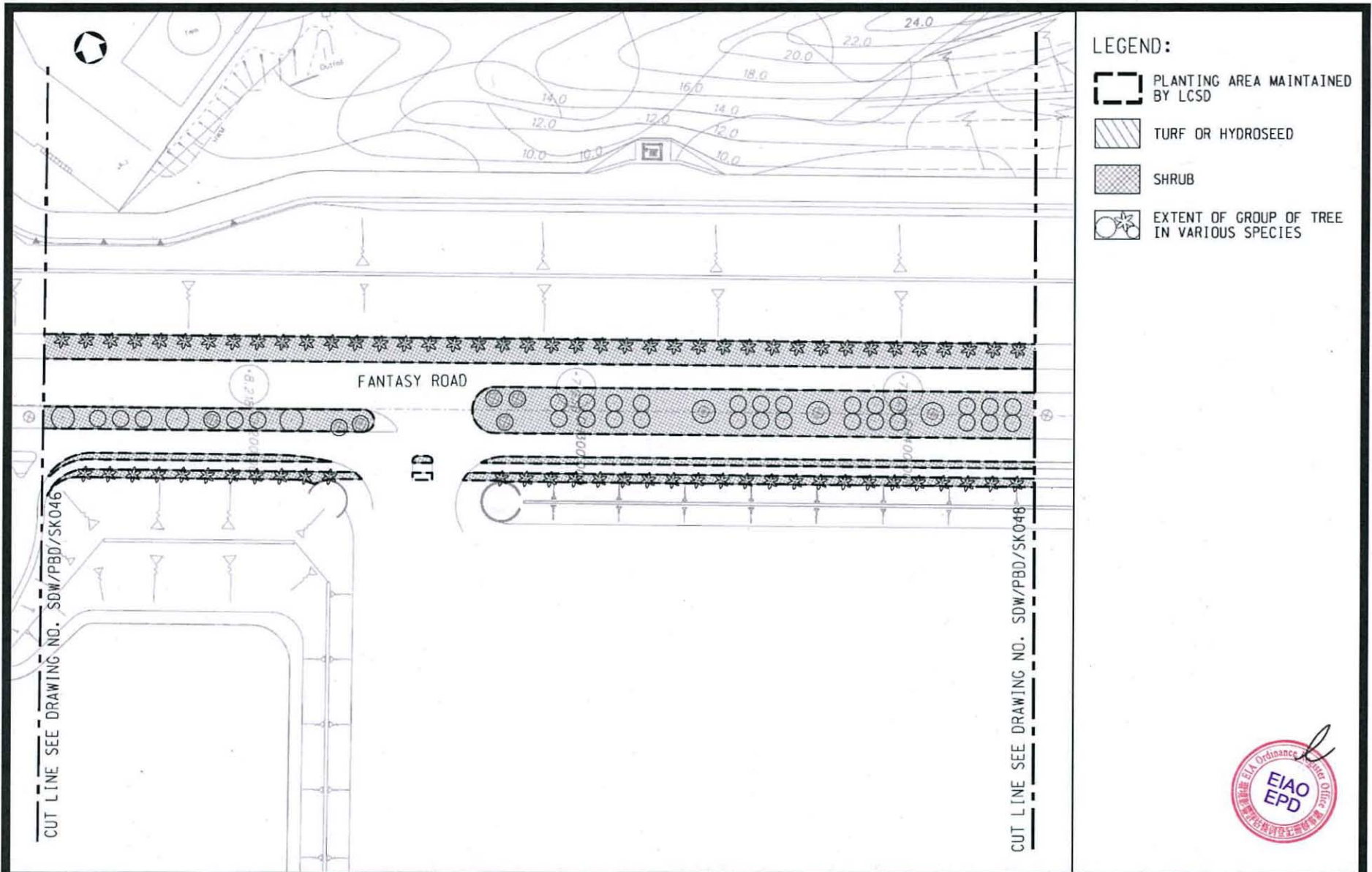


Figure R8: Chok Ko Wan Link Road (Part)

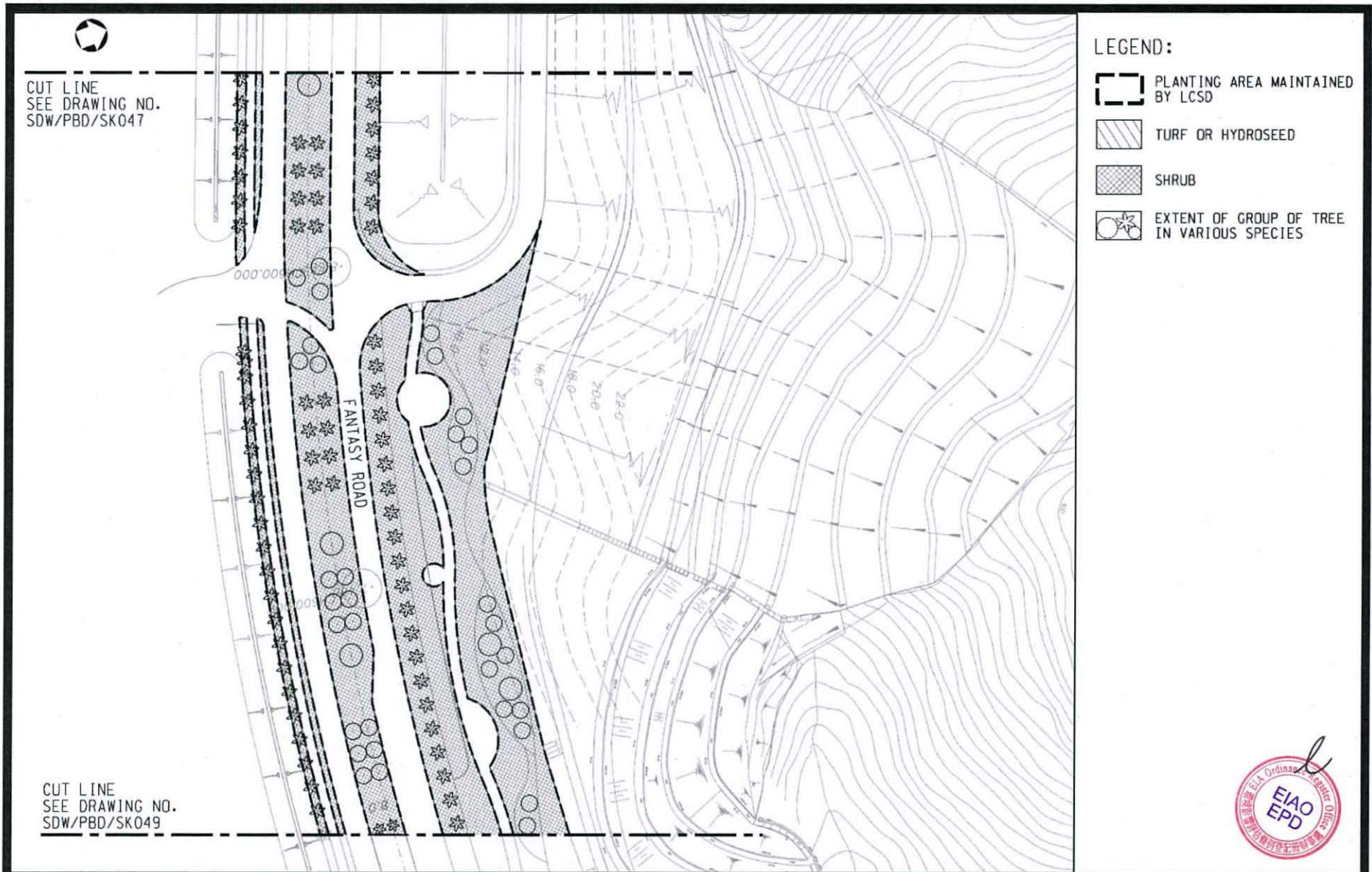


Figure R9: Chok Ko Wan Link Road (Part)

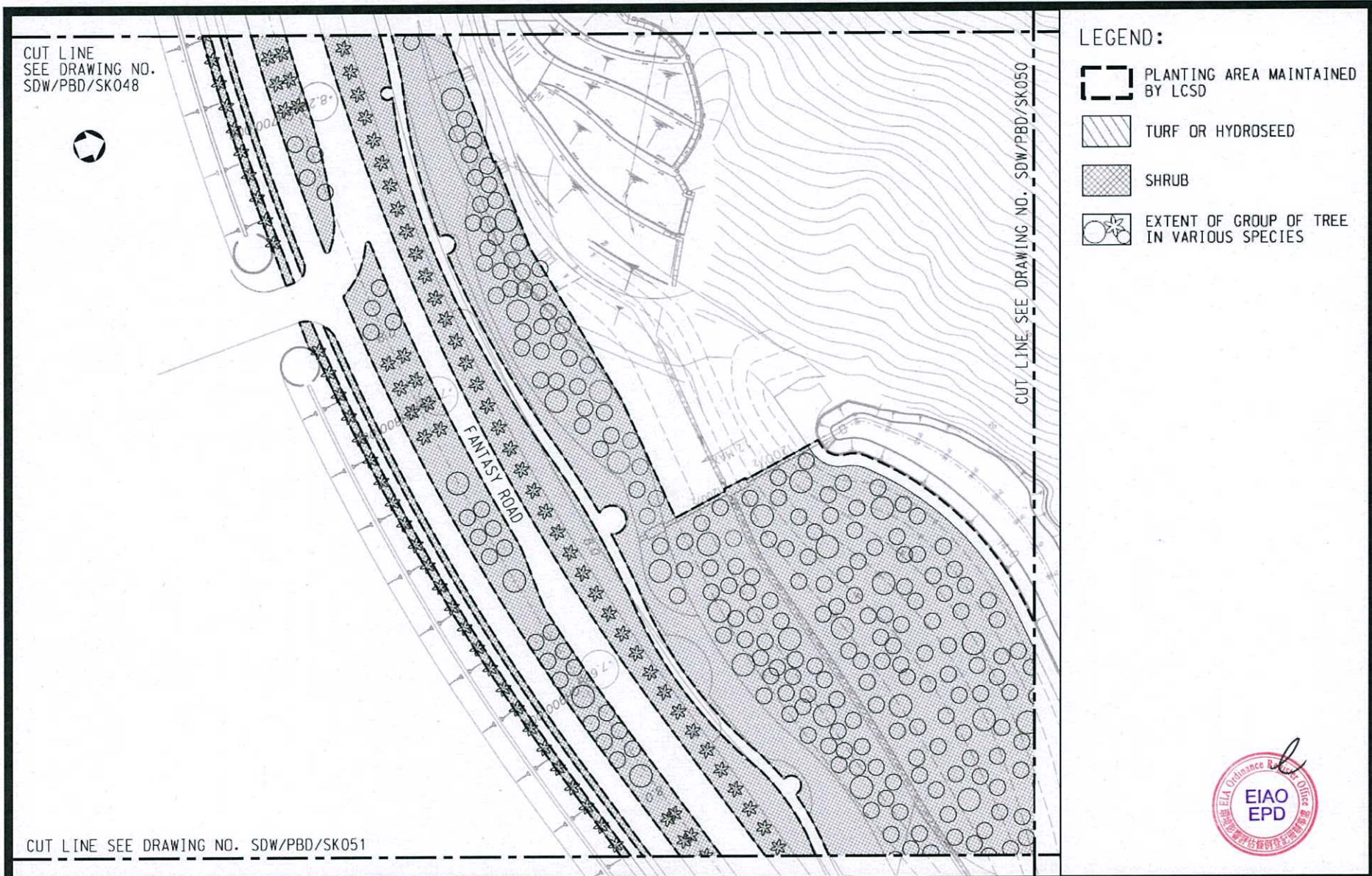


Figure R10: Chok Ko Wan Link Road (Part)

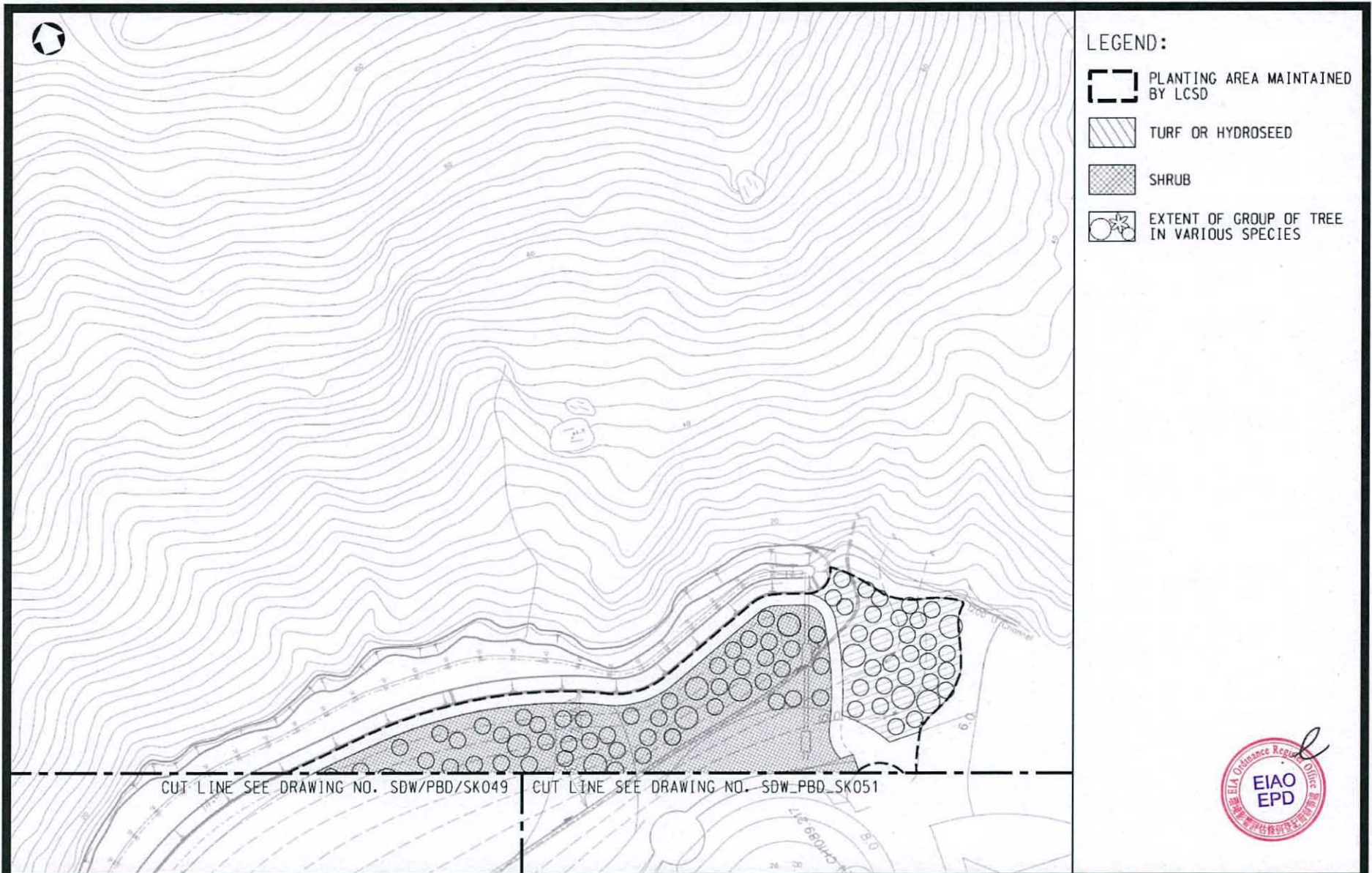


Figure R11: Chok Ko Wan Link Road (Part)

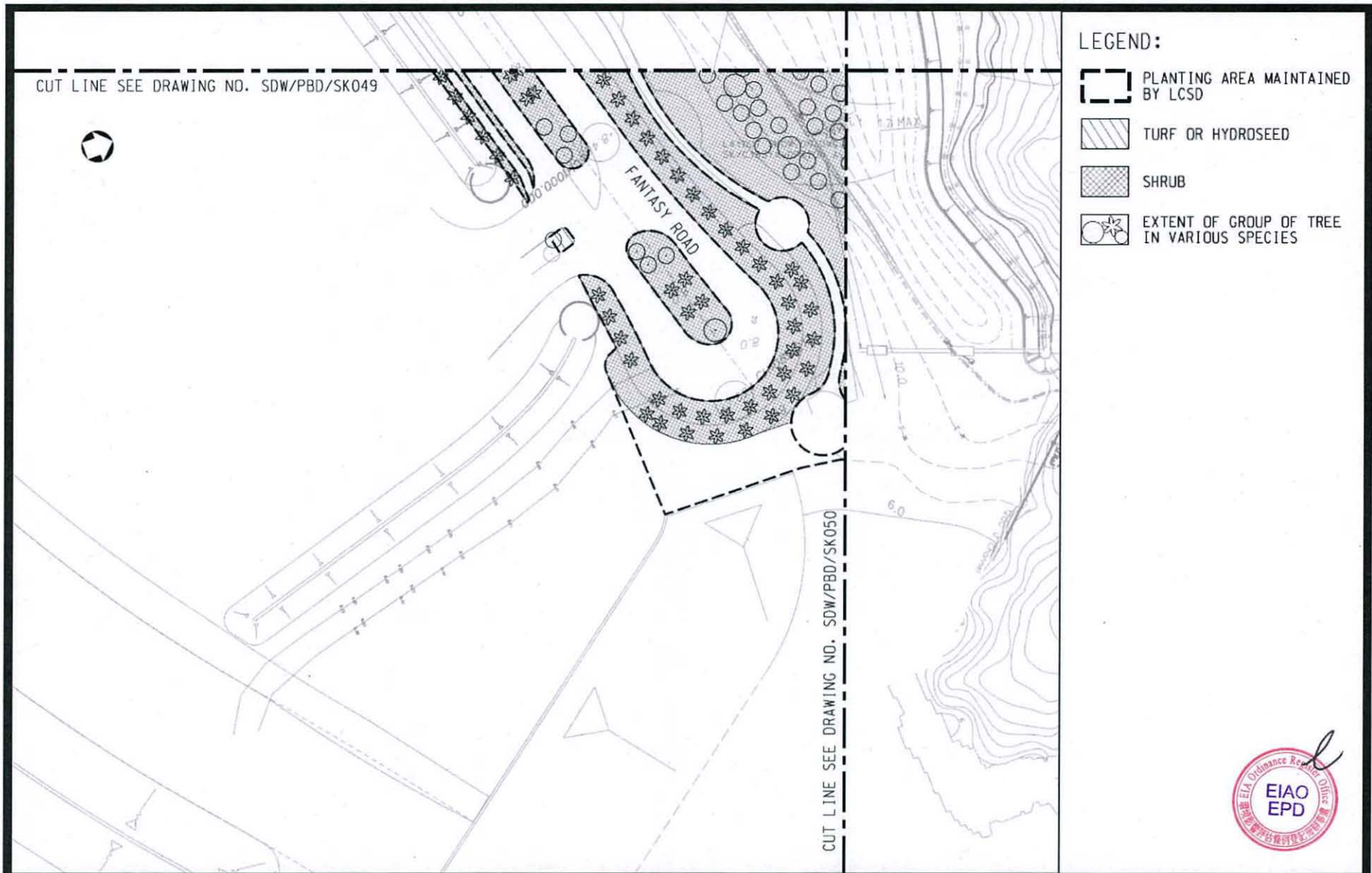


Figure R12: Chok Ko Wan Link Road (Part)
