Pursuant to Sections 10 and 12 of the Environmental Impact Assessment Ordinance (the Ordinance), the Director of Environmental Protection (the Director) grants this further environmental permit to the <u>Civil Engineering and Development Department</u> (hereinafter referred to as the "Permit Holder") to operate the designated project described in <u>Part B</u> of this permit subject to the conditions specified in <u>Part C</u>. PART C (PERMIT CONDITIONS)

C部 (許可證條件)

1. General Conditions

一般條件

1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the Ordinance.

許可證持有人及任何從事工程項目的人士必須符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反環境影響評估條例(「環評條例」)(第499章)的規定,而當局可根據條例採取適當行動。

1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Noise Control Ordinance (Cap. 400), Air Pollution Control Ordinance (Cap. 311), Water Pollution Control Ordinance (Cap. 358), Dumping at Sea Ordinance (Cap. 466) and Waste Disposal Ordinance (Cap. 354). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

許可證持有人須經常確保完全符合現行法例的規定,包括但不限於噪音管制條例 (第 400 章); 空氣污染管制條例 (第 311 章);水污染管制條例 (第 358 章);海上傾倒物料條例 (第 466 章); 以及廢物處置條例 (第 354 章)。本許可證本身不會就根據任何法例提起的法律程序構成任何抗 辯理由,或根據任何法例默示任何批准。

- 1.3 The Permit Holder shall give a copy of this Permit to the person(s) in charge of the site and ensure that such person(s) fully understands all conditions and all requirements incorporated by the Permit. The site(s) refers to site(s) of operation of the Project and shall mean the same hereafter. 許可證持有人須把本許可證的複本交予有關工地的負責人,並確保這些人士完全明白本許可證的所有條件與規定。工地是指營辦工程項目的工地,下文所提及的工地亦屬同一意思。
- 1.4 The Permit Holder shall operate the Project in accordance with the project descriptions in Part B of this Permit.

1.5 The Permit Holder shall ensure that the Project is operated in accordance with the information and recommendations described in the EIA Report (Register No. EIA-089/BC), other relevant documents in the EIAO Register Office, the information and mitigation measures described in this Permit, and mitigation measures to be recommended under on-going surveillance and monitoring activities during the operation of the Project.

2. Measures during the Operation Period

- 2.1 All design and operational measures described in the submissions approved or deposited under the Environmental Permit No. VEP-005/1999/A/EP-012 shall be properly maintained. 按環境許可證編號 VEP-005/1999/A/EP-012 獲得批准或存放的文件內所說明的所有設計或運作措施,必須妥善保養。
- 2.3 The Permit Holder shall ensure the measures to mitigate odour impact associated with the operational maintenance dredging of the drainage channels are implemented. The measures shall include: 許可證持有人須確保因排水道運作維修挖泥而產生的難聞氣味,有採取緩解措施以減輕影響。措施包括:
 - (a) any odorous permitted stockpiled material should be placed 100m away from air sensitive receivers; and 任何帶有難聞氣味的容許堆存物料,必須放置於易受空氣污染影響受體的 100 米以外地方;及
 - (b) any odorous permitted stockpiled material shall be covered with plastic tarpaulin sheets if left in excess of 2 days.

 任何帶有難聞氣味的堆存物料,如存超過 2 天,須用膠帆布覆蓋。
- 2.4 The dredged materials arising from the maintenance dredging shall be disposed of at the WENT, NENT and SENT Landfill or other location(s) as agreed with the Director. 所有由維修挖泥而產生的淤泥須棄置於新界西堆填區,新界東北堆填區,新界東南堆填區或其他經署長同意的地方。
- 2.5 The Permit Holder shall submit to the Director for approval within a month of the operation of the Project a proposal to monitor the avifauna use of the constructed channel and implement the approved monitoring proposal.

1. This Permit consists of three parts, namely, <u>Part A</u> (Main Permit), <u>Part B</u> (Description of Designated Project) and <u>Part C</u> (Permit Conditions). Any person relying on this permit should obtain independent legal advice on the legal implications under the Ordinance, and the following notes are for general information only.

2. If there is a breach of any conditions of this Permit, the Director or his authorized officer may, with the consent of the Secretary for the Environment, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer.

3. The Permit Holder may apply under Section 13 of the Ordinance to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit.

許可證持有人可根據環評條例第13條的規定,向署長申請更改本許可證的條件。許可證持有人 須以經修訂的許可證替換在工程項目的工地內展示的原有許可證。

4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the Ordinance to the Director for a further environmental permit.

 Under Section 14 of the Ordinance, the Director may with the consent of the Secretary for the Environment suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site.

根據環評條例第 14 條的規定,署長可在環境局局長的同意下暫時吊銷、更改或取消本許可證。 遭暫時吊銷、更改或取消的環境許可證必須從工程項目的工地除下,不再展示。

6. If this Permit is cancelled or surrendered during operation of the Project, another environmental permit must be obtained under the Ordinance before the Project could be continued. It is an offence under Section 26 (1) of the Ordinance to construct or operate a designated project listed in Part I of Schedule 2 of the Ordinance without a valid environmental permit.

如本許可證在工程項目營辦期間被取消或交回,則必須在繼續營辦工程項目之前,根據環評條例規定取得另一份環境許可證。根據環評條例第 26 (1) 條的規定,任何人在沒有有效環境許可證的情況下建造或營辦環評條例附表 2 第 I 部所列明的指定工程項目,即屬犯罪。

7. Any person who operates the Project contrary to the conditions in the Permit, and is convicted of an offence under the Ordinance, is liable:

如任何人在違反本許可證的條件下營辦工程項目,根據環評條例,即屬犯罪:

- (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months; —經循公訴程序首次定罪,可處罰款 200 萬元及監禁 6 個月;
- (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 - 一經循公訴程序第二次或其後每次定罪,可處罰款500萬元及監禁2年;
- (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;

 —經循簡易程序首次定罪,可處第 6 級罰款及監禁 6 個月;
- (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
 - 一經循簡易程序第二次或其後每次定罪,可處罰款 100 萬元及監禁 1 年;及
- (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.


