1 General Conditions

1.1 The Permit Holder and any person working on the Project shall comply with all conditions set out in this Permit. Any non-compliance by any person may constitute a contravention of the Environmental Impact Assessment Ordinance (EIAO) (Cap. 499) and may become the subject of appropriate action being taken under the EIAO.

許可證持有人及任何從事工程項目的人士必須完全符合本許可證載列的全部條件。任何人士如有不符合本許可證的情況,可能違反《環境影響評估條例》 (環評條例)(第 499 章)的規定,而當局可根據環評條例採取適當行動。

1.2 The Permit Holder shall ensure full compliance with all legislation from time to time in force including, without limitation to, the Air Pollution Control Ordinance (Cap. 311), Waste Disposal Ordinance (Cap. 354), Water Pollution Control Ordinance (Cap. 358), Noise Control Ordinance (Cap. 400) and Dumping at Sea Ordinance (Cap. 466). This Permit does not of itself constitute any ground of defence against any proceedings instituted under any legislation or imply any approval under any legislation.

Any reference to the Permit shall include all documents referred to in the Permit and also the relevant documents in the Register.

The Permit Holder shall ensure that the most updated information about the Permit, including any amended Permit, is displayed at such locations. If the Permit Holder surrenders a part or the whole of the Permit, the notice he sends to the Director shall also be displayed at the same locations as the original Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site(s).

1.7 The Permit Holder shall ensure that the Project is designed, constructed and operated in accordance with the information and all recommendations described in the approved EIA Report (Register No. AEIAR-175/2013) as described in Part A of this Permit; the Director's letter of approval of the EIA Report dated 18 October 2013 referenced (45) in EP2/N7/S3/57 Pt.3; the Application for Environmental Permit (Application No. AEP-466/2013) and all attached documents submitted by the Permit Holder and other relevant documents in the Register, the information and mitigation measures described in this Permit, mitigation measures to be recommended in submissions that shall be deposited with or approved by the Director as a result of permit conditions contained in this Permit, and mitigation measures to be recommended under ongoing surveillance and monitoring activities during all stages of the Project. Where recommendations referred to in the documents of the Register are not expressly referred to in this Permit, such recommendations are nevertheless to be implemented unless expressly excluded in this Permit.

1.8 All deposited submissions, as required under this Permit, shall be rectified and resubmitted in accordance with the comments, if any, made by the Director within one month of the receipt of the Director's comments or otherwise as specified by the Director.

Any variation of the submissions shall be approved by the Director in writing or as prescribed in the relevant permit conditions. Any non-compliance with the submissions may constitute a contravention of the Environmental Impact Assessment Ordinance (Cap. 499). All submissions or any variation of the submissions shall be certified by the Environmental Team (ET) Leader and verified by the Independent Environmental Checker (IEC) referred to in Conditions 2.1 and 2.2 below, before submitting to the Director under the Permit.

For this purpose, the Permit Holder shall provide sufficient copies of the submissions.

Electronic copies of all finalized submissions required under this Permit shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and/or in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies.

Employment of Environmental Monitoring and Audit (EM&A) Personnel 聘用環境監察及審核(環監)人員

An Environmental Team (ET) shall be established by the Permit Holder no later than 6 weeks before the commencement of construction of the Project. shall not be in any way an associated body of the Contractor or the Independent Environmental Checker (IEC) for the Project. The ET shall be headed by an ET The ET Leader shall be a person who has at least 7 years of experience in environmental monitoring and auditing (EM&A) or environmental management. The ET and the ET Leader shall be responsible for the implementation of the EM&A programme in accordance with the EM&A requirements as contained in the updated EM&A Manual submitted and approved under Condition 2.3 of this Permit. The ET Leader shall keep a contemporaneous log-book of each and every instance or circumstance or change of circumstances, which may affect the compliance with the recommendations of the EIA Report (Register No.: AEIAR-175/2013) and this The ET Leader shall notify the IEC within one working day of the occurrence of any such instance or circumstance or change of circumstances. The ET Leader's log-book shall be kept readily available for inspection by all persons assisting in supervision of the implementation of the recommendations of the EIA Report (Register No.: AEIAR-175/2013) and this Permit or by the Director or his authorized officers. Failure to maintain records in the log-book, failure to discharge the duties of the ET Leader as defined in the updated EM&A Manual or failure to comply with this Condition would entitle the Director to require the Permit Holder by notice in writing to replace the ET Leader. Failure by the Permit Holder to make replacement, or further failure to keep contemporaneous records in the

log-book despite the employment of a new ET Leader may render the Permit liable to suspension, cancellation or variation.

An IEC shall be employed by the Permit Holder no later than 6 weeks before the 2.2 commencement of construction of the Project. The IEC shall not be in any way an associated body of the Contractor or the ET for the Project. The IEC shall be a person who has at least 7 years of experience in EM&A or environmental management. The IEC shall be responsible for duties defined in the updated EM&A Manual submitted and approved under Condition 2.3 of this Permit, and shall audit the overall EM&A performance, including the implementation of all environmental mitigation measures, submissions required in the updated EM&A Manual, and any other submissions required under this Permit. In addition, the IEC shall be responsible for verifying the environmental acceptability of permanent and temporary works, relevant design plans and submissions under this The IEC shall verify the log-book(s) mentioned in Condition 2.1 of this The IEC shall notify the Director, within one working day of receipt of notification from the ET Leader of each and every change of circumstances or non-compliance with the recommendations of the EIA Report (Register No.: AEIAR-175/2013) and this Permit, which might affect the monitoring or control of adverse environmental impacts from the Project. In case the IEC fails to so notify the Director of the same, fails to discharge the duties of the IEC as defined in the updated EM&A Manual or fails to comply with this Condition, the Director may require the Permit Holder by notice in writing to replace the IEC. Failure to replace the IEC as directed or further failure to so notify the Director despite employment of a new IEC may render the Permit liable to suspension, cancellation or variation. Notification by the Permit Holder is the same as notification by the IEC for the purpose of this Condition.

The Permit Holder shall, at least 4 weeks before the commencement of construction of the Project, deposit with the Director four hard copies and four electronic copies of the updated EM&A Manual. Before submission to the Director, the updated EM&A Manual shall be certified by the ET Leader and verified by the IEC as conforming to the information and recommendations described in the EIA Report (Register No. AEIAR-175/2013), and taking into account any specific requirements with respect to the latest site conditions of the Project. All measures recommended in the updated EM&A Manual approved under this Condition shall be fully and properly implemented in accordance with the requirements and time schedule(s) set out in the updated EM&A Manual. The EM&A Manual deposited under this Condition shall hereinafter be referred to as the "updated EM&A Manual".

The plans shall include the details the works boundaries, works areas, vertical and horizontal alignments of the roads and any other major facilities; and the locations of key environmental mitigation measures.

Measures to mitigate Cultural Heritage Impact

2.6 A baseline condition survey and baseline vibration impact assessment shall be conducted by a qualified building surveyor or a qualified structural engineer prior to the commencement of construction of the Project to: (1) define the vibration limit of identified built heritage features at G202 and HKT03 shown in Figures 2a and 2b; (2) determine whether construction vibration monitoring and/or structural strengthening measures are required during construction phase; and (3) maintain a record of the condition survey of graded historic buildings that may be affected by the Project. The baseline condition survey and baseline vibration impact assessment shall be included in and form part of the Baseline Monitoring Report to be submitted under Condition 3.3 of this Permit.

2.7 Photographic and cartographic records of the directly impacted historical buildings at HKT08 and the entrance gate of HKT03 shown in Figures 3a and 3b shall be kept by the Permit Holder and a copy of the records shall be deposited with the Director prior to the commencement of the respective removal or relocation works.

Proposals on relocation of built heritages, if any, shall be submitted for approval by the Director prior to commencement of the respective relocation works.

Submission of Landscape Plan

2.8 The Permit Holder shall, at least 6 weeks before the commencement of the corresponding parts of landscape and visual mitigation measures of the Project, deposit with the Director three hard copies and one electronic copy of landscape plan(s). The landscape plan(s) shall show the design details, confirmation of the feasibility for proposed planting, locations, implementation programme, maintenance and management schedules, and drawings in the scale of 1:1,000 or other appropriate scale, as agreed with the Director, of the landscape and visual mitigation measures of the Project. Before submission to the Director, the landscape plan(s) shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations, including those described in the EIA Report (Register No. AEIAR-175/2013). All landscape and visual mitigation measures shall be properly implemented and maintained for the Project in accordance with the deposited landscape plan. The Permit Holder shall make available additional copies to the Director upon request.

許可證持有人須在工程項目的景觀及視覺影響緩解措施的相關部分展開前,至少提早6個星期向署長存放景觀美化計劃的3份硬複本及1份電子版本。景觀美化計劃須展示工程項目景觀及視覺影響緩解措施的設計詳情、確認擬議種植的可行性、位置、實施計劃、保養及管理時間表,以及採用1:1,000的比例或署長同意的其他合適比例繪畫的圖則。景觀美化計劃須由環境小組組長核證及獨立環境查核人核實,證明符合相關資料及建議,包括環評報告(登記冊編號:AEIAR-175/2013)所載的資料及建議,然後才提交署長。工程項目的所有景觀及視覺緩解措施須根據存放的景觀美化計劃妥善執行及維持。如署長要求,許可證持有人須提供額外的複本。

2.9 To minimise adverse impacts on habitats of ecological importance in the vicinity of the Project, 2m high solid dull green site barrier fences shall be erected around all active works areas, unless otherwise agreed with the Director.

Measures to mitigate Traffic Noise Impact

2.10 The Permit Holder shall, no later than one month before the commencement of construction of the Project, submit to the Director for approval four hard copies and two electronic copies of Traffic Noise Mitigation Plan (TNMP). If there is any change proposed to the traffic noise mitigation measures in the approved TNMP, the Permit Holder shall, no later than one month before the implementation of any such change, submit to the Director for approval four hard copies and two electronic copies of an update to the TNMP (the Updated TNMP). The TNMP or any Updated TNMP shall demonstrate that the traffic noise performance requirements set out in the EIA report (Register No.: AEIAR-175/2013) will not be exceeded with the mitigation measures in place. The TNMP or any Updated TNMP shall include an implementation schedule in table form to clearly list out the mitigation measures to be implemented, and the implementation party, location, timing, and environmental performance required for implementation of the mitigation measures. All mitigation measures recommended and requirements specified in the TNMP or any Updated TNMP and the implementation schedule shall be fully implemented. Before submission to the Director, the TNMP or any Updated TNMP shall be certified by the ET Leader and verified by the IEC as conforming to the relevant information and recommendations on noise mitigation measures contained in the approved EIA report (Register No. AEIAR-175/2013).

許可證持有人須在工程項目開始建造之前至少提早 1 個月將交通噪音緩解計劃的 4 份硬複本及 2 份電子版本,提交署長批准。如對已批准的交通噪音緩解計劃提出任何交通噪音緩解措施的更改,許可證持有人須在執行提出的更改之前至少提早 1 個月將更新交通噪音緩解計劃(更新計劃)的 4 份硬複本及 2 份電子版本,提交署長批准。交通噪音緩解計劃及任何更新計劃須證明在實施了緩解措施後,工程項目的交通噪音表現不會超逾在環評報告(登記冊編號:AEIAR-175/2013)上所訂定的規定。交通噪音緩解計劃及任何更新計劃須包括以列表形式列出的實施一覽表,清楚列明將會實施的緩解措施、實施者、地點、時間,以及實施緩解措施時須達到的環境表現規定。交通噪音緩解計劃及任何更新計劃和實施一覽表中建議的所有緩解措施和訂明的規定均須全面予以實施。交通噪音緩解計劃及任何更新計劃在提交署長前,須由環境小組組長核證及由獨立環境查核人核實,證明符合核准環評報告(登記冊編號:AEIAR-175/2013)所載有關噪音緩解措施的資料及建議。

Measures to mitigate Ecological Impacts

2.11 All noise barriers shall be opaque, non-transparent and non- reflective to minimize mortality impacts on birds, unless otherwise agreed with the Director.

除非另獲署長同意,所有隔音屏必須具遮光、不透明及不反光特性,以盡量減低對鳥類死亡的影響。

3 Environmental Monitoring and Audit Requirements

環境監察及審核規定

3.1 The EM&A programme shall be implemented in accordance with the procedures and requirements as set out in the updated EM&A Manual deposited under Condition 2.3 of this Permit. Any change to the EM&A requirements or programme shall be justified by the ET Leader and verified by the IEC as conforming to the relevant requirements set out in the updated EM&A Manual and shall seek prior approval from the Director before implementation.

環監計劃須按本許可證條件第 2.3 項存放的經更新環監手冊所載的程序及規定執行。環監規定或計劃如有任何更改,須由環境小組組長提出充分理由,並由獨立環境查核人核實,證明其符合經更新環監手冊所載的相關規定,並須事先獲署長批准,方可執行。

- 3.2 Samples, measurements and necessary remedial actions shall be taken in accordance with the requirements of the updated EM&A Manual by:-
 - (i) conducting baseline environmental monitoring;
 - (ii) conducting impact monitoring;
 - (iii) carrying out remedial actions described in the Event/Action Plans of the updated EM&A Manual in accordance with the time frames set out in the Event/Action Plans, or as agreed by the Director, in case where specified criteria in the updated EM&A Manual are exceeded; and
 - (iv) logging and keeping records of details of all parameters within 3 working days of the collection of data or completion of remedial action(s), for the purpose of preparing and submitting the monthly EM&A Reports and to make available for inspection on site.

取樣、測量及所需的補救行動,均須按照經更新環監手冊所載的規定進行:-

- (i) 進行環境基線監測;
- (ii) 進行影響監測;
- (iii) 如超逾經更新環監手冊內指定的標準,則按照經更新環監手冊內的事件/行動計劃所訂明的時限或署長所同意的時限,執行事件/行動計劃所 說明的補救行動;以及
- (iv) 在收集數據或完成補救行動 3 個工作天內,須記錄及備存所有參數的詳情,用作擬備並提交每月環監報告,並備妥有關資料以供在工地查閱。
- 3.3 Three hard copies and two electronic copy of the Baseline Monitoring Report shall be submitted to the Director at least 2 weeks before the commencement of construction of the Project. The submissions shall be certified by the ET Leader and verified by the IEC as complied with the requirements as set out in the updated EM&A Manual before submission to the Director. The ET Leader and IEC shall personally inspect the site within each reporting cycle prior to certification and

verification of compliance of EM&A Reports. Additional copies of the submission shall be provided upon request by the Director.

在工程項目的建造工程展開前,須至少提早2個星期向署長提交基線監測報告的3份硬複本及2份電子版本。提交文件須由環境小組組長核證及獨立環境查核人核實,證明其符合經更新環監手冊所載的規定,然後才提交署長。環境小組組長及獨立環境查核人須在每個提交報告周期內親自巡查工地,然後才核證及查核環監報告的遵行情況。如署長要求,則須提交文件的額外複本。

3.4 Three hard copies and two electronic copy of monthly EM&A Report shall be submitted to the Director within 2 weeks after the end of each reporting month throughout the entire construction period. The EM&A Reports shall include a summary of all non-compliance. The submissions shall be certified by the ET Leader and verified by the IEC as complying with the requirements as set out in the updated EM&A Manual before submission to the Director. Additional copies of the submission shall be provided to the Director upon request by the Director.

在整個建造期內,在每個提交報告的月份結束後2個星期內,須向署長提交每月環監報告的3份硬複本及2份電子版本。環監報告須包括各種不符合規限情況的摘要。提交文件須由環境小組組長核證及獨立環境查核人核實,證明其符合經更新環監手冊所載的規定,然後才提交署長。如署長要求,則須向署長提交文件的額外複本。

3.5 All EM&A data submitted under this Permit shall be true, valid and correct.

4 Electronic Reporting of EM&A Information

4.1 To facilitate public inspection of the Baseline Monitoring Report and Monthly EM&A Reports via the EIAO Internet Website and at the EIAO Register Office, electronic copies of these Reports shall be prepared in Hyper Text Markup Language (HTML) (version 4.0 or later) and/or in Portable Document Format (PDF version 1.3 or later), unless otherwise agreed by the Director and shall be submitted at the same time as the hard copies as described in Conditions 3.3 and 3.4 above of this Permit. For the HTML version, a content page capable of providing hyperlink to each section and sub-section of these Reports shall be included in the beginning of the document. Hyperlinks to all figures, drawings and tables in these Reports shall be provided in the main text from where the respective references are made. All graphics in these Reports shall be in interlaced GIF/JEPG format unless otherwise agreed by the Director. The content of the electronic copies of these Reports must be the same as the hard copies.

4.2 The Permit Holder shall set up a dedicated website and notify the Director in writing the internet address where the environmental monitoring and project data is to be placed within one month after the commencement of construction of the Project. All environmental monitoring results described in Condition 4.1 above and all submissions required by this Permit shall be made available to the public via this dedicated website to be set up by the Permit Holder in the shortest time practicable, and in no event later than 2 weeks after the relevant environmental monitoring data are collected or become available, unless otherwise agreed with the Director. The Permit Holder shall maintain the dedicated website for public access of the environmental monitoring data and reports throughout the entire construction period and during the first 3 years of operation of the Project, or otherwise as agreed by the Director.

許可證持有人須在工程項目建造工程展開後 1 個月內,設立特定網站存放環境 監察數據及工程項目資料,並以書面通知署長網址所在。上文條件第 4.1 項說 明的所有環境監察結果及本許可證規定提交的所有文件,須盡快透過上述特定 網站供公眾閱覽,在任何情況下均不得遲於有關環境監察數據收集或可供閱覽 後的 2 個星期,除非另獲署長同意。許可證持有人須在工程項目的整個施工期 及營運首 3 年內(或署長另行同意的時間)維持該特定網站,讓公眾人士查閱環 境監察的數據及報告。

- 4.3 The internet website as described in Condition 4.2 above shall enable user-friendly public access to the monitoring data and project data including the EIA report, the environmental permit(s) and project profile of the Project. The internet website shall have features capable of:-
 - (a) providing access to all environmental monitoring data collected since the commencement of construction and all submissions under this permit;
 - (b) searching by date;
 - (c) searching by types of monitoring data; and
 - (d) hyperlinks to relevant monitoring data after searching.

If there is a breach of any condition of this Permit, the Director or his authorized officer may, with the consent of the Secretary for Environment and Ecology, order the cessation of associated work until the remedial action is taken in respect of the resultant environmental damage, and in that case the Permit Holder shall not carry out any associated works without the permission of the Director or his authorized officer. 如違反本許可證的任何條件,署長或獲授權人員徵得環境及生態局局長的同意後可勒令停止相關工程,直至許可證持有人為所造成的環境損害採取補救行動為止。在此情況下,許可證持有人未經署長或獲授權人員同意,不得進行任何相關工程。
- 3. The Permit Holder may apply under Section 13 of the EIAO to the Director for a variation of the conditions of this Permit. The Permit Holder shall replace the original permit displayed on the Project site by the amended permit. 許可證持有人可根據環評條例第 13 條的規定向署長申請更改本環境許可證的條件。許可證持有人須以經修改的許可證替換在工程項目工地內展示的原有許可證。
- 4. A person who assumes the responsibility for the whole or a part of the Project may, before he assumes responsibility of the Project, apply under Section 12 of the EIAO to the Director for a further environmental permit. 承擔工程項目整項或部分工程的責任的人,在承擔責任之前,可根據環評條例第 12條的規定向署長申請新的環境許可證。
- 5. Under Section 14 of the EIAO, the Director may with the consent of the Secretary for Environment and Ecology, suspend, vary or cancel this Permit. The suspended, varied or cancelled Permit shall be removed from display at the Project site. 根據環評條例第 14 條的規定,署長可在取得環境及生態局局長的同意下暫時吊銷、更改或取消本許可證。遭暫時吊銷、更改或取消的許可證必須從工程項目工地除下,不再展示。
- 6. If this Permit is cancelled or surrendered during construction or operation of the Project, another environmental permit must be obtained under the EIAO before the Project could be continued. It is an offence under Section 26(1) of the EIAO to construct or operate a designated project listed in Part I of Schedule 2 of the EIAO without a valid environmental permit.

 - (i) on a first conviction on indictment to a fine of \$2 million and to imprisonment for 6 months;
 - (ii) on a second or subsequent conviction on indictment to a fine of \$5 million and to imprisonment for 2 years;
 - (iii) on a first summary conviction to a fine at level 6 and to imprisonment for 6 months;
 - (iv) on a second or subsequent summary conviction to a fine of \$1 million and to imprisonment for 1 year; and
 - (v) in any case where the offence is of a continuing nature, the court or magistrate may impose a fine of \$10,000 for each day on which he is satisfied the offence continued.

- (v) 在任何情況下如該罪行屬持續性質,法院或裁判官可就其信納該罪行持續的 每天另處罰款 10,000 元。
- 8. The Permit Holder may appeal against any condition of this Permit under Section 17 of the EIAO within 30 days of receipt of this Permit. 許可證持有人可在接獲本許可證後 30 天內,根據環評條例第 17 條就本許可證的任何條件提出上訴。
- 9. The Notes are for general reference only and that the Permit Holder should refer to the EIAO for details and seek independent legal advice.




Figure 1: Location Plan for Castle Peak Road Diversion Project




Figure 2a: Identified Built Heritage items in KTN NDA




Figure 2b: Identified Built Heritage items in KTN NDA




Figure 3a: Identified Built Heritage items in KTN NDA




Figure 3b: Identified Built Heritage items in KTN NDA
