### Condition of Approval under Section 8(3) of the EIA Ordinance

(1) The Project Proponent shall submit a Habitat Creation and Management Plan (the Plan) for the Wetland Compensation Area as recommended in the EIA Report to the Director of Environmental Protection for approval. The Plan shall set out details of the specifications for the habitats and ecological functions and to define the management, including the cooperation arrangement with the management party of the adjacent compensation wetland, if any, and ecological monitoring and audit requirements of the Wetland Compensation Area. No construction works for San Tin Station and San Tin Ancillary Building shall be carried out before all the recommended enhancement measures of the approved Plan have been completed.
