

## 10.7 Environmental Monitoring & Audit

### 10.7.1 Aquatic Ecology

10.7.1.1 Monitoring and audit activities for water quality will serve to protect against unacceptable impacts to aquatic ecological environment. No monitoring programme specific for aquatic ecology would be required. Measures for preventing deterioration of water quality during the construction phase detailed in Section 4 of this report is considered adequate to mitigate impacts on aquatic ecology.

### 10.7.2 Terrestrial Ecology

10.7.2.1 Due to minor impacts on terrestrial ecology, no mitigation measures and monitoring programme is required.
