西九龍廢物轉運站隔油池廢物處理設施 油脂車輛登記帳戶排放隔油池廢物許可條款

- (一) 油脂車輛登記帳戶必須遵守排放隔油池廢物許可條款,才可於指定時間 內在本署之隔油池廢物處理設施排放隔油池廢物。
- (二) 本署之隔油池廢物處理設施只准排放隔油池廢物,任何非隔油池廢物 (如:住宅或化糞池的流質廢物、住宅或工商業污水、禽畜廢物、淤泥或 化學廢物)一律不准排放到本設施,亦不可與隔油池廢物混雜一起排放。
- (三) 請盡可能控制和減少隔油池廢物的含水量,以善用隔油池廢物處理設施有限的處理量。
- (四) 本署職員或承辦商有權要求吸缸車司機及使用設施之人員即時提供該吸缸車所載運隔油池廢物來源、數量及收集時間的單據或運載記錄作檢查/核實。
- (五) 本署或承辨商有權及不定期會從吸缸車抽取排放廢物樣本以作檢驗。
- (六) 本署職員或承辦商可拒絕接收懷疑非隔油池廢物,並要求有關的吸缸車即時離開隔油池廢物處理設施。
- (七) 當吸缸車於本署隔油池廢物處理設施排放隔油池廢物時,司機及使用設施之人員必須遵守西九龍廢物轉運站的安全規則和本署職員或承辦商的指示。
- (八) 必須保持環境清潔衛生,請勿留下廢物、廢水於周遭及地下。
- (九) 當使用吸缸車排放隔油池廢物時,必須將排放喉管插穩和扣緊,以免廢物 流出。
- (十) 當出現緊急情況、操作需要或其他因素時,本署可在短時間內暫停收集隔 油池廢物的服務,登記帳戶不得以暫停排放導致的任何損失向本署索償。
- (十一)如有任何已登記吸缸車或登記帳戶的資料更新,請盡快通知本署以便更 新記錄。
- (十二)如登記帳戶多次被發現違反以上任何條款,其登記可被暫止或取消。
- (十三)為確保各設施使用者及道路使用者安全,請勿超載。
