- For the authorized vehicle, we only accept those vehicle owner and driver who are living at the same closed area with close relationship. The applicant should produce proof of relationship and authorization letter of the vehicle owner.
- Closed Road Permit is valid for a maximum period of one year.
- Closed Road Permits are issued free of charge but replacement for loss, defaced or damaged permits will be issued subject to the levy of a charge of \$65 in accordance with the relevant legislation and the Loss report issued by the police station, the identity document of the applicant, copy of driving licence of driver and vehicle registration.
