KWP Quarry Company Limited [CACV 256/2017]	32 IRBRD 227	On 11 April 2019, the Court of Appeal orally dismissed the Taxpayer's appeal against the Court of First Instance's dismissal of the judicial review application in respect of the Board's refusal to state a case. The Taxpayer has filed a notice of intended application for leave to appeal to the Court of Final Appeal. Leave was granted to the Taxpayer to amend its notice of motion within 28 days after handing down of the reasons for the Court of Appeal's decision. By a judgment dated 3 November 2021, the Court of Appeal dismissed the Taxpayer's appeal. The Taxpayer has filed an amended notice of motion.

The Commissioner has filed a notice of appeal to the Court of Appeal. On 29 June 2021, the Court of First Instance allowed the Taxpayer's appeal on another ground of appeal. The Commissioner has filed a notice of appeal to the Court of Appeal. These appeals will be heard in the Court of Appeal on 25 February 2022.
