# Second Meeting of the EEC Subgroup on Business Facilitation

# Agenda Item 4.2 : Regulatory activities affecting the Entertainment sector

### **Purpose**

This paper presents the initial findings on the regulatory activities affecting the entertainment sector.

2. At the second EEC meeting held on 31 May, Members agreed on the priority of industry sectors for regulatory reviews and the entertainment sector was one of the priority areas identified.

### **Findings**

- 3. Based on the Hong Kong Standard Industrial Classification<sup>(1)</sup>, there are two major industry groups under the entertainment sector, viz motion pictures and other entertainment services, and miscellaneous amusement and recreational services. Each of these industry subgroups has a number of sub-classifications as shown at **Annex 1**.
- 4. The 2003 employment statistics for the two major industry subgroups under entertainment are as follows –

- 5. The regulatory framework of the entertainment sector is mainly exercised through approvals, certification and licensing and there are altogether 60 more common regulatory activities administered by 14 departments<sup>(3)</sup> as shown in **Annexes 2 and 3**.
- 6. There has been a number of reviews in recent years to streamline the procedures of entertainment licences. These cover mahjong / tin kau centres, billiard centres, bowling centres, public dance halls, dancing schools, amusement games centres, discos and karaoke establishments, public skating rinks, amusement rides, lottery, tombola, amusement with prizes, trade promotion competition and massage establishments. The focus of these reviews was primarily on cutting red tape, with little challenge on the original policy intent.

### **Industry's Concerns**

- 7. We are gathering views from different industry subgroups under the entertainment sector. For cinema operation, we have received feedback as follows
  - (a) The fire safety requirement about independent stairways leading directly to the street level is considered outdated. Cinemas should be allowed to locate on the upper floors of commercial or shopping malls provided adequate means of escape have been taken care of. This would help increase patronage of shops; and
  - (b) Provision of a lift for workers with physical disabilities to work in the projection room is impractical as the work environment and the job nature would make it difficult for these persons to function effectively in a cinema operation room.

### **Way Forward**


8. We shall arrange to form a task force with representatives from the industry to identify and prioritize study areas, and to oversee the regulatory review. Subgroup Members are invited to join the task force.
