MAINLAND AND HONG KONG CLOSER ECONOMIC PARTNERSHIP ARRANGEMENT

Further Trade Liberalization (CEPA II)

Introduction

This note informs members of the outcome of the Administration's discussions with the Mainland on further liberalization of trade in goods and services under the Mainland and Hong Kong Closer Economic Partnership Arrangement (CEPA).

Background

2. CEPA adopts a building block approach and provides a mechanism for further liberalization measures. Since the implementation of CEPA on 1 January 2004, the Central People's Government (CPG) and the Government of the Hong Kong Special Administrative Region (HKSARG) have held a series of high level and senior official meetings with a view to broadening the scope of CEPA. The two sides reached agreement on further liberalization measures on 27 August 2004.

Summary of Further Liberalization under CEPA

(A) Trade in Goods

3. The Mainland has applied zero import tariff from 1 January 2004 for exports from Hong Kong meeting CEPA origin rules for goods in 374 Mainland 2004 tariff codes. For other products, the Mainland has undertaken to apply zero tariff latest by 1 January 2006 upon applications by local manufacturers and upon CEPA origin rules being agreed and met. The HKSARG invited local manufacturers to submit their requests from January to April 2004. The requests were consolidated and submitted to the Mainland in May 2004. After a series of meetings, the Mainland has agreed to apply zero tariff to products under 713 Mainland 2004 tariff codes. They are on top of the 374 tariff codes which have already been enjoying zero import tariff from 1 January 2004. A list of the 713 tariff codes is at *Annex I*.

- 4. The 713 Mainland 2004 tariff codes cover both existing production (529 tariff codes) and planned production (184 tariff codes). The products under the 529 tariff codes will enjoy zero tariff from 1 January 2005. For the remaining 184 codes, zero tariff will be applied from 1 January of the following year upon confirmation by both sides that the products have come into production. The Trade and Industry Department (TID) will announce the detailed arrangements shortly.
- 5. The two sides will begin formal discussions on the rules of origin (ROO) for the 713 Mainland 2004 tariff codes. Consultations on the ROOs will be completed by October 2004.

Procedures for Claiming Zero Tariff

6. To claim zero import tariff under CEPA, products being exported into the Mainland must be accompanied by a Certificate of Hong Kong Origin-CEPA (CO(CEPA)) issued by TID or one of the Government Approved Certification Organizations^(Note 1). Before applying for CO(CEPA), manufacturers are required to apply for a Factory Registration (FR) with TID to demonstrate that their factories possess sufficient capacity to produce the goods for export. The application procedures and the conditions of issuing CO(CEPA) are set out in Certificate of Origin Circulars No. 23/2003 and No. 24/2003, both issued on 14 November 2003, and No. 7/2004 issued on 7 June 2004. All these circulars can be downloaded from TID's website (www.tid.gov.hk/english/cepa/trade_goods.html).

(B) Trade in Services

- 7. In CEPA, the Mainland has given preferential treatment to Hong Kong service suppliers in 18 service sectors. Under CEPA II, the Mainland has agreed to broaden the liberalization in respect of 11 of them:
 - legal services
 - distribution services
- construction services
- transport services (including road passenger transportation and maritime transport)

(Note 1) Under the Protection of Non-Government Certificates of Origin Ordinance (Cap. 324), there are five Government Approved Certification Organizations (GACOs) designated to issue certificates of origin: Chinese Manufacturers' Association of Hong Kong; Federation of Hong Kong Industries; Hong Kong General Chamber of Commerce; Indian Chamber of Commerce, Hong Kong; and Chinese General Chamber of Commerce.

- freight forwarding services
- agency medical services
- audiovisual services
- accounting services

• banking services

- securities and futures services
- individually owned stores

In addition, the Mainland has agreed to introduce liberalization measures in the following 8 new areas:

- airport services
- patent agency services
- job referral agency services
- job intermediary services
- information technology services
- trade mark agency services
- cultural entertainment services
- professional qualification examinations

Unless specified otherwise, the new liberalization measures will take effect from <u>1 January 2005</u>. Taking the two phases of CEPA together, Hong Kong service suppliers are now eligible for preferential treatment in 26 service areas.

8. Broadly speaking, the liberalization permits earlier access for Hong Kong services suppliers to the Mainland market, ahead of China's WTO timetable. In some sectors, like audiovisual services, transport and related services and medical services, the concessions go beyond China's WTO commitments. In particular, the Mainland has agreed to lift the geographical restriction and expand the business scope for the individually owned stores set up by Hong Kong permanent residents with Chinese citizenship. The new liberalization measures under CEPA II are set out in *Annex II*.

<u>Definition and Certification of "Hong Kong Service Supplier"</u>

9. Generally speaking, "juridical persons" (including companies, partnerships and sole proprietorships) as well as "natural persons" of Hong Kong will be able to enjoy preferential treatment granted by the Mainland, provided that they fulfill the definition and related requirements of Hong Kong service suppliers. Unless otherwise specified in CEPA, a "natural person" means a Hong Kong permanent resident, whereas a "juridical person" means any legal entity duly constituted or otherwise organized under the applicable laws of Hong Kong and which has engaged in substantive business operations in Hong Kong for three to five years.

- 10. Hong Kong service supplier as a juridical person should apply to TID for a Certificate of Hong Kong Service Supplier before it can obtain the preferential treatment under CEPA. A Hong Kong service supplier who wants to obtain CEPA treatment as a natural person should provide to the relevant Mainland authorities identification of his or her Hong Kong permanent resident status.
- 11. Detailed application procedures for the 18 service sectors covered in CEPA have been announced in Notices to Service Suppliers No. 2/2003, No. 2/2004 and No. 3/2004, all of which can be downloaded from the website of TID (www.tid.gov.hk/english/cepa/). It is envisaged that procedures for applying Certificate of Hong Kong Service Supplier in respect of service areas under CEPA II will basically follow the procedures announced in the above circulars, supplemented with certain sector-specific requirements, if any. The circulars will be updated and announced as appropriate.

(C) Mutual Recognition of Professional Qualifications

- 12. As part of the services trade under CEPA, Hong Kong and the Mainland have committed to encouraging mutual recognition of professional qualifications and promoting the exchange of professional talents between each other. After the signing of the six Annexes of CEPA in September 2003, relevant professional and regulatory bodies of Hong Kong and the Mainland, with the support and facilitation of the CPG and the HKSARG, have concluded the following agreements or arrangements:
 - a reciprocal agreement in early November 2003 for the estate surveyors;
 - an arrangement to facilitate the flow of qualified personnel and expertise in respect of the securities and futures industry in December 2003;
 - a mutual recognition agreement for architects in February 2004;
 - an agreement on measures to facilitate Hong Kong residents to take the "Mainland Insurance Practitioners Qualifying Examinations" in February 2004;
 - arrangements to allow Hong Kong residents to take the "National Qualification Examination for Patent Agents" in April 2004.

On 27 August 2004, a mutual recognition agreement for structural engineers, and an arrangement for the exemption of professional examination papers in the accounting sector were signed.

Way Forward

- 13. The CPG and the HKSARG will work closely to thrash out the implementation details of CEPA II. We will inform the trade of relevant implementation measures shortly.
- 14. The HKSARG shall spare no effort in encouraging the local business sector to make full use of the preferences under CEPA. We will also underline the many business opportunities offered by CEPA in our promotion work to attract more foreign investment to Hong Kong.
- 15. The CPG and the HKSARG shall continue to pursue further liberalization on goods and services trade in the latter phases under CEPA through the established liaison mechanisms. In this regard, the HKSARG will continue to consult the business and professional communities to understand their needs. The HKSARG shall also discuss with the concerned business sectors on appropriate policy measures that may be required to enable them to gain the greatest benefits from CEPA.

Implications of Implementation

16. In terms of economic benefits, CEPA II will offer new business opportunities in the Mainland for Hong Kong businesses and service suppliers. It will enhance the attractiveness of Hong Kong to overseas investors. The zero import tariff preference has the potential to attract to Hong Kong manufacturing of brand name products, or manufacturing process with high-value added content or substantial intellectual property input. The WTO-plus market liberalization measures for trade in services will give companies in Hong Kong a head start over their competitors from other economies. It is of course up to the businessmen from Hong Kong and elsewhere in the world to decide whether and how they would like to leverage on the opportunities arising from CEPA II. This will determine the scale of business activities induced and direct and indirect economic benefits for Hong Kong. The Administration has announced that it would conduct an assessment of the economic impact of CEPA, including that on local

employment, 9-12 months following CEPA's implementation since the beginning of this year. Preparatory work is now underway.

17. The Trade and Industry Department (TID) and the Customs & Excise Department (C&ED) will continue to carry out the part of CEPA work related to the certification of goods of Hong Kong origin and of Hong Kong service suppliers. Relevant policy bureaux and departments will be involved in the implementation of those parts of CEPA II under their purview.

CONSULTATION WITH BUSINESS AND PROFESSIONAL COMMUNITIES

- 18. We have been in touch with the business and professional communities in formulating the strategy for CEPA II. We will stay in close and constant dialogue with the stakeholders in the implementation of the further liberalization measures and in talks with the Mainland on the next phases of CEPA.
- 19. We will continue to keep the Committee informed of the major developments of CEPA.

To allow consultancy companies in the Mainland established by Hong Kong accountants that have satisfied the requirements of the Mainland's "Provisional Measures for the Administration of the Provision of Bookkeeping Services" to provide bookkeeping services. Hong Kong accountants providing bookkeeping services should have obtained the Mainland's accounting qualification certificate. In addition, the person in charge of the bookkeeping services should hold the relevant Mainland's professional qualification (professional title) of accountant or above.
	2. When Hong Kong accountants apply for a practising licence in the Mainland, the length of auditing experience that they have acquired in Hong Kong is equivalent to the length of auditing experience acquired in the Mainland.
Medical and dental services	1. To allow Hong Kong permanent residents who are legally eligible to practise in Hong Kong and have practised for 5 completed years to open clinics in the Mainland on the condition that they have obtained the practicing certificate of the Mainland's qualification examinations. Matters relating to the application for and registration of opening clinics should be handled in accordance with Mainland regulations.

To allow Hong Kong permanent residents who have acquired a Chinese medicine full-time degree from the University of Hong Kong, the Chinese University of Hong Kong or the Hong Kong Baptist University and are legally eligible to practise in Hong Kong to sit the Mainland's qualification examinations on the condition that they have completed 1 year's continuous internship under the instruction of qualified practitioners in a third-level traditional Chinese medicine hospital in the Mainland and have passed the performance test, or that they have been practising in Hong Kong for more than 1 year.
	4. Hong Kong permanent residents who are legally eligible to practise western medicine, dentistry and Chinese medicine in the Hong Kong Special Administrative Region are not required to sit the Mainland's qualification examinations for the purpose of short term practice in the Mainland.
Information technology services	1. To allow Hong Kong service suppliers to apply for computer information system integration qualification certification in accordance with the provisions of the relevant laws, regulations and rules of the Mainland.
Audiovisual services	1. Hong Kong service suppliers are permitted to construct or renovate cinema theatres for the operation of film screening business on a wholly-owned basis.

- 2. Motion pictures co-produced by Hong Kong and the Mainland are permitted to be processed outside the Mainland after obtaining the approval of the State Administration of Radio, Film and Television.
- 3. Hong Kong service suppliers are permitted to establish wholly owned companies in pilot areas in the Mainland to engage in the distribution of Mainland produced motion pictures after obtaining the approval of the State Administration of Radio, Film and Television.
- 4. Television programmes co-produced by Hong Kong and the Mainland are permitted to be broadcast and distributed in the same way as Mainland produced television programmes after being examined by the relevant Mainland authorities.
- 5. Hong Kong companies engaging in the operation of cable television network are permitted to provide professional technical services related to cable television networks in Guangdong as a pilot area after obtaining the approval of the relevant Mainland authorities.

Construction and related engineering services

- 1. Hong Kong service suppliers who have already obtained the certificate of approval for establishment of enterprises with investment of Taiwan, Hong Kong and Macao in the Mainland but have not yet obtained the construction enterprise qualification certificate may apply, before 1 December 2004, for a certificate for undertaking single construction project based on their signed construction contract and "Construction Qualification Certificate for Taiwan, Hong Kong and Macao Enterprise". Subject to the preliminary vetting and agreement of construction administration department at provincial level, the application will be processed by the Ministry of Construction.
- 2. Construction enterprises in the Mainland set up by Hong Kong service suppliers may submit the performance of the enterprises for construction contracts outside the Mainland when applying for construction enterprise qualification certificate.
- 3. The residency requirement is waived for Hong Kong permanent residents employed as engineering technical staff and financial managerial staff in construction enterprises in the Mainland set up by Hong Kong service suppliers.
- 4. There will be no restriction on the proportion of Hong Kong permanent residents being project managers approved by the qualification administration authorities for construction enterprises in the Mainland set up by Hong Kong service suppliers.
- The commitments in relation to construction and related engineering services stated above will come into effect from the day after the signing of the Record of Consultations.

Distribution services

- Retailing services: to allow Hong Kong service suppliers to set up, in the form of
 wholly-owned operations, retail commercial enterprises in the Mainland in respect
 of books, newspapers, magazines, pharmaceutical products, pesticides, mulching
 films and processed oil with effect from the day after the signing of the Record of
 Consultations.
- 2. Wholesale trade services and commission agents' services: to allow Hong Kong service suppliers to set up, in the form of wholly-owned operations, wholesale and commission agents' commercial enterprises in the Mainland in respect of books, newspapers, magazines, pharmaceutical products, pesticides and mulching films with effect from the day after the signing of the Record of Consultations.
- 3. Retailing of motor vehicles: to allow Hong Kong service suppliers to set up, in the form of wholly-owned operations, retail enterprises in the Mainland for motor vehicles in accordance with the relevant motor vehicle distribution rules in the Mainland. Threshold requirements for setting up the above enterprises are waived for Hong Kong service suppliers. Those requirements are that "the average annual sales value of a Hong Kong service supplier in the preceding 3 years is not less than US\$100 million; the minimum asset in the previous year is US\$10 million; the minimum registered capital for setting up a motor vehicle retail enterprise in the Mainland is RMB 10 million. For setting up a motor vehicle retail enterprise in the

	Central and Western Region, the minimum registered capital is RMB 6 million."
Banking services	1. To allow Mainland branches of Hong Kong banks to conduct insurance agents business after obtaining approval.
Securities and futures services	1. To allow intermediary agencies, which are registered with the Securities and Futures Commission of Hong Kong and which satisfy the requirements of the China Securities Regulatory Commission, to set up joint venture futures brokerage companies in the Mainland. The proportion of Hong Kong shareholding should not exceed 49% (including shareholding of related parties). The scope of business and capital requirements of joint venture futures brokerage companies are the same as those for Mainland enterprises.
Transport services	1. To allow passenger transport companies operating franchised bus services in Hong Kong to set up wholly-owned or joint venture enterprises in Mainland cities at the municipal level to provide passenger public transport and hire car services at those cities.
	2. To allow passenger transport companies operating franchised bus services and companies operating non-franchised bus services (Guangdong-Hong Kong cross-boundary coach services) in Hong Kong to set up joint venture enterprises in Guangdong, Guangxi, Hunan, Hainan, Fujian, Jiangxi, Yunnan, Guizhou and Sichuan to provide direct inter-city passenger bus services.
	3. To allow Hong Kong service suppliers to set up wholly-owned companies in the Mainland to provide supplies services other than fuel and water (e.g. components and parts or food, etc) to vessels owned or managed by their parent companies.

To allow Hong Kong service suppliers to set up wholly-owned shipping companies in the Mainland to provide shipping agency services for vessels owned or operated by their parent companies, including customs declaration and inspection, and use of common commercial bills of lading or multimodal transport documents for conducting multimodal transport services.
	5. To allow Hong Kong service suppliers to set up wholly-owned companies in the Mainland to provide port cargo loading and unloading services.
	6. To allow Hong Kong service suppliers to set up wholly-owned shipping companies in the Mainland to provide regular business services for feeders that they operate between Hong Kong and ports that are opened to foreign vessels in the Mainland, such as shipping undertaking, issuance of bills of lading, settlement of freight rates, signing of service contracts, etc.
Freight forwarding agency services	To allow freight forwarding agency enterprises in the Mainland established by Hong Kong services suppliers to set up branch offices upon full payment of registered capital.
Airport services	1. Airport management services: to allow Hong Kong service suppliers to provide, in the form of cross-border supply, joint venture or wholly-owned operations, contract management services for small and medium airports. The period of validity of the contract should not exceed 20 years.
	To allow Hong Kong service suppliers to provide, in the form of cross-border supply, consumption abroad, joint venture or wholly-owned operations, airport management training and consultation services.
	2. Ground services: to allow Hong Kong service suppliers to provide, in the form of wholly-owned operations, the following seven types of air transport ground services in the Mainland: (1) agency services; (2) leading and unleading central communication, and departure.
	 (2) loading and unloading control, communication, and departure control system; (3) unit load devices management;

(4) passenger and baggage services; (5) cargo and mail services; ramp services; (6) aircraft services. (7) The qualifying criteria for "Hong Kong service suppliers" in this paragraph, as far as the "nature and scope of business" and the "years of operation required" are concerned, means Hong Kong service suppliers who have obtained the relevant licences in Hong Kong and are dedicated to the provision of the relevant air transport ground services and have engaged in substantive business operations for five years or more. Cultural To allow Hong Kong service suppliers to set up performing venues in the Mainland entertainment on an equity joint venture, wholly-owned or contractual joint venture basis. services To allow Hong Kong performing arts agencies to set up branches in the Mainland. To allow Hong Kong service suppliers to set up performance agencies in the Mainland on an equity joint venture or contractual joint venture basis. To allow Hong Kong service suppliers to set up internet culture business units and 4. internet online service business premises in the Mainland with the Mainland party holding majority shareholding. To allow Hong Kong service suppliers to set up art galleries, art shops and art work exhibition units in the Mainland on an equity joint venture, wholly-owned or contractual joint venture basis. Trade To allow Hong Kong service suppliers to conduct, after registering with the mark Administration for Industry and Commerce at the provincial level and acquiring the agency services statutory operating body qualification, trade mark agency business in the Mainland. Job referral To allow Hong Kong service suppliers to set up wholly-owned job referral agencies agency services in the Mainland. The minimum registered capital is US\$125,000. Job To allow Hong Kong service suppliers to set up joint-venture job intermediaries in the Mainland. The minimum registered capital is US\$125,000. The proportion of intermediary Hong Kong service suppliers' shareholding should not exceed 70% and the services Mainland partner intermediary must have been established for over 1 year. Patent To allow eligible Hong Kong permanent residents with Chinese citizenship to take agency services the National Qualification Examination for Patent Agents in the Mainland. Hong Kong permanent residents with Chinese citizenship who have obtained the Patent Agent Qualification Certificates may practise in patent agencies that have been permitted to be established in the Mainland. Those who meet the prescribed requirements may become partners or shareholders of patent agencies that have been permitted to be established in the Mainland. **Oualification** To allow eligible Hong Kong residents to take the 30 qualification examinations for examinations professionals and technicians in the Mainland, including the qualification examinations for registered architect, registered structural engineer, registered civil engineer professionals (geotechnical), construction supervising engineer, cost engineer, registered town planner, and technicians estate agent, registered safety engineer, registered nuclear safety engineer, builder, registered facility engineer, registered chemical engineer, registered civil engineer (harbour and waterway), registered facility supervising engineer, environmental impact assessment engineer, real estate appraiser, registered electrical engineer, accounting technician, assistant accountant, accountant professional qualification (professional title), certified tax accountant, certified asset appraiser, prosthetist and orthotist, mining rights assessor, registered consulting engineer, international business personnel, land registration agent, gemstone quality examiner, translator and computing technology and software.
