the application. Since the last deferment, the applicant had not submitted any further information, but indicated that additional time was needed to prepare responses to the departmental comments.

The Committee agreed that the application should be submitted for its consideration within two months from the date of receipt of further information from the applicant. If the further information submitted by the applicant was not substantial and could be processed within a shorter time, the application could be submitted to an earlier meeting for the Committee's consideration. The Committee also agreed to advise the applicant that two months were allowed for preparation of the submission of the further information. As the interests of Ms Jacinta K.C. Woo (the Chairperson), Mr Daniel K.S. Lau and Mr Simon S.W. Wang were direct, the Committee agreed that they could stay in the meeting but should refrain from participating in the discussion. As the interests of Mr Thomas O.S. Ho and Dr Lawrence W.C. Poon were indirect and since Mr Alex T.H. Lai had no involvement in the application, the Committee agreed that they could stay in the meeting.

preparation of further information/technical clarifications in response to departmental comments, and subsequent processing of the submissions by relevant government departments. It was the first time that the applicant requested deferment of the application.
