1. The aplication site is covered by planning permission No. A/HSK/390. The applicant is still implementing the accepted fire service installations proposal and it will not be finished until the provision of water supply by WSD.  2. The application site subjects to 13 planning permissions since 1996. The applied use of the current application is the same as the approved use of the previous planning permission since 2017.
3. The proposed development conforms to the Town Planning Board Guidelines for Application for Open Storage and Port Back-up Uses (TPB PG-NO. 13G) because it is subject to previous planning permissions.  4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.  5. The proposed development is not incompatible with the surrounding environment including open storage use
and port back-up activities.  6. Open storage & port back-up uses adjoining the application site were granted with planning permission.  Similar preferential treatment should be granted to the current application.  7. All the planning conditions imposed to the last planning permission have been complied with except the implementation of fire service installations proposal.
8. Shortage of land for port back-up purpose in Ha Tsuen.  9. The planning circumstance pertaining to the application site is similar to the recent approval of adjacent open
storage yards and port back-up uses.  10. Minimal traffic impact.
11. Insignificant environmental and noise impacts because the applied use is housed within an enclosed structures
12. Insiginificant drainage impact because surface U-channel has been provided at the application site.
