APPLICATION FOR PERMISSION

UNDER SECTION 16 OF THE TOWN PLANNING ORDINANCE (CAP 131) PROPOSED 'PLACE OF RECREATION, SPORTS OR CULTURE (GYMNASIUM)' AT KINDERGARTEN, G/F, CHESTWOOD COURT, KINGSWOOD VILLAS PHASE 3, NO. 8 TIN SHUI ROAD, TIN SHUI WAI, YUEN LONG ON THE APPROVED TIN SHUI WAI OUTLINE ZONING PLAN NO. S/TSW/16 (APPLICATION NO. A/TSW/81 – FURTHER INFORMATION 2)

We refer to the captioned planning application No. A/TSW/81.

Further to our original submission and Further Information (1) submission received by the Town Planning Board ("TPB") dated 16 February 2024 and 1 March 2024 respectively, we hereby submit Further Information (2) to support this application.

In response to LandsD's comment (**Attachment I**), we would like to exclude the semi-covered passageway outside the classrooms from the application area. The revised total application area is about 899.4m².

As agreed with Ms. Jessie Kwok (TP/TM 3) in the telephone conversation dated 11 March 2024, we could address this application area issue with a Class A amendment, as our rationale for setting out the initial application area was not incorrect. The initial application area was based on the GFA calculation under the Buildings Ordinance in the approved building plan, which is the normal practice for planning applications. However, LandsD opined that the application area must follow LandsD's basis for this case.

In view of the above, we now enclose the replacement pages of the Application Form (**Attachment II**) and the full set of updated planning statement (**Attachment III**) to supersede the set included in the original submission.
