7. Justifications 理由

The applicant is invited to provide justifications in support of the application. Use separate sheets if necessary.

The current application aims to seek planning permission again from the Town Planning Board (the Board) for the Temporary Open Storage of Freezer Vehicles, Air-conditioned Compartments and Spare Parts of Cooling Machinery Components for Vehicles for Sale, and Installation and Maintenance Workshop for Freezer Vehicles for a Period of 3 Years in order to allow us to continue our business of sale of compartments of freezer vehicles and the components of cooling machinery for vehicles at the application site.

On 2.3.2018, the latest previous application No. A/YL-KTS/751 was approved by the Board with a validity of three years. The planning permission was revoked on 2.9.2019 due to non-compliance with time-limited approval conditions. During the approval period of application No. A/YL-KTS/751, the provision of the fire extinguisher(s) is consider acceptable and approval condition (j) was complied. Meanwhile, our company had also made genuine efforts in searching for qualified contractor for the FSIs and the drainage works, however due to the small scale of the applied development and the remote location of the application site, qualified contractor was yet to be appointed.

Comparing with the previously approved application, the current scheme has no change in the nature of use, design and operation. The operating hours of the applied use will remain from 9:00a.m. to 6:00p.m. from Monday to Saturday exclude Sunday and public holidays . There is also no significant change in planning circumstances including the planning policy and land-use zoning of the area. Considering the current application carries the same site context, scale and nature as the latest previously approved application, the approval of the current application would be in line with the previous decision of the Board and would by no means set an undesirable precedent for other similar applications. Furthermore, the applied use in temporary nature will provide flexibility for future planning circumstance and would not jeopardise the long-term planning intention of the "Other Specified Uses" annotated "Rural Use" zone.

The surrounding areas of the application site are predominantly rural in character comprising temporary structures for warehouse/workshop/open storage use, domestic structures and vacant land. Given the abundance of industrial uses nearby, including warehouses, workshops and open storages, the proposed use will be suitable and compatible with the surrounding land uses.

The applied use will not induce significant environmental impact and nuisance on the surroundings, in which most of the workshop activities will be performed within the structures to reduce noise impacts and paint spraying activities will be restricted. The applied use and the residential dwellings in the vicinity are separated by the nullah and other open storage uses and no environmental complaint was received on our operation. If the current application is approved, our company would strictly follow the "Code of Practice on Handling the Environmental Aspects of Temporary Uses and Open Storage Sites" (COP) and to minimize any nuisance generated from the applied use.

Relevant fire, drainage and landscape proposals along with the detailed elaboration on major development parameters and operational arrangements are submitted in the current application.
