1. The proposed development is zoned 'Category 2 Areas' in accordance to the Town Planning Board Guidelines No. 13G for Application for Open Storage and Port Back-up Uses under Section 16 of the Town Planning Ordinance. Sympathetic consideration would normally be granted if no adverse comments/objection is received.
2. The current planning application is a renewal application. The application site is subject to a previous planning permission A/YL-KTS/886 approved for the same use as the applied use.
3. The proposed development would benefit the open storage industry in the area because there is acute demand for open storage in Kam Tin area.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The proposed development is not incompatible with the surrounding environment.
6. Similar shop and services in 'R(D)' zone such as A/YL-KTS/880 & 894 were granted with planning permission. Similar preferential treatment should be granted to the current application.
7. The applicant will comply with planning conditions if the Town Planning Board see fits.
8. Minimal traffic impact.
9. Insignificant environmental and noise impacts because no operation will be held during sensitive hours.
10. Insignificant drainage impact because surface U-channel will be provided at the application site.
11. The construction machinery and construction materials to be stored at the application site is not significant in size. They include miniature excavator, electric generator, sanitary ware and alike.
