1. The proposed development is a shop for selling building material such as pipes, bricks and so on.
2. Shop and services use is a Column 2 use in the 'Residential (Group D)' zone. It is a complementary use to the adjacent residential developments.
3. The proposed development would benefit the residents in the vicinity by catering their demand for building materials.
4. The proposed development is a temporary use for a period of 3 years which would not jeopardize the long term planning intention of the current zoning.
5. The nature and scale of the proposed development is not incompatible with the surrounding environment.
6. Similar shop and services such in "R(D)" zone such as A/TM-LTYT/464 was granted with planning permission. Similar preferential treatment should be granted to the current application.
7. The applicant has submitted an application for short term tenancy to DLO/TM and they replied that prior permission from Town Planning Board is required for their consideration of the short term tenancy application.
8. Minimal drainage impact because the applicant has submitted a drainage proposal in support of his application.
9. Minimal traffic impact.
10. Insignificant environmental and noise impacts because the applied use is housed within an enclosed structure.
11. No workshop activity will be carried out at the application site.
12. No medium goods vehicle and heavy goods vehicle and container trailer/tractor will enter into or park at the application site.
