**Proposed Minor Relaxation of Building Height Restriction for Permitted Social Welfare Facility (Residential Care Home for the Elderly) and Proposed House Use with Conservation Proposal at Lots 1695 S.E ss.1 RP, 1695 S.F ss.1 and 1695 S.H RP (Part) in D.D.120 and Adjoining Government Land, Tai Kei Leng, Yuen Long, New Territories  
S16 Application No.: A/YL/302 - Submission of Further Information (3)**

Reference is made to the Building Department's comments on the General Building Plan submission for the same development proposal on May 24, 2023. It is explicitly stated that the proposed 7450mm headroom on G/F would be considered excessive and shall be double counted for Gross Floor Area (GFA). As a recap, the proposed 7450mm headroom is to allow for the in-situ preservation of Siu Lo including its Annex Block, and to maintain sufficient vertical clearance for future maintenance of the pitched roof of the Annex Block.

To comply with the Building Authority's (BA's) ruling, the GFA for certain parts of the G/F, accounting for a total of about 575m<sup>2</sup>, will be double counted. Whilst there are no GFA or PR restrictions on the extant OZP, the proposed update in total GFA from 5,756m<sup>2</sup> under the submitted proposal to 6,331m<sup>2</sup> (+575m<sup>2</sup>) as a result from the double counting is solely for GFA calculation under Building Regulation. **Please see the attached Drawing No. P-101 (Appendix 1).**

The amendment in GFA solely arisen from GFA calculation under BA's ruling has no changes on the schematic layout and other development parameters. **Please see the attached replacement pages of the application form (Appendix 2) and planning statement (Appendix 3).**

It is worth noting that the maximum total GFA eligible for premium payment exemption has been relaxed from 5,400m<sup>2</sup> to 12,000m<sup>2</sup> as per the Legislative Council Panel on Welfare Services Meeting (LC Paper No. CB(2)535/2023(04)). The Applicant will seek formal policy support on premium concession with reference to the updated practice note, which is expected to be available by the end of June. The Proposed Development is therefore still expected to be eligible for the concerned Incentive Scheme.

Remarkably, please note that a proposed right-of-way (RoW) is shown on the attached Drawing No. P-101 and this indicative RoW will be further applied to the Lands Department at the land application stage. The RoW is also outside the planning application boundary.
