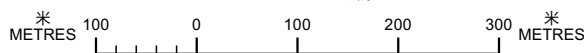

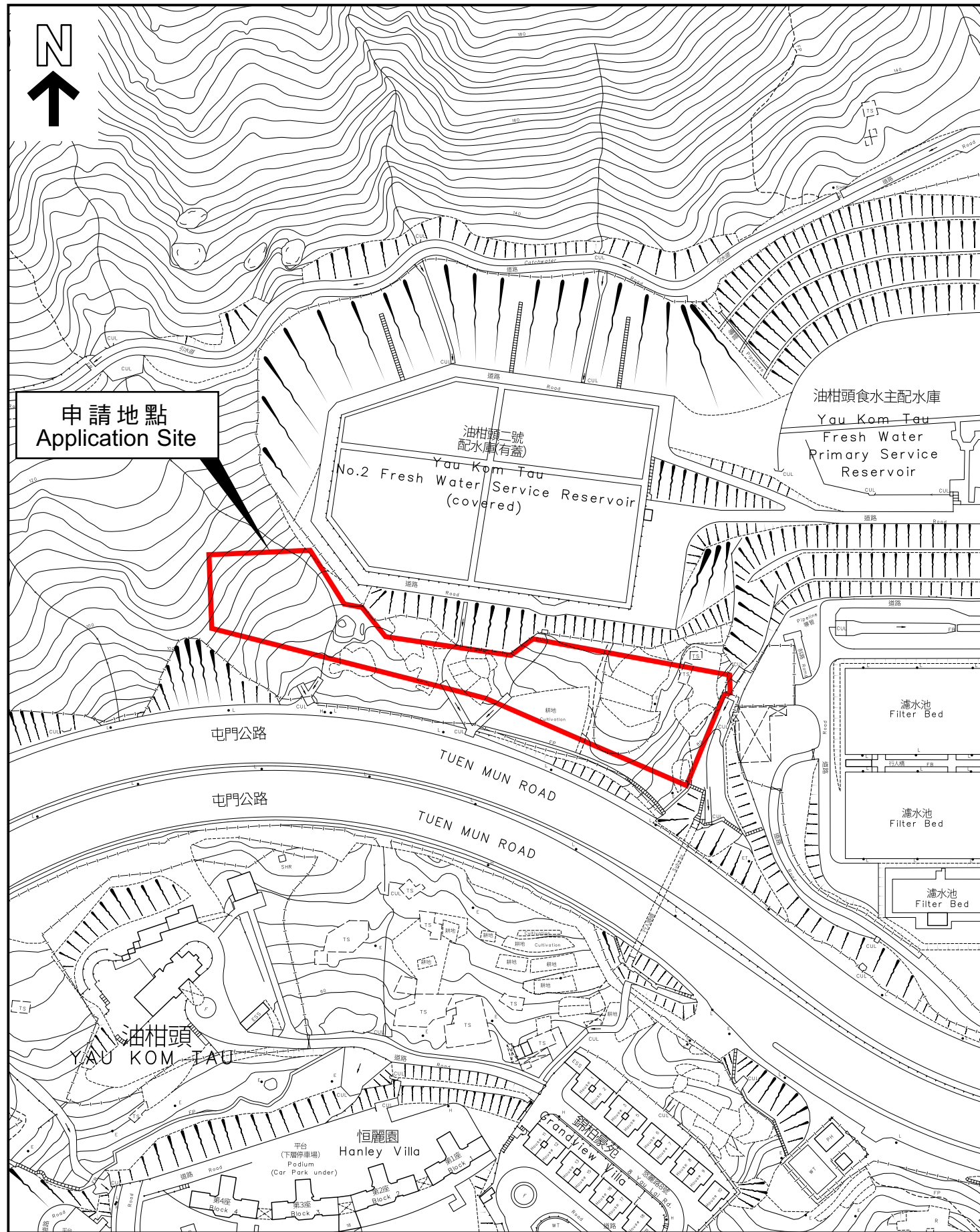

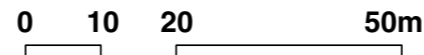

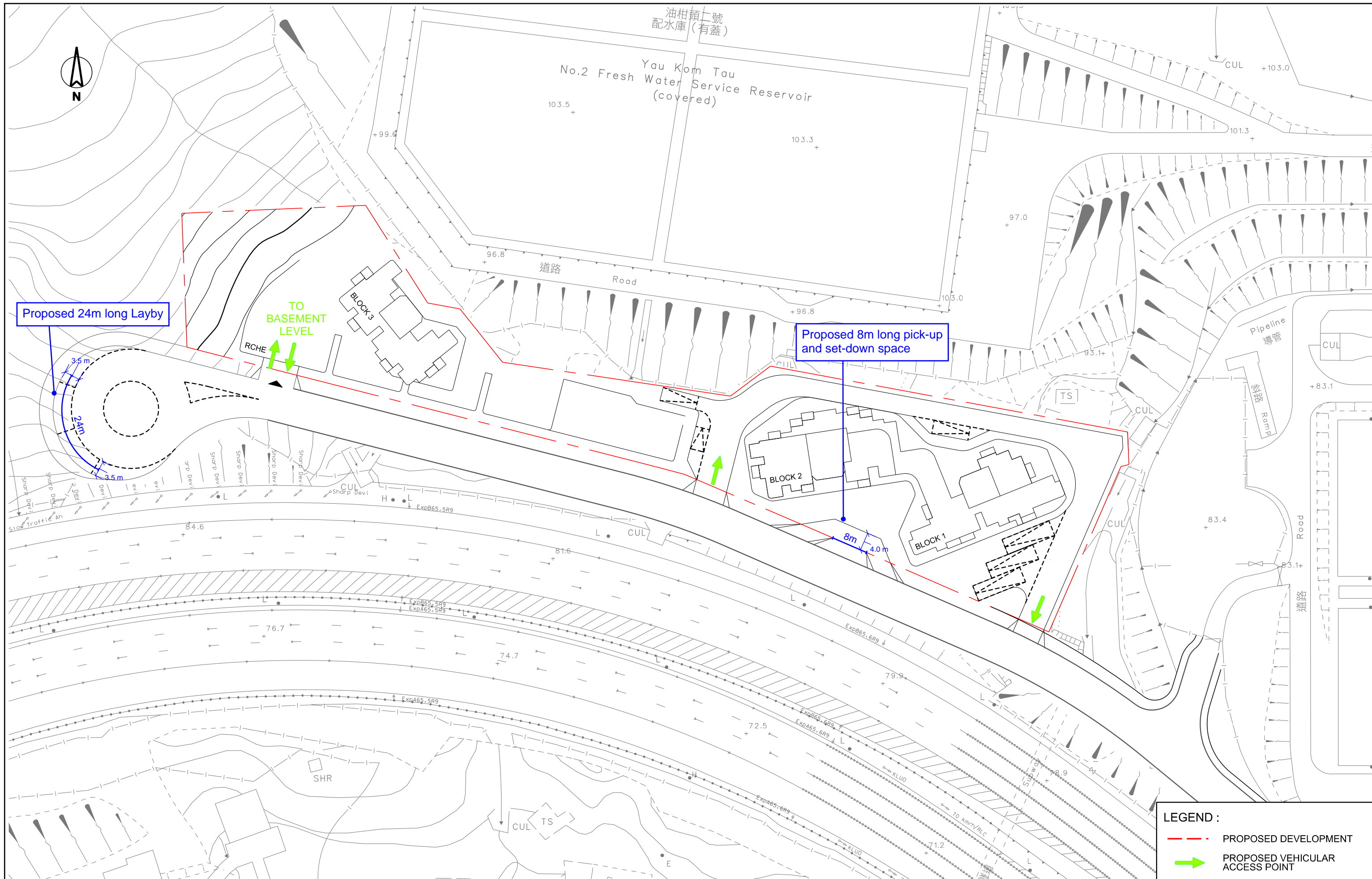


SCHEMATIC SECTION AA SK-3 5 MAY 2023

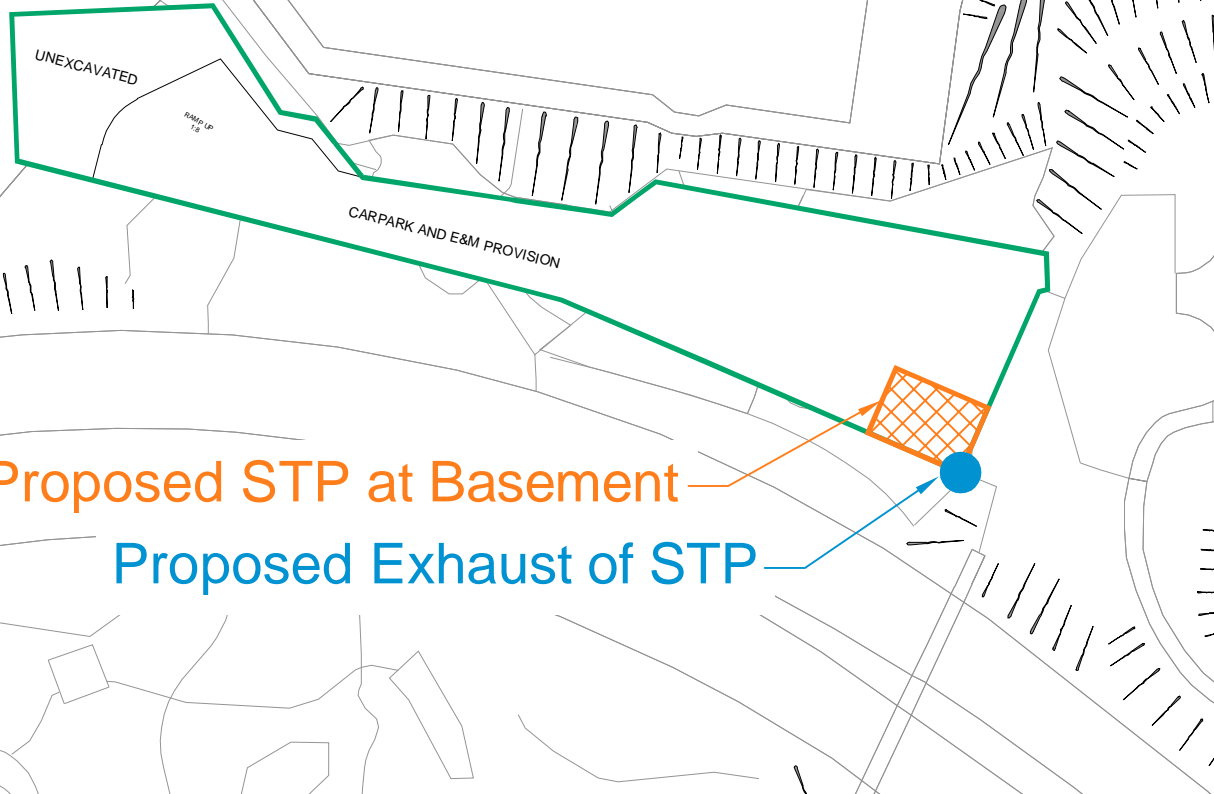
