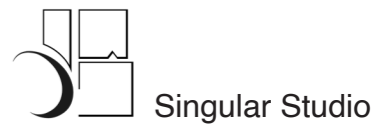


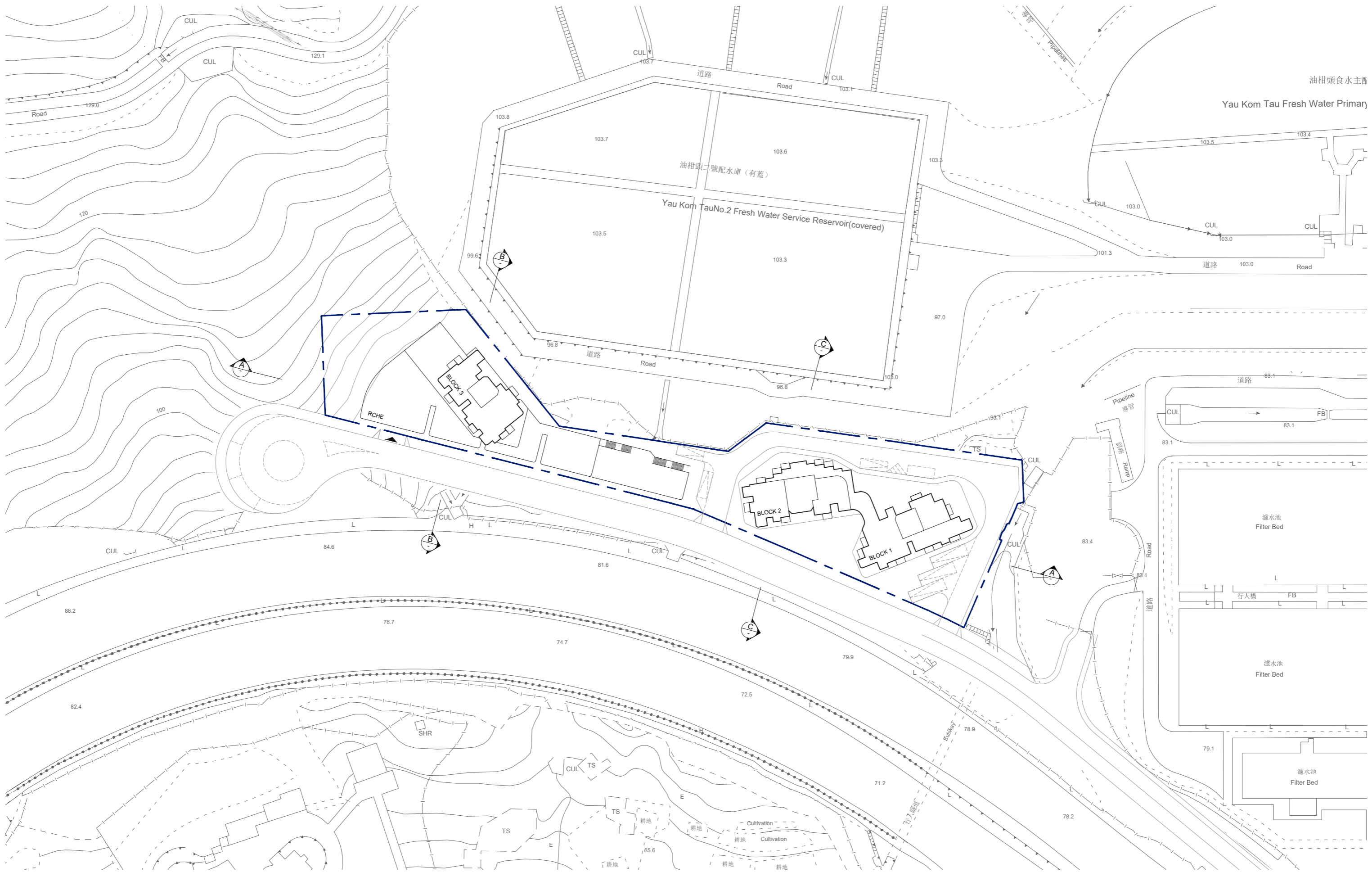


LOCATION PLAN SK-1 25 SEPTEMBER 2023

GOVERNMENT LAND IN YAU KOM TAU, TSUEN WAN

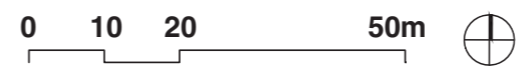

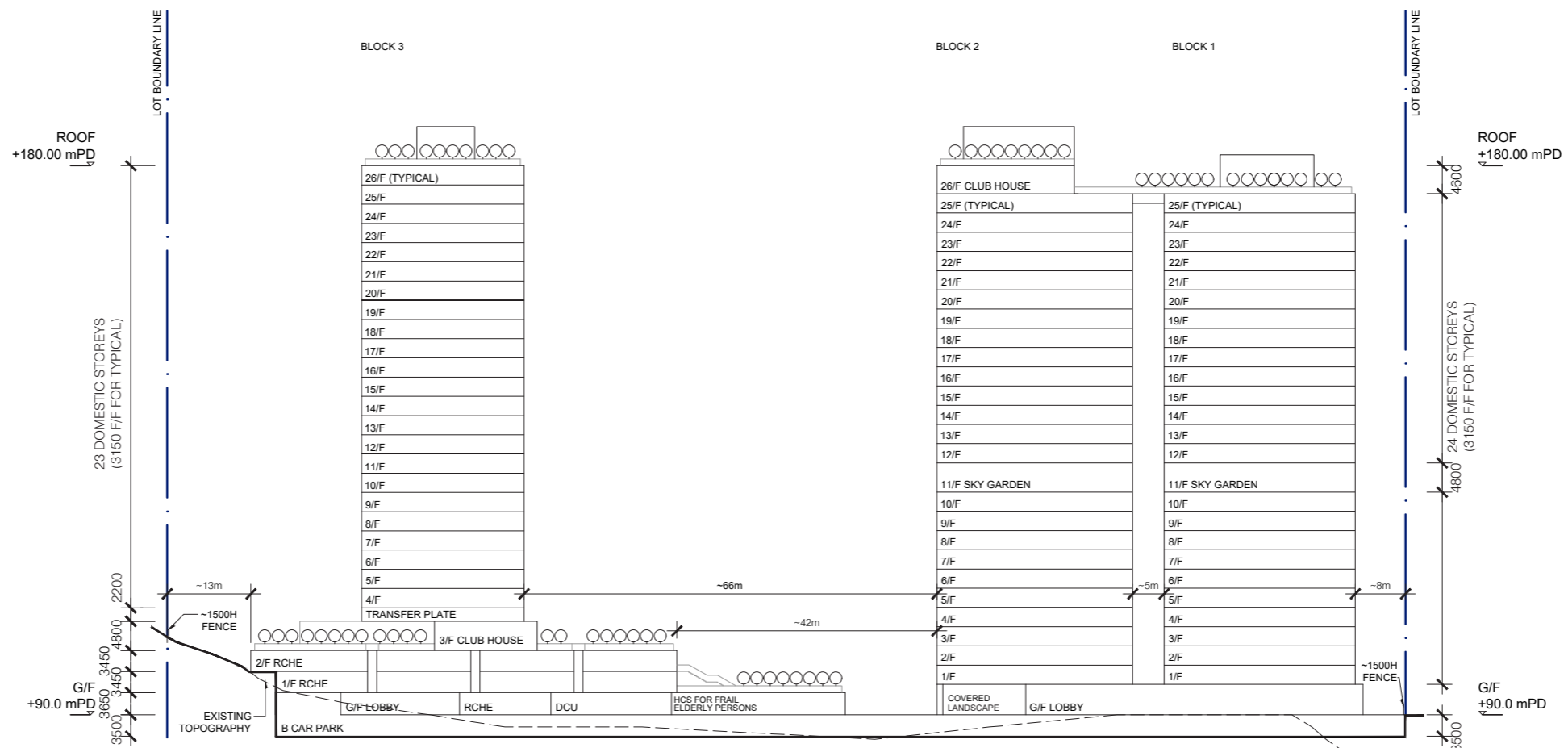

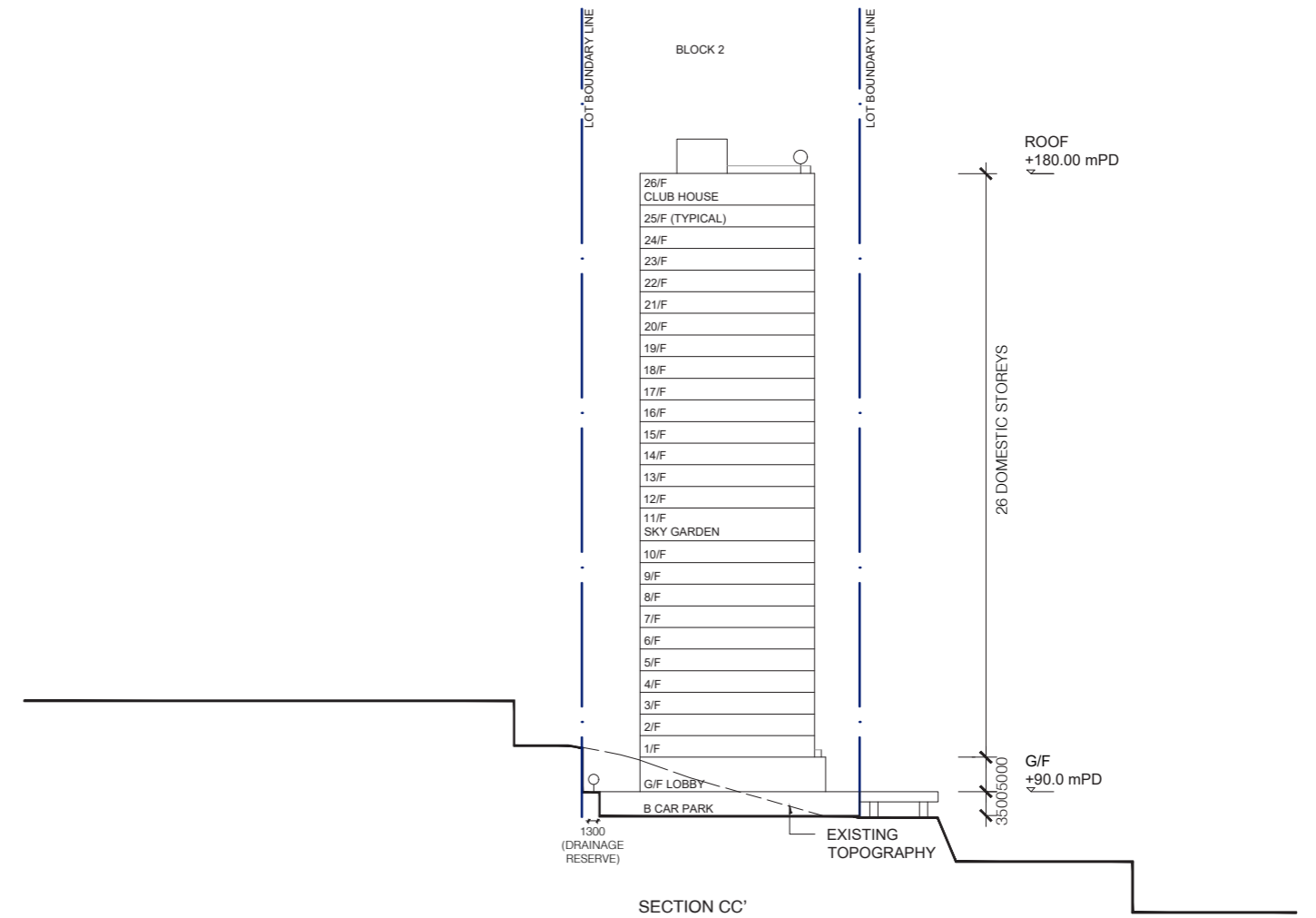
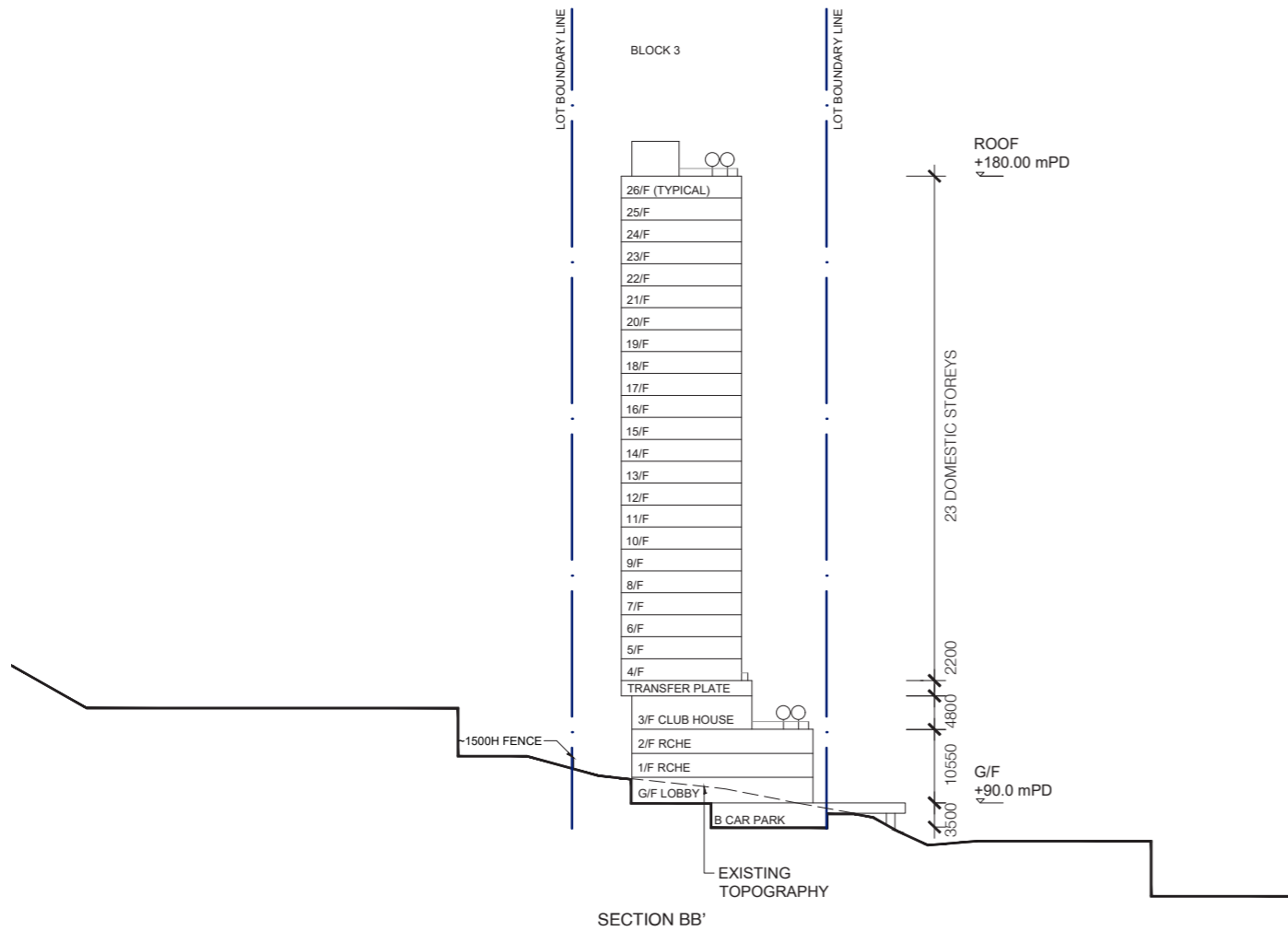


SCHEMATIC SECTION AA SK-3 22 SEPTEMBER 2023

GOVERNMENT LAND IN YAU KOM TAU, TSUEN WAN

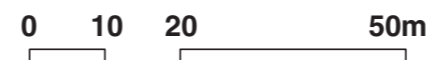

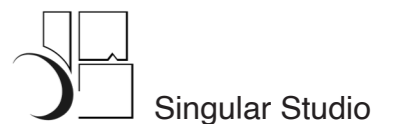


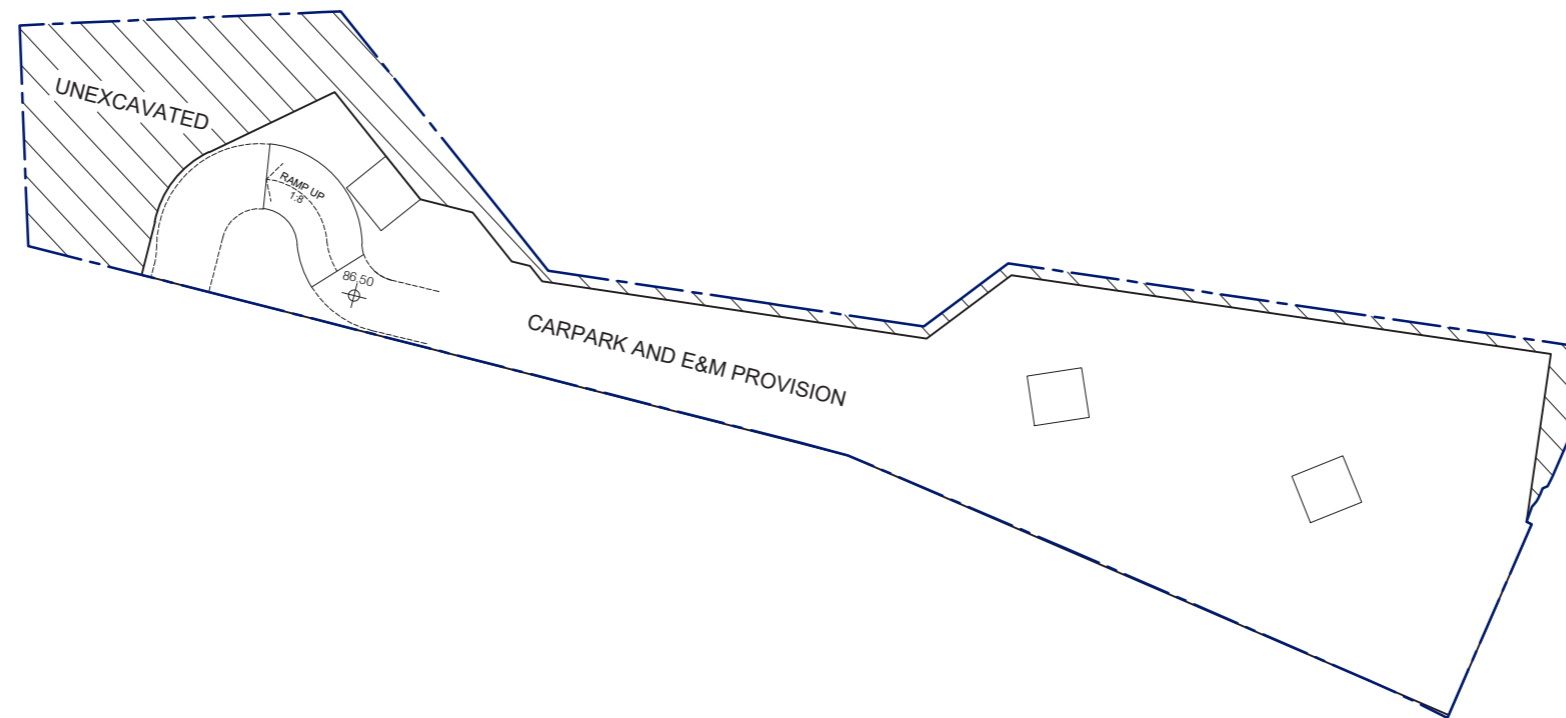


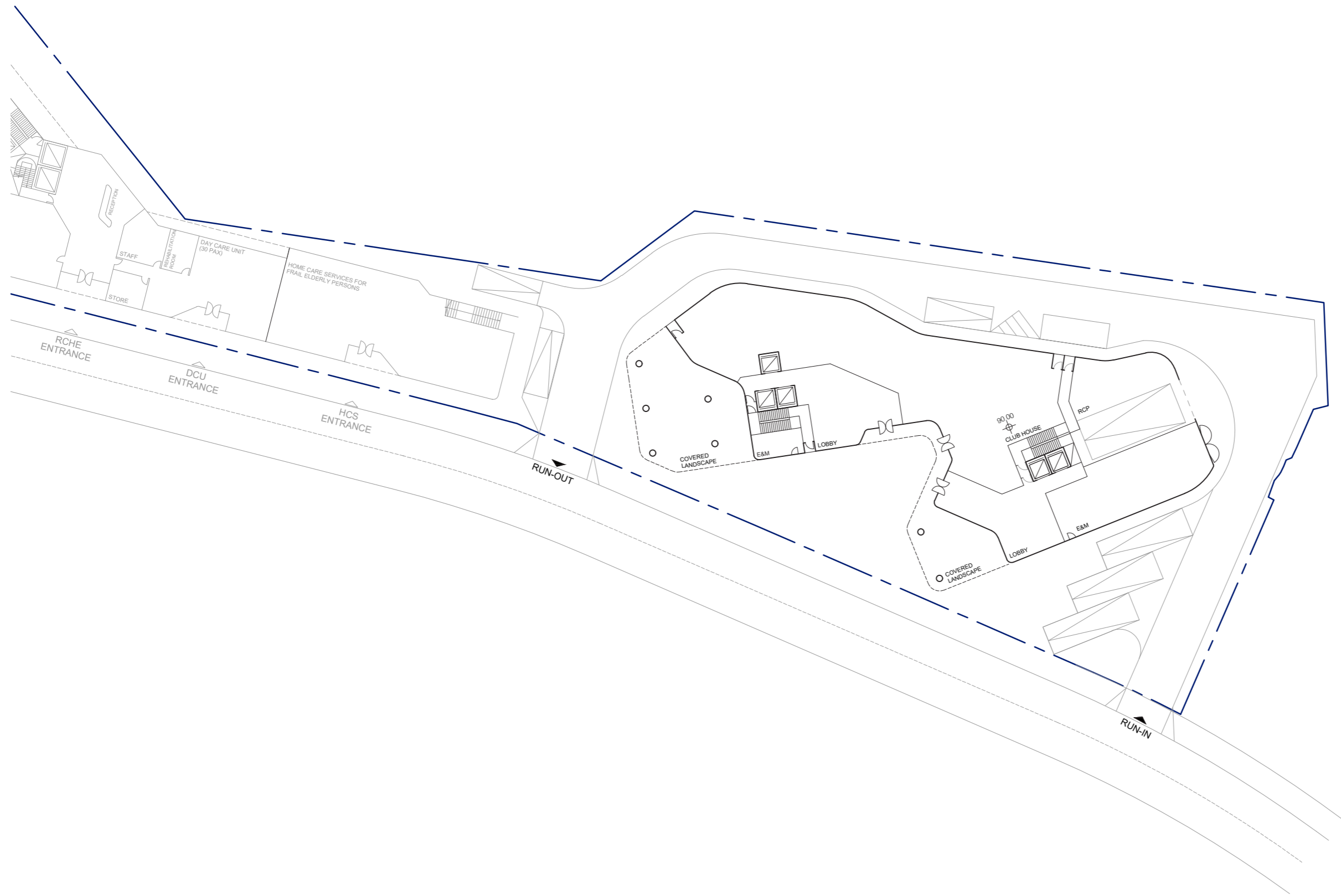
SCHEMATIC SECTIONS SK-4 22 SEPTEMBER 2023

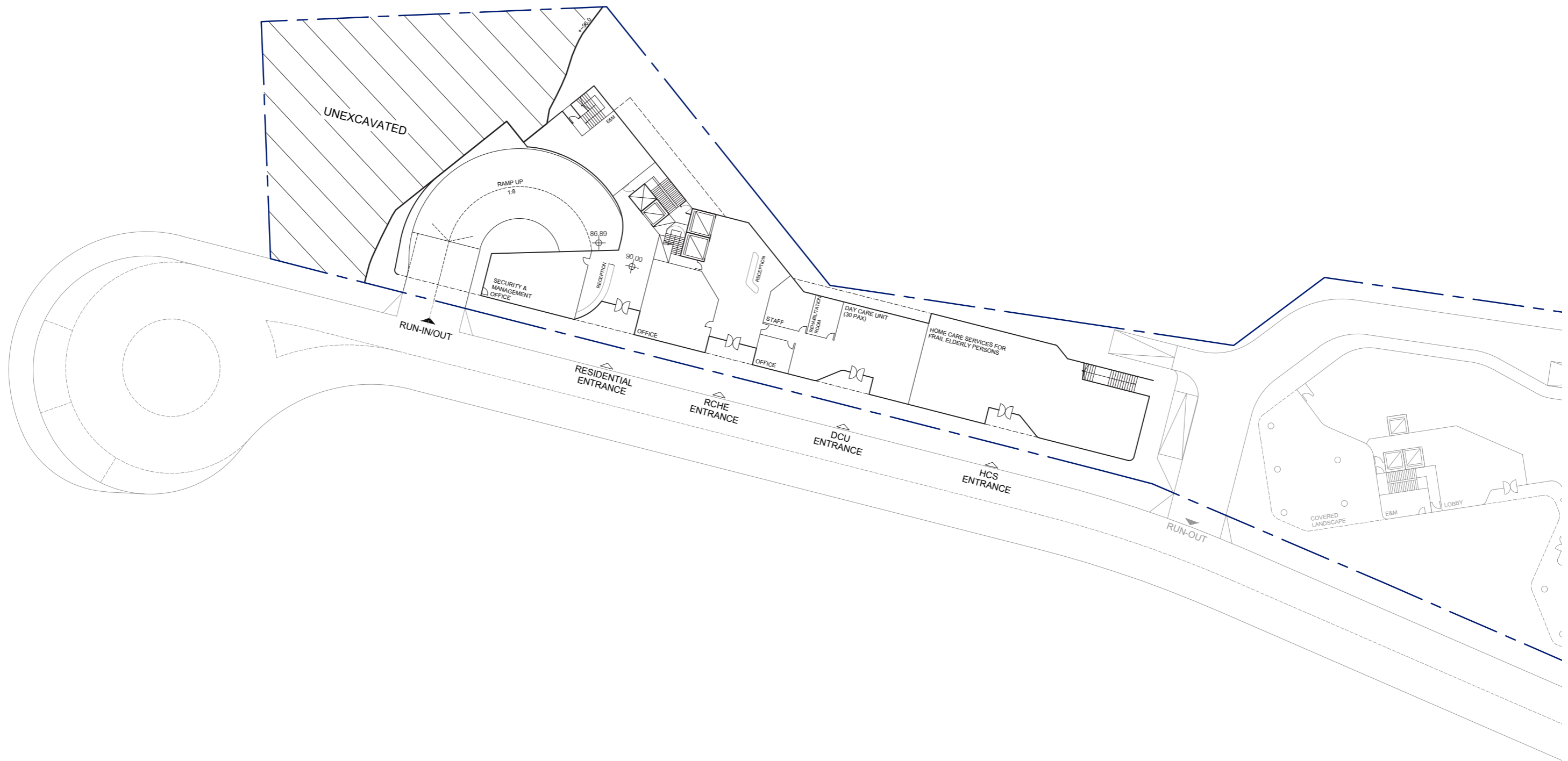




GROUND FLOOR PLAN (BLOCK 1 & 2) SK-6 25 SEPTEMBER 2023

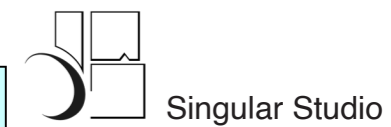




FIRST FLOOR PLAN (RCHE) SK-8 22 SEPTEMBER 2023

 GOVERNMENT LAND IN YAU KOM TAU, TSUEN WAN

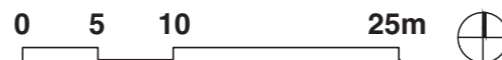
